Independent Auditor's Report

Opinion

(1) Plan Description

The following description of the Employee Benefit Trust for Employees of Life, Inc. ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, ("ERISA"), and is administered through a voluntary employees' beneficiary association (VEBA) trust established January 1, 2011, with an effective date for providing benefits to employees as of January 1, 2011. Life, Inc. ("the Company") is the plan sponsor, and the plan trustees are employees of the Company. Certain Plan assets are held a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

All health benefits under the Plan are paid by Blue Cross and Blue Shield of North Carolina, the administrative agent. The Plan's VEBA trust then reimburses the administrative agent for such benefit payments.

(b) Benefits and Participation

The Plan provides life, health, accident insurance and other benefits to eligible employees of the Company. All employees who work an average of thirty or more hours per week are eligible to participate in the Plan. Benefits begin sixty days from the first day of the month following the employee's hire date. The level of benefits payable under the Plan is determined as set forth in the plan agreement. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

(c) Stop Loss Coverage

The Plan has entered into a stop-loss arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

(d) Contributions

The Plan agreement provides that any required contributions from participants are to be collected through appropriate payroll deductions and paid to the trust. All remaining contributions necessary to fund benefits payable under the Plan are paid by the Company to the trust. Participants may elect not to contribute toward the funding of benefits under this Plan; however, in such event, the benefits payable to such participant or his dependents will be reduced or deleted as set forth in the Plan agreement.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

(b) Cash and Cash Equivalents

The Plan maintains cash in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan also maintains cash held by the administrative agent which is used to pay plan administrative expenses and plan benefits. The Plan believes it is not exposed to any significant credit risk on cash.

(c) Plan Benefit Obligations Currently Payable

Plan obligations for health claims incurred by active participants but not reported at that date are estimated by the Administrative Agent. Such estimated amounts are reported in the accompanying statements of plan benefit obligations at the present value of the estimated ultimate cost to the Plan of settling the claims. Such amounts are paid by the Plan only if claims are submitted and approved for payment.

(d) Payment of Benefits

Claim payments are recorded when paid by the third party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Premiums paid by the VEBA trust are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits.

(e) Stop Loss

Premiums for stop loss insurance are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. The stop loss refund for the year ended December 31, 2024 totaled \$239,925. This amount is netted with claims paid in the statement of changes in net assets. There was no stop loss refund for the year ended December 31, 2023.

(2) Summary of Significant Accounting Policies, Continued

(f) Administrative Expenses

Administrative expenses are paid by the Plan and consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

(3) Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS dated December 9, 2011, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No Federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(4) Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
