## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Greylock Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Greylock Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

**Note 1 - Description of Plan**

The following description of the Greylock Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan established effective January 1, 1973, covering all full-time employees of the Greylock Federal Credit Union (the “Company”) who have completed one year of service and are at least 21 years of age. Employees automatically become members of the Plan upon meeting the eligibility requirements noted above.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

The Company makes contributions allocated to each eligible participant based on a formula, which is integrated with Social Security. For the Plan years ended December 31, 2024 and 2023, this formula was equal to 6% of total compensation, plus an additional 4.3% of compensation in excess of 20% of the Social Security wage base. For the Plan years ended December 31, 2024 and 2023, the Company’s contribution was \$1,882,263 and \$1,855,693, respectively.

*Participant Accounts*

Each participant’s account is credited with their share of the Company’s contributions, forfeitures, and on each valuation date, their account shall be adjusted for Plan earnings associated with the fund(s) in which such account is invested. Allocations are based on participants’ account balances or compensation, as defined. Participants may direct their investment among various mutual fund options and a guaranteed income fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

*Vesting*

Active participants who have reached the age of 55 become fully vested in their account balance. For those participants under age 55, vesting in the Company’s contribution and the actual earnings thereon is based on the following:

**Note 2 - Summary of Significant Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). In accordance with the policy of stating investments at fair market value, net appreciation or depreciation for the year is reflected in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in the fair value of its investments consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Interest and other investment income are recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

*Risks and Uncertainties*

The Plan provides for various investment options in any combination of registered investment companies, pooled separate accounts and a guaranteed investment contract. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

*Use of Estimates*

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America and DOL rules and regulations for reporting and disclosure under ERISA require the Plan administrator to make significant estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

*Administrative Expenses*

The Company absorbs substantially all costs related to the operation of the Plan at no charge to the Plan. Certain administrative fees are paid by the Plan.

*Forfeitures*

Forfeitures are first used to pay plan expenses and then used to reduce the employer's contribution to the Plan. Forfeitures of \$71,747 and \$28,515 were used during the years ended December 31, 2024 and 2023, respectively, to reduce the employer contributions to the Plan. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$14,235 and \$3,027, respectively.

*Payment of Benefits and Withdrawals*

The aggregate benefit payable to any participant upon withdrawal from or termination of the Plan is dependent upon the rate of contribution, the earnings of the fund and the length of time such employee continues as a participant. Benefits may be paid to the participant or designated beneficiary upon death, disability, retirement, or termination of employment in the amount of the participant's account as of the valuation date following termination of employment. Benefits may be paid in a lump sum or on an installment basis. Benefits are recorded when paid.

**Note 3 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a definition of fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. The Plan has shares of registered investment companies (mutual funds) and pooled separate accounts which are considered Level 1 investments.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan has no Level 2 assets or liabilities.

**Level 3:** Inputs that are unobservable inputs for the asset or liability. The Plan has no Level 3 assets or liabilities.

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The pooled separate accounts invest mainly in mutual funds and domestic stocks that have observable level 1 quoted pricing inputs. The net asset value of the pooled separate accounts is not publicly quoted but is available to its investors when plan participants access their account values. The net asset value is the basis for current transactions and the funds can be redeemed for net asset value as of the measurement date, therefore, the trustee believes the accounts have a readily determinable fair value.

*Investments Measured at Net Asset Value*

The Plan invests in a common collective trust consisting of the Principal Stable Value Preferred Fund which is measured at fair value using the net asset value (NAV) per share as a practical expedient. The Fund is 100% invested in the Morely Stable Value Fund. The Morley Stable Value Fund invests in conventional, synthetic and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The Fund prepares its financial statement consistent with the measurement principals of an investment company. This value represents the proportionate shares of the NAV of the Morley Stable Value Fund. Redemption restrictions and unfunded commitments, if any, are disclosed in the table below. Investments valued using NAV as a practical expedient are excluded from the fair value hierarchy.

**Note 5 - Guaranteed Investment Contract with Insurance Company**

In 2012, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$- and \$5,362,763, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

This investment contract was terminated during the year ended December 31, 2024 and replaced with the Principal Stable Value Preferred Fund.

Note 6 - **Related Party Transactions**

Plan investments are shares of mutual funds, pooled separate accounts and a guaranteed investment contract managed by Principal. Principal serves as the custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$3,492 and \$2,287 for the years ended December 31, 2024 and 2023.

In addition, Global Retirement Partners, LLC d/b/a BCG Retirement Consultants provided investment advisory services to the plan. During each of the years ended December 31, 2024 and 2023, this company received \$24,000 of indirect compensation from the Plan.

Note 7 - **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 8 - **Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 - **Subsequent Events**

Effective January 1, 2025, the Plan was amended to reduce the eligible age for participation from 21 years to age to 18 years of age and the employer contribution was reduced to a fixed rate of 4% of participant compensation.

Management has evaluated subsequent events through July 1, 2025, the date on which the financial statements were available to be issued.
