## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Zeck Motor Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net asset available for benefits as of July 31, 2024 and December 31, 2023, and the related statement of changes in net assets available or benefits for the years then ended, and the related notes to the financial statements.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Zeck Motor Company 401(k) Plan (the “Plan”) provides only general information. Specific inquiries regarding plan provisions should refer to the plan document language found in the plan’s adoption agreement, basic plan document, and supplemental amendments.

**General**

The Plan is a defined contribution plan (401(k)), effective January 1, 1994, as restated January 11, 2023, covering all eligible employees of Zeck Motor Company dba Zeck Ford (the “Company”) who have been credited with one year of Service and who have attained 21 years of age. Employees of the Company who are members of union or are nonresident aliens are not eligible for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, eligible participants may make salary deferrals up to the maximum amount allowed by the Internal Revenue Service under IRC Section 402(g). The Company makes traditional enhanced safe harbor matching contributions (100% of the first 4% of participant contributions) and may elect to make additional discretionary matching or profit-sharing contributions to all eligible participants. Participants who have attained age 50 by the last day of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans.

**Participant Accounts**

Each participant’s account is credited with (a) the participant’s salary deferral contribution and related employer matching contribution, (b) an allocation of the Company’s discretionary contribution, if any, and (c) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant eligible compensation or account balances, as defined under the Plan. The participant eligible for a distribution of their account balance under the Plan is entitled to no more than their vested account balance.

**Vesting**

Participants are immediately vested in their salary deferral contributions and safe harbor match contributions plus earnings thereon. Vesting in the Company’s non-elective profit-sharing contributions and employer matching contributions plus earnings thereon is based on a six-year graduated vesting schedule. A participant is fully vested after six years of credited service.

**Investment Options**

Upon enrollment in the Plan, a participant may direct their entire account balance among any of the pre-selected investment options. Participants may change their investment options electronically daily.

**Forfeited Accounts**

Forfeitures of terminated participants’ non-vested accounts are used to reduce employer contributions or administrative fees. Forfeitures totaled \$0 and \$236 for the plan years ended July 31, 2024, and December 31, 2023, respectively.

**Distribution of Benefits**

The benefit to which a participant is entitled is equal to the value of the participant's vested interest in their account. Benefits may be distributed to participants upon termination of service by reason of retirement, disability, death, or other separation from service. Upon reaching 59½ years of age, participants may elect to receive in-service withdrawals. The Plan also maintains a provision for hardship withdrawals.

**Notes Receivable from Participants**

Participants are entitled to loan up to the lesser of 50% of the participant's vested account balance or \$50,000. The minimum loan that may be taken is \$1,000. Loans bear an interest rate equal to 1% over the prime interest rate. Loan payments are made through payroll deduction.

Notes receivable from participants are measured at the participant loans' unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Reclassifications**

Certain items in the prior year's financial statements have been reclassified to conform to the current year presentation. These reclassifications had no effect on the Statement of Changes in Net Assets Available for Benefits or Statement of Net Assets of the Plan.

**Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Fair Value of Plan Assets and Liabilities.

**Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain expenses for maintaining the Plan are paid directly by the Company and are not reflected within the financial statements. Fees related to the administration of a Plan service for

**Administrative Expenses (Continued)**

a participant is assessed directly to that participant's account. Investment related expenses are included in net appreciation/(depreciation) of the fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE C – PLAN TERMINATION**

The Company has elected to terminate the plan as of July 31, 2024. In the event of Plan termination, participants would become 100% vested in their employer contributions. The Rose Financial Group will oversee the termination of the plan.

**NOTE D – TAX STATUS**

The Plan adopted a standardized form of prototype plan sponsored by The Rose Financial Group, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of July 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. Plan tax filings are subject to examination for three years.

**NOTE E – FAIR VALUE OF PLAN ASSETS AND LIABILITIES**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Topic 820 also specifies a fair value hierarchy which requires a plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of input that may be used to measure fair value:

- Level 1 – Quoted prices in active markets for identical assets or liabilities
- Level 2 – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are

- Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Non-register accounts:* *Participant* loans are valued at their outstanding balances, which approximates fair value.

*Pooled separate accounts:* Are valued at the net asset value (NAV) based on units of the pooled separate accounts. The NAV is provided by the trustee and is used a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Redemptions are permitted daily with no restrictions or notice periods. There are no unfunded commitments.

*Registered Investment Companies and Money Market Funds:* Registered investment companies (or mutual funds) and money market funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are also required to publish their daily net asset value and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

*Registered Investment Companies:* Registered investment companies (or mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust:* Collective trust funds represent investments held in pooled funds. The Plan's interests in the collective trust funds are valued based on the net asset value (NAV) provided by the fund sponsor. The accuracy of the NAV is verified using the audited financial statements of the collective trust funds. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to

temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no significant redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. Pooled Separate Accounts are measured at net asset value.

**NOTE F – GUARANTEED STABLE VALUE FUND**

The Plan assets in the Guaranteed Stable Value Fund are invested in a group annuity contract, which is a benefit-responsive investment contract with Lincoln National Life Insurance Company (LNFIC) totaling \$0 for 2024, and \$241,782 for 2023. LNFIC maintains the contributions on a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Stable Value Fund provides a guaranteed fixed rate of return with no risk of loss of principal except as subject to charges upon withdrawal as described in the contract. The credit rates are not based on the actual performance of the underlying securities in the Stable Value Fund but rather determined in the contract. Crediting interest rates are reset at least as frequently as annually. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Stable Value Fund meets the criteria of a fully benefit-responsive investment contract and therefore is reported at contract value, which is the most reasonable estimate of fair value. Contract value is the relevant measure for the fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate the permitted transaction under the terms of the Plan. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant

withdrawal for the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the contract issuers and the also would limit the ability of the plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE G – INFORMATION PREPARED AND CERTIFIED BY LINCOLN NATIONAL**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Lincoln National Life Insurance Company, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule of assets (held at the end of year).

The custodian has supplied the plan administrator with a certification as to the completeness and accuracy of certain investment information presented in the accompanying statements of net assets available for benefits as of July 31, 2024 and December 31, 2023, the statement of changes in net assets available for benefits for the years ended July 31, 2024 and December 31, 2023 and the supplemental schedule of assets held at end of year as of July 31, 2024 and December 31, 2023.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I – PARTY-IN-INTEREST**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, and person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose employees are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons. Accordingly, loans to participants and the management of investments held by the trustee are considered party-interest transactions.

The Plan invests in certain funds of Lincoln National Life Insurance Company who serve as the plan trustee.

**NOTE J – SUBSEQUENT EVENTS**

Subsequent events have been evaluated through May 22<sup>nd</sup>, 2025, the date these financial statements were issued. Based on the results of our audit procedures, inquiry of Plan management, discussion with Rose Financial Group (third party administrator), we found no other subsequent events requiring disclosure as of December 31, 2024 because the plan had been terminated as of July 31, 2024.

**NOTE K – PLAN TERMINATION**

Effective July 31, 2024, the Zeck Motor Company 401(k) Plan (the Plan) was terminated by the Plan Sponsor due to Sale of the company. All plan participants were notified of the termination and provided with rollover notices. As a result of the termination, all affected participants became 100% vested in their account balances. The distribution of Plan assets to participants is expected to be completed as soon as is practicable after the termination date. The final Form 5500 series return will be filed. Net assets available for benefits were significantly reduced due to the distribution of assets to participants. The financial statements have been prepared on a basis other than a going concern due to the termination of the Plan.
