### **NOTES TO FINANCIAL STATEMENTS**

#### **DESCRIPTION OF PLAN**

“K” Line America, Inc., together with its U. S. subsidiaries, (Company or Sponsor) is a wholly-owned subsidiary of a Japanese corporation, Kawasaki Kisen Kaisha, Ltd. (Parent). The following description of “K” Line America, Inc. Savings and Investment Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan available to all eligible employees of “K” Line America, Inc.

Employees are eligible to participate in the Plan at any time after the employee completes six months of continuous service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan became effective February 16, 1990.

#### ***Contributions***

Each year, participants may contribute between 2 percent and 100 percent of their annual compensation as defined in the Plan. Participant salary deferrals may be traditional 401(k) (pre-tax or after-tax) or Roth 401(k) (after-tax). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision, whereby all newly-eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate is increased 1 percent annually, not to exceed 8 percent. Participants can select a different deferral percentage for bonus payments.

The Company makes matching contributions equal to 25 percent of the total compensation deferred by each participant, not to exceed 15 percent of each participant’s eligible compensation. For any Plan year, the Company may contribute additional discretionary amounts as determined by the Company’s board of directors. For the years ended December 31, 2024 and 2023, the Company contributed a discretionary contribution equal to 25 percent of the total compensation deferred by each participant, not to exceed 15 percent of the each participant’s eligible compensation.

Contributions from participants and the Company are recorded in the year in which the employee contributions are withheld from compensation.

Participants direct the investment of both employee and employer contributions into various investment options offered by the Plan. Participants may change their investment options periodically. Contributions are subject to certain IRS limitations.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of (a) the Company’s discretionary contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants’ earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and rollover amounts, plus actual earnings thereon. Participants hired prior to July 1, 2022 are immediately vested in Company contributions. For participants hired after July 1, 2022, employer matching and discretionary matching contributions are subject to a two-year cliff vesting schedule.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account. The loan interest rate for new participant loans is the Prime rate plus 1 percent. At December 31, 2024, all loans bear interest at rates that range from 4.25 percent to 9.5 percent per annum. A participant may have only one loan outstanding at a time. Loans granted to participants must have repayment terms ranging from one to five years for general-purpose loans and up to ten years for primary residence loans. Principal and interest is paid ratably through monthly payroll deductions. If loan balances are not paid back by terminated participants within 90 days of termination, the participant’s account balance will be reduced by the outstanding loan amount.

***Excess Contributions Payable***

During December 31, 2024, certain participants exceeded the applicable contribution limits as defined by the Internal Revenue Code. At December 31, 2024, excess contributions totaling \$24,438 had been identified and are reflected as a liability. These amounts were returned to the affected participants during 2025 in accordance with applicable IRS regulations and guidance.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or other reasons, a participant can elect to receive benefits in a lump sum as follows:

For participants with account balances of \$1,000 or less, the balance is paid out in a lump sum distribution.

For participants with account balances of over \$1,000 to \$5,000, if the participant does not affirmatively elect to receive a distribution of the account, the account will be automatically rolled over to an individual retirement account at the Vanguard Group as soon as administratively feasible following termination of employment.

For participants with account balances greater than \$5,000, the participant can elect to receive the balance of his or her account as a lump sum or direct rollover, or to retain the balance in the Plan.

For retired employees older than 59 ½, the Plan allows for installment payments and partial termination withdrawals.

Participants with an account who are no longer employed with the Company (excluding “K” Line America, Inc. retirees) are charged an annual administrative fee.

#### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$400 and \$1,000, respectively. These accounts can generally be used to reduce employer contributions. No forfeited accounts were used to reduce employer contributions for the Plan year ended December 31, 2024.

### **SUMMARY OF ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment and Administrative Committee determines the Plan’s valuation policies utilizing information provided by the investment adviser and trustee. See the **FAIR VALUE MEASUREMENTS** note for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and record-keeping fees are charged directly to the participants’ accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

**INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Vanguard Fiduciary Trust Company and was not subjected to any auditing procedures performed:

1. Total investments, as shown in the accompanying statements of net assets available for benefits, of \$51,914,426 as of December 31, 2024 and \$48,427,905 as of December 31, 2023.
2. Notes receivable from participants, as shown in the accompanying statements of net assets available for benefits, of \$105,896 as of December 31, 2024 and \$150,945 as of December 31, 2023.

**FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability; and

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies and the money market are stated at fair value as reported by Vanguard Fiduciary Trust Company (the Plan’s trustee), and are based on the fair value of the underlying securities. The fair value of the underlying securities is based on quotes from national exchanges.
- The Plan’s interests in the stable value collective trusts are valued at the net asset value (NAV) of units of the trusts, which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the collective trusts’ underlying investments, which is based on information reported by the investment advisor using the audited financial statements of the collective trusts at year end. The Vanguard Retirement Savings Trust is a collective investment trust fund that invests solely in the Vanguard Retirement Savings Master Trust (the Master Trust). The underlying investments of the Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality bonds, bond trusts, and bond mutual funds. The Putnam Stable Value Fund is a collective investment trust fund that invests in various high-quality investment contracts and similar contracts issued by insurance companies, banks, and other financial institutions. Investment contracts include traditional Guaranteed Investment Contracts (GIC’s), Synthetic Investment Contracts (SICs), and wrapper contracts. GICs are valued based on estimated fair value, computed using discounted cash flows. SICs are valued based on the aggregate market value of the applicable bond trusts, mutual funds, and other investments. Wrapper contracts are valued at estimated fair value based on a replacement cost approach.

#### **RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Company contributions to the Plan or benefits accrued or paid by the Plan for participants are not considered party in interest transactions.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are managed by Vanguard Fiduciary Trust Company (Vanguard). Vanguard is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for these services amounted to \$22,071 for the year ended December 31, 2024.

#### **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **TAX STATUS OF THE PLAN**

The Plan is a Vanguard prototype plan for which a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, has been received. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
