NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Kamminga & Roodvoets, Inc. 401(k) Savings Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Kamminga & Roodvoets, Inc. (Company), the Plan sponsor. Employees become eligible to participate in the voluntary deferral, employer matching contribution, and discretionary contributions after meeting the Plan's minimum service requirement of being in employment for 90 days with the Company and attaining age 18. Employees must be employed on the last day of the year to receive an employer matching contribution and on the date of funding to receive an employer discretionary contribution. Employees become eligible to participate in prevailing wage contract contributions as of the date they begin working under the qualifying contract and are not subject to the Plan's minimum age or service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's most recent restatement is effective December 1, 2023.

Contributions

Participants may elect to make voluntary pre-tax and Roth deferral contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. Employees are automatically enrolled to defer 3% of their eligible compensation upon meeting eligibility requirements unless they elect otherwise. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

For the 2024 Plan year, the Company provided a matching contribution in the amount of 100% of the first 6% of eligible compensation deferred by the participant. The Company may also make a discretionary profit-sharing contribution to eligible participants' accounts. To be eligible to receive a share of the Company matching and discretionary profit-sharing contributions, a participant must be employed by the Company on the last day of the Plan year to be eligible for the matching contribution and must be employed through the date of funding for the discretionary profit-sharing contribution, except in the case of death, disability or retirement. Employer discretionary contribution amounts are determined annually. In addition, employees working on prevailing wage contracts receive a contribution based upon their classification. The prevailing wage contribution is based upon eligible hours worked on the qualifying contract.

Plan Operations

The Company has appointed Ascensus Trust Company and Newport Trust Company, LLC to act as trustee and the Company to act as plan administrator. The trustee is responsible for holding the investment assets of the Plan, executing investment transactions and making distributions to participants. The plan administrator interprets and communicates the provision of the Plan and ensures that all government and participant reporting requirements are fulfilled.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching, discretionary, and prevailing wage contributions, as well as Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying schedule of assets held at end of year.

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their voluntary deferral and employer nonforfeitable match and profit-sharing account balances; however, the calculated amount is limited to 100% of the participant's deferral and vested match balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 5.25% to 10.50% (10.00% to 10.50% for loans issued during 2024), which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions, Company prevailing wage contributions, and rollover contributions plus actual earnings thereon. Vesting in the employer matching and discretionary contributions accounts is based on years of vested service, defined as a plan year with at least 1,000 hours of service.

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed or upon attainment of normal retirement age.

Payment of Benefits

On termination of service, the value of the participant's vested interest in his or her account (exceeding \$7,000) may remain in the plan as a non-active participant with benefit installments disbursed over a period of not more than the participant's assumed life expectancy, transferred to another qualified retirement plan, or disbursed as partial or lump sum distributions subject to income tax and, depending upon circumstances, early withdrawal penalties may apply.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$10,583, respectively. Forfeitures from non-vested accounts available at year ended December 31, 2023 in the amount of \$10,583 were used to reduce employer contributions during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. While management believes it has consistently applied its best judgment in those areas requiring estimates, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Participant purchases and sales of mutual fund shares are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis with related note administration fees recorded as administrative expenses and charged to the appropriate individual's account when incurred.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Expenses

Expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants and administrative expenses related to terminated employees with Plan balances are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

For the year ended December 31, 2024, plan management has evaluated subsequent events for potential recognition and disclosure through July 23, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS AND DISCLOSURES

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The mutual funds and cash equivalents have been valued using the unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Using unadjusted quoted prices for identical investments in an active market is defined as a level 1 measurement method.

The Vanguard Retirement Savings Trust is a collective trust fund that is valued at the net asset value of the units of the collective trust fund held by the Plan. The net asset value, as provided by the trustee, is based on the fair value of the underlying investments held by the fund, which is defined as a level 2 measurement method.

NOTE 4 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and a collective trust are managed by Ascensus Trust Company and Newport Trust Company, LLC as the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the plan for investment management services are included in net appreciation (depreciation) in fair value of the investment. The Plan made a direct payment to the third-party administrator of \$13,607 for participant related direct expenses. The sponsor pays directly any other fees related to the plan's operations.

NOTE 5 - TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved plan and has received an opinion letter issued by the IRS dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Kamminga & Roodvoets, Inc. 401(k) Savings Retirement Plan was restated effective December 1, 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions subsequent to 2021; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 8 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC.
