REPORT OF INDEPENDENT AUDITOR

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of FCI Lender Services, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of FCI Lender Services, Inc. 401(k) Profit Sharing Plan & Trust and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audit. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Method - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation, Transactions and Income Recognition -

General - Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement and Disclosures*, and Accounting Standards Update (ASU) 2010-6, *Improving Disclosures about Fair Value Measurements*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable input be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods for each of the Plan’s investment classes are presented below.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

Inputs and Valuation Methods -

Mutual funds - The fair value of the mutual funds is generally based on quoted market prices in active markets (Level 1).

Common Collective Trust - The fair value of the common collective trust does not have a readily determinable fair value and is valued based upon a net asset value practical expedient (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Participant Loans - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Risks and Uncertainties - The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of FCI Lender Services, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the summary plan description for more complete information.

General – On January 1, 1999, FCI Lender Services, Inc. (the Sponsor) established the FCI Lender Services, Inc. 401(k) Profit Sharing Plan and Trust. The Plan was established to provide retirement benefits for eligible employees of the Sponsor. The Plan is financed by contributions from participants and by the net earnings of the investments of the Plan. This is a defined 401(k) plan covering all eligible employees of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Participants may elect to defer a portion of their compensation, not to exceed the legal maximum, as calculated in accordance with Internal Revenue Code. The limit for employee elective deferrals for 2024 and 2023 was \$23,000 and \$22,500, respectively. The limit for catch-up contributions for 2024 and 2023 was \$7,500. The Plan allows for non-elective employer contributions. Safe Harbor matching contributions are made equal to 100% of participant deferrals, not to exceed 3% of participant compensation as defined by the Plan, plus 50% of the next 2% of participant compensation, as applicable.

Participation and Vesting - After completing three months of continuous employment, an employee at least 21 years of age may participate in the Plan. Participants are fully vested in their contributions and employer matching contributions as of the first day of eligibility. Participants are 0% vested in employer non-elective contributions until 2 years of service time have been met, at which time, they are 20% vested per year each year until 6 years of service, at which time, they are 100% vested in employer non-elective contributions.

Investment Options - Contributions to the Plan are invested as directed by the participant in various mutual funds and a common collective trust. If participants do not direct the investment of their contributions, the contributions will be directed according to the provisions of the Plan.

Participants may evaluate their own investment goals and objectives and choose the mutual funds best suited to achieve those goals and objectives. Poor investment performance by the investments selected by the participants may cause their balances to be lower than the amounts contributed to the Plan.

Notes Receivable from Participant - Participants may borrow from their fund accounts a minimum of \$500, up to a maximum of the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

NOTE 2 DESCRIPTION OF THE PLAN (CONT'D)

Payment of Benefits - On termination of service due to death, disability, retirement or other termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or may request a direct rollover to another qualified plan that accepts direct rollovers. Upon termination of employment, the Plan allows for automatic lump-sum distribution of participant account balances. Upon termination, if the value of the vested account balance is \$5,000 or less on the applicable valuation date as provided under the Plan, the Company can cash the entire vested account balance out of the Plan

Forfeitures – Forfeitures will be allocated in the same Plan Year in which the forfeitures occur and can be used to pay Plan expenses or reduce employer contributions. No forfeitures were used to reduce employer contributions in 2024 and 2023, respectively.

Allocation Provisions – Plan investment income from each investment selected by a participant is allocated to individual participant accounts proportionally based on the beginning of the year balance of a participant's account plus annual contributions.

NOTE 3 PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. Benefits would be distributed to the participants and their beneficiaries as if the Plan had not been terminated until all participants' accounts have been completely distributed to, or for the benefit of, the participants or their beneficiaries in accordance with the Plan.

NOTE 4. TAX STATUS

The Plan adopted the ADP, LLC. Prototype Non-standardized Profit-sharing Plan with CODA, which received a favorable opinion letter from the Internal Revenue Service, dated July 8, 2014, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statement

NOTE 5 FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan's administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information (such as mutual funds) certified by Mid Atlantic Trust Company, the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustees to information included in the Plan's financial statements, as follows:

NOTE 7 SUBSEQUENT EVENTS

Management has evaluated the impact of all subsequent events on the Plan through the date the financial statements were available to be issued and has determined that there were no subsequent events requiring adjustment or additional disclosure in the financial statements.

NOTE 8 RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers or employees of the plan sponsor and, therefore, these transactions qualify as party-in-interest transactions. No officer or employee of the Company receives compensation from the Plan.

Certain investments are managed by the investment advisors of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the investment advisors from Plan assets totaled \$37,930 and \$37,320 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative expenses on the statement of changes in net assets available for benefits.

Certain administrative functions are performed by Paychex, Inc., the Plan's record keeper and fees are paid by plan participants. During the years ended December 31, 2024 and 2023, the record keeper received \$24,289 and \$19,773, respectively, in administrative fees from Plan assets which is included in administrative expenses on the statement of changes in net assets available for benefits.

Certain administrative functions are performed by Mid Atlantic Trust Company, the Plan's custodian. Plan expenses include participant loan fees, distribution fees and fund (custodial) fees, which are paid by plan participants. During the years ended December 31, 2024 and 2023, the custodian received \$860 in administrative fees from Plan assets which is included in administrative expenses on the statement of changes in net assets available for benefits. In addition, the custodian charges asset management fees of approximately 1% of participants' account balances, which are included in the net depreciation in fair value of investments on the statement of changes in net assets available for benefit
