In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Skidmore College 403(b) Retirement Plan for Employees Represented by UPSEU Local 1222's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Skidmore College 403(b) Retirement Plan for Employees Represented by UPSEU Local 1222's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Skidmore College 403(b) Retirement Plan for Employees Represented by UPSEU Local 1222's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Skidmore College 403(b) Retirement Plan for Employees Represented by UPSEU Local 1222 (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General Information

The Plan was adopted on March 1, 2014 and is a defined contribution pension plan under Section 403(b) of the Internal Revenue Code ("IRC"). The Plan covers all eligible employees of Skidmore College (the "College") represented by UPSEU Local 1222. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Effective May 15, 2024, the Plan merged with the Skidmore 403(b) Retirement Plan and assets of approximately \$5,272,200 were transferred. All participants of the Plan become participants in the Skidmore 403(b) Retirement Plan.

Eligibility

Employees are eligible to make elective deferrals upon employment. Employees are eligible for employer nonelective contributions once they have achieved at least 1,000 hours of service in their initial (or subsequent) 12 month computation period.

Contributions

Participants may make voluntary pretax and Roth contributions subject to certain limitations under the terms of the Plan and the IRC. Participants who have attained age 50 before Plan year end are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The College provides a nonelective contribution to eligible employees. The College contributed an amount equal to \$1.95 per hour of service for the period from January 1, 2024 to May 15, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the College's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employees are 100% vested in all contributions and for actual gains and losses resulting from their investments.

NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%.

Payment of Benefits

Benefits are distributed in a lump sum or installment and are based on normal retirement date, disability, death or termination of employment of the participant. Termination distributions of account balances greater than \$5,000 may be deferred to a later date. Participants may also request an in-service withdrawal after age 59½ or hardship withdrawals upon meeting certain requirements as outlined by the Internal Revenue Service (IRS).

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

As of December 31, 2023, there were approximately \$231,500 of loans deemed distributed for active participants (none as of May 15, 2024).

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits are recorded as deductions from net assets available for benefits when paid.

Administrative Expenses

Fees for the administration of notes receivable from participants and benefits paid to participants are included in administrative expenses and charged directly to the participant's account. Expenses related to investment transactions are netted against investment income. Certain expenses of maintaining the Plan are paid by the College and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available for issuance.

NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company ("Vanguard"), the trustee of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. This certifications are as of May 15, 2024 and December 31, 2023, and for the period from January 1, 2024 to May 15, 2024 and includes investment information related to the fair value of investments, notes receivable from participants, interest and dividend income and net appreciation in fair value of investments that is included in the Plan's financial statements.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

NOTE 4 — FAIR VALUE MEASUREMENTS (Continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value.

Registered Investment Company Accounts: Shares are valued at the net asset value of shares held by the Plan at year end and is based on quoted market prices in active markets.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets include investments in funds managed by Vanguard. Vanguard is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

Notes receivable from participants qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules of ERISA.

NOTE 6 — PLAN TERMINATION

Although it had not expressed any intent to do so, the College had the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. As further discussed in Note 1, effective May 15, 2024, the Plan merged with the Skidmore 403(b) Retirement Plan.

NOTE 7 — TAX STATUS

The Plan has adopted a volume submitter 403(b) plan sponsored by Vanguard, with the latest opinion letter dated February 1, 2018, in which the IRS stated that the plan, as then designed, was in compliance with the applicable requirements of the IRC and therefore, the plan is exempt from federal income tax under Section 403(b) of the Code. To maintain its qualification, the plan is required to operate in conformity with the IRC.

NOTE 7 — TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
