## INDEPENDENT AUDITOR'S REPORT

Plan Administrator and Plan Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the financial statements of Fisher Associates, P.E., L.S., L.A., D.P.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Fisher Associates, P.E., L.S., L.A., D.P.C. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of Fisher Associates, P.E., L.S., L.A., D.P.C. (the "Company") who are not union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of a good faith bargaining, nonresident aliens, leased employees and any employee who is a resident of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Committee is responsible for Plan oversight which included determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

**Contributions:** Each year, participants may contribute up to the maximum annual limitations as provided by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation to be allocated to the appropriate target retirement date fund until changed by the participant. In addition, the elective deferral election rate of automatically enrolled participants will be increased by 1 percent annually beginning on the first day of each Plan year following the automatic enrollment up to 15 percent, unless otherwise directed by the participant.

The Company may make a discretionary profit-sharing contribution which is allocated to eligible participants' accounts at a discretionary amount determined by the Company. Each participant who receives a profit-sharing contribution will receive a contribution of at least 2 percent of their compensation. The profit-sharing contributions totaled \$390,366 for the year ended December 31, 2024 (\$336,055 – 2023). Contributions are subject to certain Internal Revenue Services (IRS) limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and the Company's profit-sharing contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 20 percent vested after two years of service, 40 percent after three years of service, 60 percent after four years of service, 80 percent vested after five years of service, and 100 percent vested after six years of service. A year of service has been defined as completion of at least 500 hours of service during a plan year.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Participants may only have two loans outstanding at any time. Loans are payable over a period not to exceed five years, except when used to acquire a principal residence, in which case the Administrator can permit a longer repayment period. The loan bears interest at the prime rate plus 2 percent. Principal and interest are paid ratably through payroll deductions.

**NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)**

**Payment of Benefits:** On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participants vested interest in his or her account in the form of a lump-sum payment. Participants may also request an in-service distribution upon attainment of age 59 ½. On separation of service, a participant may request early payment of benefits or defer receipt of a distribution in accordance with Plan provisions. Partial withdrawals or installments are only permitted for required minimum distributions. If the participant's account is \$5,000 or less, the Plan will distribute the entire balance as soon as practicable after termination of employment.

**Forfeited Accounts:** At December 31, 2024, forfeited non-vested accounts totaled \$89,069 (\$68,752 – 2023). These accounts can be used to pay administrative expenses or used to reduce future Company contributions. During the year ended December 31, 2024, \$92,447 of forfeitures were used to reduce employer contributions (\$22,923 – 2023).

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits:** Benefits are recorded when paid.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 (FASB ASC 820) are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market funds:** A money market fund is a public investment vehicle valued using \$1 for the NAV and is classified as a Level 1 investment.

**Pooled separate accounts:** Unit value calculated based on the NAV of the underlying investments or pool of securities.

**Common collective trusts:** Valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**Collective investment trusts:** The fair value of the collective investment trust (CIT) is determined using the NAV per unit, which is valued daily by the fund manager. The NAV is based on the market prices of the investments held within the CIT, which includes both publicly traded and non-publicly traded securities. CIT's are not publicly traded, however the daily price of the funds are publicly available through the Nasdaq Fund Network. CIT's are classified within Level 2 of the fair value hierarchy.

### NOTE 5: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe Price. T. Rowe Price is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Certain investments were maintained in investment funds managed Principal Life Insurance Company and Principal Life Insurance Company as agent for Principal Global Investors Trust Company (Collectively "Principal"), the former custodians of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Administrative expenses incurred by the Plan for custodial and recordkeeping fees as well as participant loans also qualify as party-in-interest transactions.

### NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### NOTE 7: TAX STATUS

Effective January 1, 2021, the Plan adopted a non-standardized form of a pre-approved plan sponsored by FIS Business Systems, LLC. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the date of this letter, however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
