We have performed audits of the accompanying financial statements of Devine, Millimet & Branch 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

### **Note 1: Description of Plan**

The following description of the Devine, Millimet & Branch 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Devine, Millimet & Branch 401(k) Plan (the Plan), is a defined contribution plan established by Devine Millimet & Branch, Professional Association (the employer). The Plan covers substantially all employees, as defined, who elect to participate and who have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Plan participants may select from various investment options made available under the Plan, including a participant directed brokerage account investment option. The brokerage account is an option within the Plan which allows a participant to invest in assets outside the list of Plan investment options. Investment decisions are the sole responsibility of the Plan participant. Plan contributions are invested based upon these selected options. Effective December 1, 2023, the Plan changed its Trustee from Matrix Trust Company to Fidelity Management Trust Company.

#### **Contributions**

Participating employees are allowed to make salary savings contributions at a rate of up to 100% of compensation, subject to certain dollar limitations. Participants may designate all or part of their elective contributions as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, participants may contribute funds from another qualified plan (rollover contributions) subject to certain requirements. The employer will make matching contributions equal to 50% of the participant's elective deferrals that do not exceed 4% of the compensation. In addition, the employer may make a discretionary contribution to the Plan, which would be allocated to participants in accordance with the Plan document. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Plan matching contributions, and allocations of the Plan's discretionary contribution and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1: Description of Plan (Continued)

#### Vesting

The portions of participants' accounts consisting of salary deferrals are 100% vested immediately. The portions of participants' accounts which result from employer contributions are subject to a graded vesting schedule with vesting at 20% after two years of service and 20% vesting each subsequent year until 100% vested after 6 years of service.

#### Notes Receivable From Participants

Participants may borrow from the Plan, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, as defined. Loans must be repaid, with interest, over a period normally not to exceed five years. If the loan is for the purchase of a principal residence, a longer repayment period may be permitted. There is no penalty for prepayment of loans. With the exception of transferred loans, individual participants may not have more than one loan in existence at a time. The participant balances are held as collateral for these loans. Interest on participant loans is based upon market rates set at the time of the borrowing. Interest rates for participant loans ranged from 3.25% to 9.50% during the year ended December 31, 2024, and 3.25% to 8.25% during the year ended December 31, 2023. Principal and interest is paid through payroll deductions.

#### Payment of Benefits

Benefits under the Plan are determined, as follows:

1. Upon retirement, death, total and permanent disability, or termination of service for other reasons, all amounts credited to the participant's account shall be distributed either in one lump-sum payment, a series of periodic payments as defined in the Plan, or in partial withdrawals, provided the minimum withdrawal is \$1,000. If the vested balance does not exceed \$5,000 (\$7,000 effective January 1, 2024), the balance may only be distributed in a single lump-sum payment and will be made regardless of whether consent is received.
2. In-service withdrawals are permitted for active employees who have reached age 59 ½ and who have been a participant in the Plan for at least six years. Hardship distributions may also be made subject to certain requirements and Plan provisions.

#### Forfeitures

Forfeitures attributable to employer contributions, if any, which have not become vested, are used to reduce the employer contributions. Employer contributions were reduced by forfeitures in the amount of \$56,617 and \$107,877 for 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,470 and \$72,156, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Accounting Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions in net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The measurement of fair value is made using the fair value hierarchy discussed in Note 3.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as benefit payments based upon the terms of the Plan document.

#### **Benefit Payments**

Benefits are reflected as a deduction in net assets available for benefits when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses that are paid by the plan are included in net investment income.

#### Subsequent Events

Management has evaluated subsequent events through July 28, 2025, the date when the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The fair value of the Plan's investments is determined by using a hierarchy that prioritizes the inputs to valuation techniques. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for identical or similar assets in inactive markets, quoted prices for similar assets in active markets, inputs that are derived principally from or corroborated by observable market data by correlation or other means, or observable inputs other than quoted prices; and Level 3 inputs consist of inputs to the valuation methodology that are unobservable and significant to the fair value measurement and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts:* Valued at the NAV of the shares of the trusts or accounts held by the Plan at year end. The NAV is based on the fair value of the underlying investments of the trust or account less its liabilities. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

### Note 4: Information Prepared and Certified by the Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and for the period December 1, 2023 to December 31, 2023, and Matrix Trust Company, the Trustee of the Plan for the period January 1, 2023 to November 30, 2023.

### Note 5: Tax Status

Effective July 15, 2022, the Employer adopted a non-standardized pre-approved profit sharing plan with CODA with an IRS notification letter, dated August 19, 2020, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC).

Effective December 1, 2023, the Employer adopted the Fidelity Basic Plan Document No. 17, a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The IRS issued a notification letter on the plan, dated June 30, 2020, which states the pre-approved plan document is in compliance with the applicable sections of the IRC.

### **Note 5: Tax Status** (Continued)

The Plan has been amended since receiving the notification letters; however, the plan administrator and the Plan's legal counsel believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 7: Party-In-Interest Transactions**

Fidelity Workplace Services LLC (the recordkeeper and third party administrator), provided administrative and management services for which it charged the Plan \$22,339 during 2024. These services were previously provided by OneAmerica Retirement Services (prior recordkeeper) who charged the Plan \$54,730 during 2023. These transactions qualify as party-in-interest transactions.

Fiduciant Advisors provides various services in connection with the plan, including investment advisory services to Plan participants for which they charged the Plan approximately \$57,300 and \$18,500 during 2024 and 2023, respectively. These services were previously provided by Morgan Stanley Smith Barney LLC who charged the plan approximately \$22,000 during 2023. These transactions qualify as party-in-interest transactions.

The Plan also has arrangements with various service providers. These transactions also qualify as party-in-interest transactions under ERISA.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
