## **Notes to Financial Statements**

---

### **NOTE 1 PLAN DESCRIPTION**

---

The following description of the RH Benefits Trust, Inc. Employee Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The trust related to the Plan was established on January 1, 2021, the beginning of the initial Plan year.

#### ***General***

The Plan provides health and other benefits covering eligible employees and covered dependents of Restaurant Advisory Services, Inc. dba Bridge Hospitality, Refined Hospitality, Gateway to New Hope Operating, LLC, The Grove at Centerton, LLC, and Shelter Haven Hospitality, Inc. dba The Reeds at Shelter Haven (the Companies or Employers). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 26, 2024, the Board of Directors voted to withdrawal all Companies, except Refined Hospitality, from RH Benefits Trust, Inc. and transition to a Professional Employer Organization (PEO) sponsored benefits platform, to be effective January 1, 2025. Refined Hospitality will remain as the sole member of RH Benefits Trust, Inc. Employee Welfare Benefit Plan going forward.

#### ***Benefits***

The Plan provides health (medical and prescription), dental, vision, short-term disability, life and accidental death and dismemberment (AD&D), accident, hospital indemnity, critical illness, and discount plan insurance benefits, to covered persons who are employees of the Companies.

The eligibility period for all full-time employees (defined as working an average of 30 hours per week) is 60 days. Coverage will begin on the first day of the month following the first day that all eligibility requirements are met. Spouses, child(ren) and dependents of the full-time employees are also eligible for coverage.

#### ***Insured Benefits***

The Plan fully insures health, dental, vision, short-term disability, life and AD&D, accident, hospital indemnity, critical illness, and discount plan insurance benefits. The Companies purchase annual insurance contracts for these insured benefits.

Premiums for health, dental, and vision insurance benefits are paid to the insurance companies from both Employer and employee contributions. Premiums for life and AD&D insurance benefits are paid fully by the Companies' contributions. Premiums for short-term disability, accident, hospital indemnity, critical illness, and discount plan insurance benefits are paid fully by employee contributions.

#### ***Contributions***

Participants are required to contribute to the Plan to fund a portion, or all, of the cost of their health, dental, vision, short-term disability, accident, hospital indemnity, critical illness, and discount plan benefits. Amounts required to be contributed by participants are determined annually in accordance with the Plan document. The remainder of the funding required to pay benefits and cover expenses under the Plan is paid by the Companies.

#### **NOTE 1 PLAN DESCRIPTION (CONTINUED)**

---

The Companies fund the health, dental, vision, and life and AD&D insurance benefits through the use of a trust established by the Companies for the Plan. Monthly contributions are made to the trust in an amount sufficient to cover expected premiums due and administrative expenses of the Plan.

The Companies fund the short-term disability, accident, hospital indemnity, critical illness, and discount plan insurance benefits through direct payments to the insurance provider or vendor.

#### ***COBRA***

The Plan offers continuation of benefits under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event. Each qualifying individual pays their premium directly to a third-party (COBRA) administrator. The premium collected is then paid to the Companies. Separate third-party administrators process claims and other expenses. The Companies and the Plan retain the risk for insured claims.

#### ***Plan Termination and Modification***

Although it has not expressed any intent to do so, except as previously disclosed in the General section herein, the Companies have the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the Companies must pay the premiums for the insured benefits and expenses of the Plan due up to the date of termination, plus extended benefits, if any, provided under the Plan.

#### **NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

#### ***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting and in accordance with the accounting principles generally accepted in the United States of America.

#### ***Premiums Payable***

Premiums payable represent the amount of premiums for insured benefits due by the Plan at the end of the year, but not yet paid by the Plan as of the end of the year.

#### ***Payment of Benefits***

Insured benefits are recorded when premiums are due or paid.

#### **NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### ***Use of Estimates***

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those amounts.

#### **NOTE 3 RISKS AND UNCERTAINTIES**

---

Plan assets include non-interest-bearing cash, which is held at a bank insured by the Federal Deposit Insurance Corporation (FDIC) up to \$ 250,000. The Plan may have deposits from time to time which exceed the maximum amount insured by the FDIC.

#### **NOTE 4 TAX STATUS**

---

The Companies adopted the Plan on January 1, 2021. The Plan and related trust were designed in accordance with applicable sections of, and exempt from federal income tax under, the Internal Revenue Code (IRC). The related trust received a favorable determination letter from the Internal Revenue Service (IRS) on January 8, 2021.

An IRS notice dated August 19, 2024 was received by Plan management stating that the RH Benefits Trust had its tax-exempt status automatically revoked, effective May 15, 2024, due to a Form 990, Return of Organization Exempt from Income Tax, not being filed for three consecutive years. RH Benefits Trust is actively working to get current on its annual filings and applying for reinstatement of its tax-exempt status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress, except as noted above.

#### **NOTE 5 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

---

The Plan engages third parties to perform administrative functions and process claims. Fees paid by the Plan for these services are included in premiums for insured benefits and administrative expenses on the statement of changes in net assets available for plan benefits.

#### **NOTE 6 SUBSEQUENT EVENTS**

---

The Plan has evaluated events and transactions subsequent to December 31, 2024 through July 28, 2025, the date these financial statements were available to be issued. Based on the definitions and requirements of generally accepted accounting principles, we have not identified any events that have occurred subsequent to December 31, 2024 and through July 28, 2025, which require recognition or disclosure in the financial statements, except as noted in Note 1.
