**Note 1 – Description of the Plan**

The following description of The Expo Group, Inc. Employer 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by The Expo Group, Inc. (the “Company”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan, established on January 1, 2000, as amended from time to time, covering all employees of the Company except for union employees and nonresident aliens. Employees are eligible to participate in the Plan after completing one month of service. Union employees and nonresident aliens are ineligible to participate in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as well as all provisions of the federal income tax laws.

The Trustees of the Plan are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Trustees of the Plan.

*Contributions* - Each year, participants may make tax-deferred contributions to the Plan not to exceed the amount deductible for federal income tax purposes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision. Each participant will be subject to the automatic enrollment of 6% of Plan compensation upon reaching eligibility. The first deferral rate increase of 1% shall occur on the first day of the second Plan year following the effective automatic enrollment date and will increase by 1% for each subsequent Plan year until reaching a maximum deferral rate of 10%.

The Company may contribute to the Plan by making a matching contribution equal to a uniform percentage of salary deferrals, which percentage will be determined each year at the option of the Company’s board of directors. The Company may also make an additional contribution equal to a percentage of participant compensation. During the year ended December 31, 2024, the Company accrued a \$100,000 profit sharing contribution which was remitted to the Plan during March 2025. Contributions are subject to Internal Revenue Service (IRS) limitations.

*Participant Accounts* - Each participant’s account is credited with the participant’s tax-deferred contributions and employer contributions (if any), as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1 – Description of the Plan (continued)**

Vesting - Participants are immediately vested in their deferred salary contributions, rollover contributions from other plans and actual earnings thereon. Vesting in the Company's matching contributions and profit-sharing contributions, if any, of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested upon retirement, permanent disability, death or reaching retirement age while employed by the Company.

If a participant separates from the employment of the Company, a participant shall be vested based upon the following schedule:

<u>Years of Vesting Service</u>	<u>Percentage Vested</u>
Less than 2 years	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more years	100%

Notes Receivable from Participants - Participants who are active employees may borrow against their vested account balances a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000 minus the highest outstanding balance of loans in the past 12 months. The notes, in the form of promissory notes (Note 2), are secured by the balances in the participant's account and bear interest at the prime rate plus two percent. Only one note per participant may be outstanding at any one time. Principal and interest on participant notes receivable are repaid through payroll deductions and are generally repaid within five years.

Payment of Benefits - Distributions from the Plan will be made in a single lump-sum payment; or if an in-service distribution, may be received in partial distributions. If a participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it may be made. If the participant's vested interest does not exceed \$5,000, then the participant's benefit will be distributed in a lump-sum as soon as practicable following the event that led to the participant being entitled to a distribution.

Forfeited Accounts - Forfeitures may first be used to pay Plan administrative costs and then to reduce the employer's matching contribution to the Plan. During the year ended December 31, 2024, forfeitures were not used to pay for Plan administrative expenses or reduce employer matching contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$25,932 and \$14,618, respectively.

Basis of Accounting - The Plan's financial statements are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America require the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Note 2 – Summary of Significant Accounting Policies**

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, which generally is the quoted market price, representing the net asset value (NAV) of shares held by the Plan at its year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis with dividends being recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on its investments bought and sold as well as those held during the year.

Notes Receivable from Participants - Notes receivable from participants (Note 1) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

During the year ended December 31, 2024, the Plan incurred \$62,721 of contract and administrative expenses with its third-party administrator, investment advisor and custodian (Note 4). These charges are reflected in the accompanying statement of changes in net assets available for benefits.

Recent Accounting Pronouncements - During the year ended December 31, 2024 and through July 28, 2025, there were several new accounting pronouncements issued by the Financial Accounting Standards Board (FASB). Each of these pronouncements, as applicable, has been or will be adopted by the Plan. Management does not believe the adoption of any of these accounting pronouncements has had or will have a material impact on the Plan's financial statements.

Subsequent Events - In preparing the accompanying financial statements, management of the Plan has reviewed all events and transactions occurring after December 31, 2024 through July 28, 2025 and determined there were no events or transactions that should be adjusted for or disclosed in the accompanying financial statements.

**Note 3 – Fair Value Measurements**

Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

**Level 1** Valuations based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Level 2** Valuations based on quoted prices in markets that are not active, or financial instruments for which all significant inputs are observable; either directly or indirectly; and

**Level 3** Valuations based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable; thus, reflecting assumptions about the market participants.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Mutual funds:* valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* consists primarily of shares of registered investment companies that are valued at the closing price reported on the active market on which the individual securities are traded and is classified in Level 1 of the fair value hierarchy.

*Common/collective trusts:* valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying instruments held by the fund less its liabilities.

**Note 4 – Related-Party Transactions and Party-In-Interest Transactions**

Empower Retirement is the Plan’s custodian and, therefore, any transactions with the Plan qualify as party-in-interest transactions. During the year ended December 31, 2024, fees paid by the Plan for recordkeeping fees amounted to \$29,819.

In addition, during the year ended December 31, 2024, the Plan paid fees for investment consulting and advising totaling \$32,902.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan terminating, participants will become 100% vested in their account balances.

**Note 6 – Reportable Transactions**

There were no reportable transactions or uncollectible, non-exempt transactions with parties-in-interest or any other prohibited transactions which would require supplemental presentation under Department of Labor rules and regulations.

**Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

It is not possible at this time to reasonably estimate the possible loss or range of loss, if any. We further caution that it is not possible to list all such factors, and you should not consider the identified factors as a complete list of all risks and uncertainties.

**Note 8 – Federal Income Tax Status**

The Plan, as originally drafted, is a Volume Submitter Profit-Sharing Plan with Cash or Deferred Arrangement. The Internal Revenue Service has determined and informed the Sponsor of the prototype plan by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. However, a determination letter from the Internal Revenue Service has not yet been requested by the Company to determine if the Plan as amended was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and ERISA and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9 – Information Prepared and Certified by Custodian (Unaudited)**

For the years ended December 31, 2024 and 2023, the Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors to not perform any auditing procedures with respect to the information certified by the custodian of the Plan in 2024 and 2023, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule.
