**1. DESCRIPTION OF THE PLAN**

The following description of Whole Enchilada, Inc. (dba big Burrito Restaurant Group) 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General**

The plan is a defined contribution plan adopted on January 1, 2000, covering all employees of the Company who have one year of service and are age 21 and older. A year of service is a twelve consecutive month period, beginning on the date of hire, during which the employee completes 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year employees may make pretax contributions, as defined in the plan, up to the maximum permitted by law. The Company contributes 25% of the employee contribution up to a maximum of 4% of the employee's pretax annual compensation. The Company may also make other contributions to the Plan which is at the option of the Company's Board of Directors.

The plan also provides the participants who are age 50 or older by the end of the calendar year and who are making deferral contributions to make catch-up contributions as permitted by IRS; catch-up contributions will also be matched by the Company at the same rate as regular pretax contributions.

Employees may also make after-tax Roth Contributions as defined in the Plan, up to the maximum permitted by law.

Additionally, the plan provides for rollover contributions from eligible rollover distributions that participants received from a prior employer's eligible retirement plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures

If an employee terminates employment, the nonvested portion of contributions are treated as forfeitures and are retained by the Plan to be used to pay expenses and reduce future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,747 and \$10,889, respectively.

Investment Options

Upon enrollment in the plan, each participant may direct their contributions into several investment options provided by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service for any reason, a participant may receive a lump-sum amount equal to the value in the participant's vested interest in his or her account. Beneficiaries may elect to receive death benefits over an extended period of time, as defined.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through July 14, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for the benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contribution Payable

Amounts payable to participants totaling \$36,352 for contributions in excess allowed by the IRS are reported as distribution payable, with corresponding addition to 2024 benefits paid to participants. The plan distributed the 2024 excess contributions prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in administration expenses.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits, except fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 and Level 3 inputs were available to the Plan. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the years presented.

Level 1 Fair Value Measurements

The fair values of mutual funds and money market funds are based on quoted net asset values of the shares reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**5. ADMINISTRATIVE EXPENSES**

Plan administrative expenses consisted of investment related expenses, service, and asset charges of \$31,335 and \$25,026 in 2024 and 2023. Remaining operating and administrative expenses were paid by the Plan sponsor.

**6. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds and investment contracts managed by Fidelity who is the trustee under the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the years ended December 31, 2024 and 2023 amounted to \$1,756 and \$1,150. The Plan sponsor pays directly any other fees related to the Plan's operations.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**8. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated September 18, 2001, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**1. DESCRIPTION OF THE PLAN**

The following description of Whole Enchilada, Inc. (dba big Burrito Restaurant Group) 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General**

The plan is a defined contribution plan adopted on January 1, 2000, covering all employees of the Company who have one year of service and are age 21 and older. A year of service is a twelve consecutive month period, beginning on the date of hire, during which the employee completes 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year employees may make pretax contributions, as defined in the plan, up to the maximum permitted by law. The Company contributes 25% of the employee contribution up to a maximum of 4% of the employee's pretax annual compensation. The Company may also make other contributions to the Plan which is at the option of the Company's Board of Directors.

The plan also provides the participants who are age 50 or older by the end of the calendar year and who are making deferral contributions to make catch-up contributions as permitted by IRS; catch-up contributions will also be matched by the Company at the same rate as regular pretax contributions.

Employees may also make after-tax Roth Contributions as defined in the Plan, up to the maximum permitted by law.

Additionally, the plan provides for rollover contributions from eligible rollover distributions that participants received from a prior employer's eligible retirement plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after six years of credited service.

Forfeitures

If an employee terminates employment, the nonvested portion of contributions are treated as forfeitures and are retained by the Plan to be used to pay expenses and reduce future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,747 and \$10,889, respectively.

Investment Options

Upon enrollment in the plan, each participant may direct their contributions into several investment options provided by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service for any reason, a participant may receive a lump-sum amount equal to the value in the participant's vested interest in his or her account. Beneficiaries may elect to receive death benefits over an extended period of time, as defined.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through July 14, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for the benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value, except fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contribution Payable

Amounts payable to participants totaling \$36,352 for contributions in excess allowed by the IRS are reported as distribution payable, with corresponding addition to 2024 benefits paid to participants. The plan distributed the 2024 excess contributions prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in administration expenses.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits, except fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 and Level 3 inputs were available to the Plan. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the years presented.

Level 1 Fair Value Measurements

The fair values of mutual funds and money market funds are based on quoted net asset values of the shares reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**5. ADMINISTRATIVE EXPENSES**

Plan administrative expenses consisted of investment related expenses, service, and asset charges of \$31,335 and \$25,026 in 2024 and 2023. Remaining operating and administrative expenses were paid by the Plan sponsor.

**6. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds and investment contracts managed by Fidelity who is the trustee under the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the years ended December 31, 2024 and 2023 amounted to \$1,756 and \$1,150. The Plan sponsor pays directly any other fees related to the Plan's operations.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**8. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated September 18, 2001, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
