We have performed audits of the financial statements of Carhartt, Inc. Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 - Plan Description**

The following description of Carhartt, Inc. Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

Carhartt, Inc. (the "Company") implemented the Plan effective July 1, 1998. The Plan is a defined contribution plan covering employees who are covered by a collective bargaining agreement. Employees are eligible to begin contributing to the Plan upon attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Contributions to the Plan are invested as directed by the participant in any of one or more investment alternatives. The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code.

The Plan provides for employer fixed contributions equal to 3 percent of gross wages.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted the 2023 late contributions and related lost earnings during 2024.

Effective April 14, 2022, certain employees were automatically enrolled in the Plan, unless they opted out, at a deferral rate of 1 percent of compensation. For these same employees, the Plan provides for employer matching contributions of 100 percent of the participant's contribution, not to exceed 1 percent of the employee's deferred compensation. Effective April 12, 2024, the group of employees eligible for the matching contribution expanded to additional divisions, and, effective April 1, 2025, the group of employees eligible for the matching contribution expanded to all divisions.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately vested in their employee deferrals plus actual earnings thereon. Participants are vested in the Company's contributions plus related earnings thereon based on percentages for each year of credited service, with 100 percent vesting after three years of service.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of service. Upon termination, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

**Note 1 - Plan Description (Continued)**

Participants may request that a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Party-in-interest Transactions***

Certain plan assets are invested in funds managed by Vanguard Fiduciary Trust Company, the custodian. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, the Company paid certain administrative expenses on behalf of the Plan.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Participant Notes Receivable***

No notes receivable are permitted under the Plan.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these collective trust funds. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 16, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 4 - Certified Information**

Vanguard Fiduciary Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Carhartt, Inc. Union 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1 - Plan Description**

The following description of Carhartt, Inc. Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

Carhartt, Inc. (the "Company") implemented the Plan effective July 1, 1998. The Plan is a defined contribution plan covering employees who are covered by a collective bargaining agreement. Employees are eligible to begin contributing to the Plan upon attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Contributions to the Plan are invested as directed by the participant in any of one or more investment alternatives. The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code.

The Plan provides for employer fixed contributions equal to 3 percent of gross wages.

Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The Company remitted the 2023 late contributions and related lost earnings during 2024.

Effective April 14, 2022, certain employees were automatically enrolled in the Plan, unless they opted out, at a deferral rate of 1 percent of compensation. For these same employees, the Plan provides for employer matching contributions of 100 percent of the participant's contribution, not to exceed 1 percent of the employee's deferred compensation. Effective April 12, 2024, the group of employees eligible for the matching contribution expanded to additional divisions, and, effective April 1, 2025, the group of employees eligible for the matching contribution expanded to all divisions.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants are immediately vested in their employee deferrals plus actual earnings thereon. Participants are vested in the Company's contributions plus related earnings thereon based on percentages for each year of credited service, with 100 percent vesting after three years of service.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of service. Upon termination, a participant shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

**Note 1 - Plan Description (Continued)**

Participants may request that a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

***Party-in-interest Transactions***

Certain plan assets are invested in funds managed by Vanguard Fiduciary Trust Company, the custodian. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, the Company paid certain administrative expenses on behalf of the Plan.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Participant Notes Receivable***

No notes receivable are permitted under the Plan.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these collective trust funds. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 16, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 4 - Certified Information**

Vanguard Fiduciary Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
