1. Summary of Significant Accounting Policies

A summary of the major accounting policies followed by the Karsten Interior Services, L.P. ("Company") 401(k) Retirement Plan ("Plan") in the preparation of the accompanying financial statements is presented below:

The Plan was initiated on January 1, 1999. The financial statements of the Plan are prepared under the accrual method of accounting.

The 401(k) Plan is qualified under Section 401(a) of the Internal Revenue Code and is exempt from Federal Income Taxes under 501(a) of the Internal Revenue Code.

The Company adopted a Volume Submitter Profit Sharing Plan (VSPS Plan) with CODA sponsored by Third Party Trust Company. The Internal Revenue Service has determined and informed the VSPS Plan Sponsor by a letter dated June 30, 2020 that the VSPS Plan and related trust are designed in accordance with applicable sections of the IRC. The VSPS Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. For federal income tax purposes the tax returns essentially remain open for possible examination for a period of three years after the date on which those returns are filed.

The Plan's investments in mutual funds and pooled separate accounts are reported at fair value as determined by Principal Financial Group, the Issuer, based on quoted market values of underlying assets. Purchases and securities are recorded on a trade-date basis.

Investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

The participant loans are classified as notes receivable and measured at their unpaid balance plus any accrued but unpaid interest.

1. Summary of Significant Accounting Policies (Continued)

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Investments

The Plan's investments are held by a retirement plan insurance company and are composed of general and pooled funds. Pooled separate accounts are comprised of stocks, bonds, mutual funds, and real estate investments.

The general fund is composed of a Guaranteed Interest Account stated at contract value which provides a guaranteed interest rate for a period of time as determined by the Plan.

3. Guaranteed Investment Contracts With Principal Financial Group

On January 1, 2024 and 2023, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Financial Group (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. Plan Participants' Equity

The net assets available for Plan benefits are composed of the trust fund established by the Plan's Trustee for the benefit of the plan participants.

5. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the company who have more than one year (1,000 hours within 12 months) of service. It is subject to the provisions of the Employee Retirement Security Act (ERISA).

The trustees of the Plan are the managing partner and chief financial officer of the plan sponsor/Company. Among other duties, the trustees are responsible for overseeing the Plan and evaluating plan management and service providers. Principal Financial Group serves as the custodian of the Plan's assets. The custodian's duties include receiving contributions, holding and investing fund assets in accordance with the directions of the participants, making distributions as directed by the plan administrator, recordkeeping, and transaction processing, including maintaining complete and accurate account records for all plan participants, allocating contributions and earnings, posting distributions and forfeitures to participant accounts, and preparing participant statements and reports. Nova Associates, Inc., serves as the third party administrator responsible for plan administration, compliance, and preparing the Plan's annual form 5500.

Contributions

For 2024 and 2023 participants may contribute a percentage of their annual wages up to the federal mandated limit of \$23,000 and \$22,500, with an additional \$7,500 catch-up contribution for employees at age 50 by the end of the year.

The Plan also allows for discretionary employer matching and/or employer non-elective contributions that are determined and funded on an annual basis. In the year ended December 31, 2024 and 2023, the Company made a matching contribution of 100% up to 6% and 50% up to 6% of participant contributions, respectively.

Participant Loans

Loans are treated as participant directed investments. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum cannot exceed limits specified by the Internal Revenue Service (IRS) for the outstanding balance of all other loans made to the participant by any other plan maintained by the Employer or a related company. Interest rates on outstanding loans range from 3.25% to 10.50%.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures result from nonvested benefit payments remaining in the Plan for all terminated employees. Upon reaching the break-in service requirement as defined by the Plan agreement, forfeitures generated are added to the forfeiture reserve balance and shall be used to reduce future employer contributions. At December 31, 2024 and 2023, the total forfeited non-vested accounts that have been applied totaled \$16,355 and \$5,643.

Vesting

Participants are always 100% vested in amounts contributed from their salary deferrals. Participants will always be vested if they are employed on or after their normal retirement age. The vesting percentage in the participant's account generated from employer non-elective and matching contributions is determined as follows:

Administrative Charges

All administrative expenses of the Plan, except amounts paid for certain investments, advisory services and bank charges, are paid by the Company.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will be entitled to receive 100% of their account balance in either a lump sum amount or in annual installments over a specified period of time. On termination of service for reasons other than death, disability or retirement, a participant will be entitled to receive only the vested percentage of their account balance and the remainder of their account will be forfeited.

A participant may at any time file for a hardship distribution based on account of an immediate and heavy financial need.

In-Service distributions may be made to a Participant who has not separated from service provided the participant has attained the age of 59 1/2 and can only be made from accounts that are fully vested.

6. Continuation of the Plan

The Company plans to continue the Plan indefinitely, but has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

7. Participant Directed Investments

Investments held by the Plan represent participant-directed accounts where individual participants decide how funds held in trust for them are allocated among various investments. Participants should see the Principal Financial Group Retirement Plan website for the available investment choices.

8. Certification Information

As permitted by 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information prepared and certified by a bank or insurance company, which is regulated, supervised and subject to periodic examination by a state or federal agency, need not be audited.

The plan administrator has obtained certifications from the Principal Life Insurance Company (custodian) that all information provided by them is complete and accurate. Information included in the accompanying financial statements and notes to financial statements as to investments, net appreciation (depreciation) in fair value of investments, interest income and all information in the Supplemental Schedule H, line 4i, Schedule of Assets (held at year end), is presented solely upon reliance on those certifications. The independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information in the financial statements, notes to financial statements, and supplemental schedules.

9. Party-in-Interest Transactions

Plan investments are in funds managed by Principal Financial Group, an entity that is a party-in-interest with respect to the Plan. These transactions are exempt and covered by the Prohibited Transaction Exemption provisions of ERISA and the Code.

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Auditing fees paid by the Company on behalf of the Plan were \$17,920 and \$15,000 for the years ended December 31, 2024 and 2023.

10. Fair Value Measurements

In July 2015, the FASB issued ASU 2015-12, Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), and Health and Welfare Benefit Plans (Topic 965): Part (1) Fully Benefit-Responsive Investment Contracts, Part (II) Plan Investment Disclosures, Part (III) Measurement Date Practical Expedient. This three-part standard simplifies employee benefit plan reporting with respect to fully benefit-responsive investment contracts and plan investment disclosures, and provides for a measurement-date practical expedient.

Parts I and II are effective for fiscal years beginning after December 15, 2015 and should be applied retrospectively, with early application permitted. Part III is effective for fiscal years beginning after December 15, 2015 and should be applied prospectively, with early application permitted. Accordingly, the standard requires fully benefit-responsive investment contracts to be reported at contract value instead of fair value on the Statement of Net Assets Available for Plan Benefits retrospectively applied.

The Plan's investments, except for guaranteed investment contracts, are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are other than quoted prices that are observable; and Level 3 inputs are unobservable inputs used for valuing the asset and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 Fair Value Measurements

The fair value of pooled separate funds is based on quoted net asset values of the underlying assets held by the Plan at year-end, but is not publicly quoted in an active market.

11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

12. Subsequent Events

Subsequent events were evaluated by management through July 25, 2025, which is the date the financial statements were available to be issued. No additional disclosures were considered necessary.
