Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Brungardt Honomichl & Company, P.A. Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Brungardt Honomichl & Company, P.A. Employees' Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of Brungardt Honomichl & Company, P.A (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Matrix Trust Company ("Matrix") serves as the custodian of the Plan, North American KTRADE Alliance, LLC ("KTRADE") is the Plan's participant recordkeeper. TD Ameritrade is the custodian of the self-directed brokerage account. Employees of the Company serve as the Plan's trustees.

Eligibility – An employee is eligible to defer a portion of their salary to the Plan when the employee has reached age 18 and completed one hour of service. The Plan is not open to union employees, non-resident aliens and leased employees.

Contributions – Participants may contribute up to 100% of their annual compensation, subject to certain Internal Revenue Code ("IRC") limitations. Participants over age 50 are permitted to make catch-up contributions, as defined in the Plan.

The Company may match participant contributions at a discretionary rate. For 2024, the Company matched 50% of a participant's contributions up to a maximum of 6% of eligible compensation.

Additionally, the Company may make discretionary profit sharing contributions. Profit sharing contributions are allocated to eligible participants in accordance with applicable provisions of the Plan. A participant is eligible to receive the Company discretionary profit sharing contribution on the first day of the Plan quarter after completing one year of service, 1,000 hours, and being employed on the last day of the Plan year. There was no profit sharing contribution in 2024.

Participants' Accounts – Each participant's account is credited with the participant's contribution, employer contributions, and allocations of Plan earnings, and is charged with the participant's withdrawals and distributions. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – The Plan offers a variety of mutual funds, a money market account and self-directed brokerage accounts as investment options for participants.

Vesting – Participants' contributions are fully vested at all times. Effective January 1, 2024, the Plan was amended to change vesting for the employer discretionary contributions to 25% increments, with 25% vested after the first year and increasing in 25% increments with full vesting after 4 years. Prior to January 1, 2024, the employer discretionary contributions vested in 20% increments, with 20% vested after the second year, 40% vested after the third year, and increasing in 20% increments. After 6 years of service, Company contributions became fully vested. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures will be used by the Company to reduce future employer contributions or pay plan expenses. During 2024, approximately \$26,300 in forfeitures was used to pay Plan expenses. As of December 31, 2024 and 2023, there are approximately \$16,400 and \$27,000 in forfeitures available, respectively.

Payment of Benefits – Distributions from the Plan are made upon death, disability, retirement or termination pursuant to the Plan provisions and as permitted by law. A participant may elect to receive a distribution of their vested account balance in a single lump sum payment. If the account balance does not exceed \$7,000, the Plan allows for automatic distribution and a lump-sum payment is the only form of disbursement available. For distributions greater than \$1,000 but not exceeding \$7,000, the account balance will be rolled over into an individual retirement account, unless otherwise directed by the participant.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 3 years for a loan less than \$2,500, and 5 years for loans greater than \$2,500, except if the loan is to acquire the participant's principal residence, which has a maximum of 15 years. Interest rates are established as the Prime rate as published in the *Wall Street Journal*, plus 0.25%. A participant may only have one loan outstanding at a time. A participant's loan shall immediately become due and payable upon termination from employment for any reason, or upon failure to make a principal and/or interest payment, as provided in the loan agreement. The balance in the participant's account secures the loan.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Administrative Expenses – Plan fees and expenses, including fees and expenses connected with providing of investment advisory and administrative services by external service providers are paid from Plan assets. Expenses totaled \$70,245 for 2024. The Company may pay other professional fees associated with the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. Upon such termination of the Plan, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Contributions are recorded in the year service is rendered by the participant.

Investments Valuation and Income Recognition – The Plan’s Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Subsequent events have been evaluated through July 28, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the net asset value (“NAV”) of shares held by the plan at year end based on published quoted prices.

Money market account – Valued at cost plus accrued interest, which approximates fair value.

Self-Directed brokerage account – Consist of stocks and a deposit account. The stocks are valued at the closing price of shares held by the account at year end based on published quoted prices. The deposit account is valued at cost plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023:

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Interest and dividends
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year) except for Notes Receivable from Participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

A Plan investment is a money market account managed by Matrix. Matrix is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest. The Plan has a number of service providers, and such providers are parties in interest under ERISA. Notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The Company has adopted a Prototype Non-standardized Profit Sharing Plan with CODA which received a favorable opinion letter from the IRS on March 22, 2021, stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. SUBSEQUENT EVENTS

Effective March 15, 2025, the Plan was amended to change the Plan Sponsor to BHC, Inc. and the Plan name to BHC, Inc. Employees' Retirement Plan.
