## INDEPENDENT AUDITORS' REPORT

To the Trustees  
OnSolve, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the OnSolve, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **Basis for Opinion**

The Plan is a safe harbor defined contribution plan established on January 1, 2011, covering substantially all employees of OnSolve, LLC (the "Company"), except union employees, leased employees, non-resident aliens, interns and residents of Puerto Rico. Prior to September 1, 2020, employees are eligible to participate upon completing 30 days of service and are at least 21 years of age. Effective September 1, 2020, employees are eligible to participate on the first day of the month coinciding with or next following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management is responsible for oversight of the Plan, determines the appropriateness of the Plan's investments offerings and monitors investment performance.

On July 31, 2024, the Company was acquired by GardaWorld and integrated into its Crisis24 division.

**Plan Amendments:**

Effective January 1, 2023, the Plan was amended to exclude temporary and seasonal employees from participating in the Plan and to exclude imputed income and "tax gross up" from eligible compensation.

The Plan Sponsor intends to administer, and the Plan will adopt and make available Domestic Abuse Distributions pursuant to the domestic abuse provision of the SECURE Act 2.0 effective May 1, 2024.

**Contributions:**

Each year, participants may elect to contribute up to a maximum dollar amount as established by the Internal Revenue Service. Participants who have attained the age of 50 before the end of the Plan year are eligible to make additional catch up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Each year, the Company makes a 3% non-elective safe harbor contribution. Each year, the Company may make an additional discretionary matching contribution. No such additional discretionary matching contributions were made for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

An employee may roll over into this Plan, a distribution which qualifies as an "eligible rollover distribution" under IRC Section 402(c)(4). An "eligible rollover distribution" can only be made from a 401(a) plan, IRA, or annuity (IRA).

Eligible employees whose employment commencement date is on or after January 1, 2018, are automatically enrolled in the plan at their eligibility date at an elected deferral contribution rate of 3%, with an escalation provision of 1% increase up to 10% deferral rate annually. The participant may affirmatively elect a different percentage or elect not to make a deferral.

**Description of Plan (Continued)**

Participant Accounts:

Each participant's account is credited with the participant's contributions as well as the participant's allocation of the Sponsor's contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

Payment of Benefits:

On termination of service due to death, disability, or retirement, or other reasons, a beneficiary may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions may be made at the participant's election prior to termination upon attainment of age 59 1/2 or hardship as defined in the Plan document.

Notes Receivable from Participants:

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan may be repaid within 130 months. A participant may have no more than one outstanding loan at any one time.

**Note B**

**Significant Accounting Policies**

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition:**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Investment Committee determines the Plan's valuation policies. See Note I for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Use of Estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Expenses:**

Certain expenses of maintaining the plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant recordkeeping and specific participant transactions are charged directly to each participants' account and are included in administrative expenses. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and included in administrative expenses. A Plan expense account is maintained to hold revenue sharing funds the Plan receives from Empower Annuity Insurance Company of America pursuant to an agreement between Empower Annuity Insurance Company of America and the Plan. These revenue sharing funds are available to pay qualified Plan administrative or investment expenses. During 2024, \$72,758 was used to pay Plan expenses and credits of \$72,758 were received.

**Contributions:**

Participant contributions are recognized in the period the participant contribution is withheld from compensation. Company safe harbor nonelective contributions are recognized in the period the eligible compensation is paid to the participant.

**Payments of Benefits:**

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the Plan to comply with nondiscrimination rules.

**Fair Value Measurement Reclassification:**

During the year ended December 31, 2024, the Plan reevaluated the classification of its investment in the common collective trusts (“CCT”) within the fair value hierarchy. Historically, these investments were included within the fair value hierarchy based on observable inputs. However, management determined that the CCT investments are measured at net asset value (“NAV”) as a practical expedient and does not have a readily determinable fair value.

As a result, the investments have been reclassified and are now excluded from the fair value hierarchy table in accordance with applicable accounting guidance. This change in classification had no impact on the net assets available for benefits or on the investment valuation methodology used in prior periods. The comparative disclosures for the year ended December 31, 2023, have been adjusted to conform to the current year presentation.

**Note C**  
**Related Party Activity**

Certain plan investments are investments managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the trustees, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note D**  
**Information Prepared and Certified by Trustees**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan.

**Note E**

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**Note F**

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note G**

**Income Tax Status**

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H**

**Investment Contracts with Insurance Companies**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America ("Empower"), that invests contributions in the Key Guaranteed Portfolio Fund (the "Fund"). The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may transfer their account balance in the Fund to any other investment option offered under the Plan at any time with no restrictions or penalties, because the Fund is designed to be a Plan's only guaranteed/stable value/money market investment. In order to provide the participant with liquidity (100% for participant transfers),

there cannot be any actively competing guaranteed/stable value/money market investments in the Plan. Bond funds of durations longer than three years are permitted. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or
- (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Upon termination of the group annuity contract, the employer may (a) receive the payoff of the fund in a lump sum with a market value adjustment, (b) receive the payout of the fund in a lump sum at book value, or (c) maintain participant accounts in the Key Guaranteed Portfolio Fund.

**Note I**

**Fair Value Measurements**

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Fair Value Measurements (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the quoted net asset value of shares traded in active markets and held by the Plan at year end.

*Interest in pooled separate accounts:* The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund net asset value (NAV) calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day. The NAV is used as a practical expedient to estimate fair value and is determined by the trustee based on the fair value of the underlying assets in the account, less the liabilities.

*Interests in common collective trust funds:* Valued at the NAV of units of the collective trusts. This fund is a collective investment trust that contains asset-backed securities, corporate bonds, mutual funds and money market funds comprised of both underlying investment and contractual components which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. NAV is used as an estimate of fair value, as the reporting entity has the ability to redeem its investment at NAV as of the measurement date as collective investment trusts can be redeemed on a daily basis. NAV is a readily determinable fair value and is the basis for current transactions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note J**

**Subsequent Events**

Effective May 1, 2025, the Plan was merged into the Crisis24, Inc. 401(k) Profit Sharing Plan, sponsored by Crisis 24, Inc. As a result of the merger, substantially all assets of the Plan were transferred to the Crisis24, Inc. 401(k) Profit Sharing Plan. However, assets invested in the Key Guaranteed Portfolio Fund did not transfer at the time of the merger due to restrictions associated with the fund's contract provisions. These assets remain in the original Plan's account and will be transferred to the successor plan in accordance with the terms of the investment contract and applicable Plan provisions.

Subsequent events have been evaluated through July 14, 2025, which is the date the financial statements were available to be issued.
