Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Herrera School Buses and Coaches, Inc. Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan’s internal control over financial reporting (internal control) as a basis for designing our auditing procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Principal Life Insurance Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified a certain deficiency in internal control that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan’s financial statements will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

We consider the following deficiency in internal control to be a significant deficiency:

Personnel Pay Rate Documentation

Internal controls should be established to ensure pay rates and changes in pay rates for employees are documented. Of the 25 employees tested as part of our audit, none of the employees tested had a documented pay rate.

Recommendation: The Plan should implement internal controls and modify HR procedures to ensure employees' pay rates and changes in pay rates are adequately documented and approved.

During our audit, we also became aware of another matter that is an opportunity for strengthening internal controls and operating efficiency as follows:

Plan Meeting Minutes (Documentation)

A good practice is to have periodic meetings of the ownership group to discuss the retirement plan and to document the meeting minutes. Based on discussions with Plan personnel, a formal meeting was not held during the year and, therefore, there were no documented minutes.

Recommendation: At least annually, those individuals charged with governance of the Plan should meet and document any significant discussions, approvals, or changes to the Plan. Meeting minutes should be documented and maintained for any significant discussions or actions decided upon.

The disclosure of fair value measurements in Note 4 to the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. The attached schedule titled "AJE" summarizes adjustments, detected as a result of audit procedures and corrected by management. The attached schedule titled "PAJE" summarizes those adjustments that were not corrected by management.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

Their report dated June 14, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1) Description of Plan

The Herrera Buses and Coaches, Inc. Retirement Plan (the "Plan") was initially formed November 1993, and was adopted by Herrera Buses and Coaches, Inc. (the "Company"), the Sponsor of the Plan. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k)-profit sharing plan that covers employees of the Company who are at least 18 years of age and have completed one year of service. A year of service is defined by the Plan as 1,000 hours of service in the calendar year or completion of a participant's anniversary year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has been restated at various dates since its inception to comply with new ERISA standards as they are issued by the U.S. Department of Labor.

Contributions

Participants may contribute up to the maximum annual limits defined by the IRS. Participants may also contribute rollover amounts in cash from other qualified plans, including plans described by IRC 401(a), 403(a), 403(b) and 457(b). Participants contribute to the Plan based on their elective amounts. The Company matches the participant's contributions. The match equals 25% of the employees' contribution up to 4% of the employees' compensation. Additional amounts may be contributed by the Company at its discretion.

Participants direct the investment of their elective deferrals and discretionary contributions among investment options offered by the Plan. The amounts contributed may not exceed the maximum amounts prescribed by law.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (1) the employer's contributions, and (2) Plan earnings charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1) Description of Plan — continued

Forfeited Accounts

Forfeited nonvested portions of terminated participant's employer contribution accounts are available to meet the Employer's contribution obligations to the Plan or to pay Plan expenses, as directed by the Plan Administrator.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into several investment options offered by Principal Life. The investment options are:

Guaranteed Interest Account - Provides a guaranteed interest rate for a specified period as determined, or allowed, by the Plan. The rate credited is the rate in effect on the day when each deposit is directed in the participant's accounts. All rates credited during the twelve-month deposit year are averaged at a single composite rate. The underlying assets in the Guaranteed Interest Rate Account are invested mostly in private placement bonds, commercial mortgages, and residential mortgages.

Pooled Separate Accounts - Provides for a separate account for each electing participant. The value of the account is determined at the close of each business day based on market value. The value of the account is expressed in units. There are various types of separate accounts that invest in U.S. securities, money market instruments, real estate, intermediate-term fixed income loans, foreign stocks, and securities of companies listed in the Standard & Poor's 500 Stock Index.

Vesting

Participants are immediately vested in their employee deferral and related earnings. Vesting in the Company's contributions to their accounts plus earnings thereon is based on years of service. A participant's vesting is as follows:

A year of vesting service is a twelve-consecutive month period ending on the last day of each Plan year in which the participant is still employed.

Payments of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. Participants are also allowed to withdraw from their accounts in the event of undue financial hardship. Withdrawals for this reason are limited to the participant's contributions plus earnings thereon.

Plan Termination

Although it has not expressed an interest to do so, the Sponsor has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants will receive the full amount of their accounts.

Tax Status

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter in March 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

2) Summary of Significant Accounting Policies

Basis of Presentation

The Plan has adopted the Financial Accounting Standards Board (FASB) Codification (Codification). The Codification is the single source of authoritative generally accepted accounting principles in the United States (U.S. GAAP) recognized by the FASB to be applied by nongovernmental entities. All the Codification's content carries the same level of authority

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Except for certain contracts held by Principal Life Insurance Company described in Notes 4 and 5, investments are stated at the amounts certified to the Plan Administrator by Principal Life Insurance Company at December 31, 2024, which represents fair value at the statements of net assets available for plan benefits date. Guaranteed interest contracts are valued at contract value which approximates fair value. Guaranteed interest contracts are valued at the total of the net asset value of shares held at year-end which is based on the fair value of the underlying investments. Shares of pooled separate accounts are valued at net asset value of investments held at year end. Share of registered investment companies are valued at quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investment bought and sold as well as those held during the year are allocated based on participants' balances. The amount ultimately realized by participants upon receipt of benefits may differ from the amounts reported in these financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses incurred in the administration of the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are expenses charged to the underlying funds by the fund managers and are included in administrative expenses. Certain asset management and service fees are paid by the Plan and allocated to participants' accounts on a quarterly basis.

3) **Information Prepared and Certified by the Custodian**

The following information, included in the accompanying financial statements and the Schedule of Assets (Held at End of Year) was obtained from data that has been prepared and certified as complete and accurate by the custodian of the Plan. Principal Life Insurance Company served as the custodian as of December 31, 2024 and 2023, and during the years then ended.

4) Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1 Fair Value Measurements – Valuations based on unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

Level 2 Fair Value Measurements – Valuations based on inputs other than quoted prices included within Level 1 that are observable for the asset, either directly and indirectly. Observable inputs include quoted prices for similar assets active or non-active markets.

Level 3 Fair Value Measurements – Valuations derived through the use of valuation models or methodologies using significant unobservable inputs. Level 3 valuations incorporate certain assumptions and projections that are not observable in the market and as a result significant professional judgment may be used in determining the fair values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

As of December 31, 2024 and 2023, Plan investments held in pooled separate accounts with a fair value total \$4,319,590 and \$3,731,043, respectively. These investments are valued and reported at their NAV and are not included within the fair value hierarchy.

5) Investment Contract with Principal Life Insurance Company

The Plan has a guaranteed interest contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Investment contracts are fully benefit responsive; contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by Principal Life Insurance Company. The contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At December 31, 2024 and 2023 one of the Plan's investment contracts is fully benefit responsive.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Principal Life Insurance Company indicates that contract value approximates fair value for these investments at December 31, 2024 and 2023. The fair value and the contract value of the guaranteed interest account at December 31, 2024 and 2023 was \$20,696 and \$18,513, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the custodial account to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7) Related Parties

The Plan's investments in pooled separate accounts and guaranteed interest accounts include assets managed by the Plan's custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$7,496 and \$5,547 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8) Subsequent Events

Management evaluated subsequent events through June 3, 2025, the date the financial statements were available to be issued. Events or transactions occurring after December 31, 2024, but prior to June 3, 2025, that provided additional evidence about conditions that existed at December 31, 2024 have been recognized in the financial statements for the year ended December 31, 2024. Events or transactions that provided evidence about conditions that did not exist at December 31, 2024 but arose before the financial statements were available to be issued, have not been recognized in the financial statements for the year ended December 31, 2024
