As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

1. Description Of Plan

The following description of the Flood & Peterson Insurance, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Flood & Peterson Insurance, Inc. (the Company) who are age 21 or older and have completed 6 months of service. Employees become eligible on the first day of the calendar quarter following their completion of the above requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration

The Company is the administrator of the Plan. As an administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, the Custodian) serve as custodian for the Plan, manage Plan assets and maintain the Plan's records at the direction of the Plan's administrator.

Contributions

Contributions to the Plan include salary reduction contributions authorized by participants, rollovers from other qualified retirement plans, nonelective contributions made by the Company, discretionary matching contributions made by the Company and discretionary profit sharing contributions made by the Company.

Participants may contribute up to 100% of their compensation, not to exceed the dollar limit set by law, to the Plan (\$23,000 in 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 in 2024). Participants have the option of deferring their compensation on a pre-tax or post-tax basis.

The Company makes a nonelective contribution on behalf of each of its eligible employees. The nonelective contribution is 3% of a participant's eligible compensation, as defined in the Plan.

Notes To Financial Statements (*Continued*)

Company matching contributions and profit sharing contributions are at the discretion of the Company's Board of Directors. Participants must be employed on the last day of the Plan year to be eligible for the Company discretionary matching contribution and profit sharing contribution. In 2024, the Company made a matching contribution to each eligible participant's account equal to 25% of the amount contributed by the participant. No profit sharing contributions were made in 2024.

Participant Accounts

Participant accounts are credited with participant's contributions, the Company's contributions, an allocation of Plan earnings (losses) and administrative expenses. The allocation of earnings (losses) is determined by the earnings (losses) of the participant's investment selection based on each participant's account balance and the investments selected by the participant.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any of several investment options sponsored by an insurance company. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their voluntary contributions and their share of the Company nonelective contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service (as defined) and is determined as follows:

Forfeited Accounts

At December 31, 2024 and 2023, the Plan had a balance of \$2,944 and \$8,382, respectively, in forfeited nonvested accounts. These amounts will be used to pay Plan expenses or reduce future Company contributions, and unused forfeiture balances will be reallocated to participants in the same manner as employer contributions. During the year ended December 31, 2024, \$10,732 was used to reduce employer contributions.

Payment Of Benefits

Upon termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or have the payment made as a direct rollover to an individual retirement account or to another employer's tax-qualified plan in an amount equal to the vested value of his or her account.

In-Service Distributions

Active participants who reach age 59½ or experience a qualifying financial hardship may withdraw all or part of their vested account. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Code (the IRC) safe harbor withdrawal provisions.

Administrative Expenses

Significant administrative expenses of the Plan may be paid directly by the Company, if sufficient forfeiture amounts are not available within the Plan. Administrative expenses paid by the Plan included recordkeeper fees, service fees and transaction fees.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments held by a defined contribution plan, other than fully benefit-responsive investments contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net change in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits, and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments held by a defined contribution plan and that are fully benefit-responsive are reported at contract value rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the EI Fixed Account - Series Class V Fund is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Under the terms of the contract, participant-initiated transactions for the purpose of receiving benefits allowed under the Plan, such as retirement, death, disability, hardship, loan, required minimum distribution or allowable in-service withdrawal, are completed at contract value without conditions, limits or restrictions. Benefits related to termination of employment receive the same treatment unless a termination is associated with a full or partial Plan termination, the insolvency of the Plan sponsor or aggregate terminations in any contract year exceeding 20% of the full contract value as determined on the first day of that contract year.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The crediting interest rate was 2.41% and 2.23% as of December 31, 2024 and 2023, respectively.

Payment Of Benefits

Benefits are recorded when paid.

3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net change in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Assets are valued at the daily closing price as reported by the funds. Mutual funds are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

There have been no changes in the valuation methodology used at December 31, 2024 or 2023.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and any unallocated assets of the Plan shall be allocated to participant accounts as defined by the Plan.

6. Tax Status

The Plan utilizes a pre-approved plan document sponsored by the Custodian. The Custodian received an opinion letter from the IRS, dated November 14, 2022, which states that the pre-approved plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party In Interest Transactions

Plan investments include a guaranteed investment contract managed by the Custodian as of and for the year ended December 31, 2024, and as of December 31, 2023. These transactions qualify as party in interest transactions allowable under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

Management has evaluated subsequent events through the date the financial statements were available for issuance, which is the date of the Independent Auditors' Report.
