Report on the Audits of the Financial Statements

NOTE 1 DESCRIPTION OF PLAN

The following description of the Vista Pacifica Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement or summary Plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on October 1, 1993 and most recently restated effective December 31, 2020, which was adopted by Vista Pacifica Enterprises, Inc. (the Company) under the provisions of Section 401(k) of the Internal Revenue Code of 1986 (IRC) and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and IRC, as amended.

Eligibility

The purpose of the Plan is to provide retirement benefits for substantially all employees who are a minimum of 21 years of age and have completed one year of service consisting of at least 1,000 hours. Employees become eligible to enroll on a semiannual basis following the satisfaction of eligibility requirements.

Contributions

Participants may elect to contribute up to 90% of their annual wages for up to a maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides for a safe harbor matching contributions of 3% of Plan compensation plus 50% of contributions between 3% and 5% of Plan compensation. The Plan also allows for a discretionary matching and profit-sharing contribution. To be eligible for employer profit-sharing contribution, a participant is required work at least 1,000 hours and be an employee of the Company as of the last day of the Plan year. During 2024, the Company elected to contribute a discretionary profit-sharing contribution for all eligible participants.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their voluntary, rollover, and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon is based on years of continuous service. A participant becomes 100% vested in discretionary contributions after three years of service.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment to be paid in a lump sum to the participant without the participant's consent. If the balance of the terminated participant's account is between \$60 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for in-service distributions if a participant reaches age 59½ subject to Plan provisions.

Forfeitures

Forfeitures of the employee's nonvested portion of the Company's discretionary matching and profit-sharing contributions are used to reduce future employer's contributions or to pay Plan expenses. During the year ended December 31, 2024, \$5,888 in forfeitures were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,172 and \$5,888, respectively, and are included in cash and cash equivalents in the accompanying statements of net assets available for benefits.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

At December 31, 2024 and 2023, the fair value of the Plan's investments in pooled separate accounts and the stable value fund is measured using the net asset value per share (NAV) as a practical expedient. Each unit in these accounts invests directly in a unit of the underlying investment. Unit values are calculated based on the observable NAV of the underlying investment in the funds, as more fully described in Note 8.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date.

Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits as Net Appreciation (Depreciation) in Fair Value of Investments.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses incurred by the Plan are absorbed by the Company, and such expenses are not recorded in the Plan's financial statements. Additionally, certain administrative functions are performed by officers or employees of the Company; however, no such officer or employee received compensation from the Plan. The administrative expenses that are paid by the Plan consist of third-party administrator fees and other administrative fees charged by the custodian.

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

NOTE 3 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION

John Hancock Life Insurance Company (U.S.A), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of investments as of December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, in the accompanying financial statements and ERISA-required supplemental schedule.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
