### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Partners Enterprise Capital Holdings LLC 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Basis for Opinion

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **NOTE 1 PLAN DESCRIPTION**

The following description of Partners Enterprise Capital Holdings LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees excluding those covered by a collective bargaining agreement of the real estate operating companies, which are majority owned by Partners Enterprise Capital Holdings LLC, the Plan sponsor. Employees are eligible to participate in the Plan on the first day of the month following one month of employment and once they have reached the age of 19. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute a percentage of their pretax annual compensation as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 5% of eligible compensation. Participants also have the option to contribute post-tax compensation through Roth 401(k) contributions. The employer provides a safe harbor matching contribution equal to 100% of the employee contributions up to 3% of the employee's eligible compensation, plus an additional 50% of contributions between 3% and 5% of the employee's eligible compensation. Additional profit sharing contributions may be contributed at the option of the Plan sponsor and each participating employer. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the employer's contribution, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and the employer's contributions, plus actual earnings thereon.

**Investment Options**

Upon enrollment in the Plan, a participant may direct the investment of employee and employer contributions into various investment options. The Plan currently offers mutual funds and a collective investment trust. Participants may change their investment options at any time.

**Forfeitures**

Forfeitures occur when a terminated participant does not claim their distribution of Plan benefits. These unclaimed benefits are held in forfeiture until claimed by the participant. Forfeited accounts totaled \$11,508 and \$8,212 at December 31, 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding from the Plan at any one time. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the participant's account and bear interest rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Participants or their beneficiaries are eligible for benefits upon termination, retirement, death or disability. Benefits shall be distributed through a lump sum payment in the form of a non-rollover or a direct rollover distribution. Accounts with a vested interest between \$1,000 and \$5,000 will be distributed to an individual retirement account for the participant's benefit. Accounts with a vested interest less than \$1,000, upon termination for any reason, will be distributed in full without option for installments.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need and are limited to a participant's vested account balance.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

In accordance with the Plan Document, loans are considered to be in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Defaulted loans will be reported as taxable deemed distributions in the year in which default occurs. During the years ended December 31, 2024 and 2023, deemed distributions in the amount of \$8,707 and \$978, respectively, were reported with distributions to participants in the statements of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan. The amount of such expenses and cost of such services have not been determined. Certain other administrative expenses are paid directly by the Plan.

**Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds*—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust*—The collective investment trust is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the issuer's collective trust. The net asset value is used as the practical expedient to estimate the fair value.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE 6 TAX EXEMPT STATUS**

The Plan adopted the Non-Standardized Pre-Approved Profit Sharing Plan sponsored by FMRLLC which obtained its latest determination letter on June 30, 2020 in which the IRS stated the Plan, as then designed, was qualified and the trust established under the Plan was tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan Administrator and the prototype plan sponsor believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE 7 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in accounts managed by Fidelity Management Trust Company (Fidelity). Fidelity is also the Plan trustee, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Officers of the real estate operating companies are participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through June 12, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
