Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Prudential Lighting Corporation Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all eligible employees who have completed six months of service and have attained the age of 18. The Plan excludes all employees covered by a collective bargaining agreement. The Plan entry dates are January 1 and July 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Contributions

The Plan may, at its sole discretion, elect to make employer contributions for any Plan year, and any such employer contribution shall be allocated to eligible participants pro rata as a uniform percentage of participant compensation for the Plan year. Participants may also contribute amounts representing distributions (roll-over contributions) from other qualified benefit plans. Participants direct the investment of all contributions to their account into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the employer's contribution plus any Plan earnings. Forfeited balances of terminated participants' nonvested accounts are allocated as additional nonelective contributions.

Allocations are based on participants' earnings. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

The participants' vested accounts for any employer contributions are based on years of service and do not have to be continuous. A participant is 100% vested after six years of credited service, death, disability or upon attainment of normal retirement age. A participant is fully vested in employee contributions (roll-over contributions).

Payment of Benefits

Upon termination of service a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution, annual installments, partial distribution, or an annuity. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment to be paid in a lump sum to the participant without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for hardship distributions subject to Plan provisions.

Plan Administrative Costs

All significant costs of administering the Plan are paid by the Plan.

Investment Options

Upon enrollment in the Plan, a participant may direct employer contributions to any of the available investment options.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Employer contributions are recorded in the year in which the employee compensation used in the calculation is paid.

Benefit Payments

Benefit payments are recorded when paid.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits presents the fully-benefit-responsive investment contracts at contract value. The statement of changes in net assets available for benefits is prepared using the contract value basis for fully benefit-responsive investment contracts.

Forfeitures

A participant's forfeiture of their nonvested account balance from employer contributions occurs when a participant is terminated. For the years ended December 31, 2024 and 2023, the balance of forfeitures was \$37,468 and \$21,448, respectively. Forfeitures are redistributed to existing participant accounts in the subsequent Plan year.

Subsequent Events

The Plan has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS HELD WITH TRUST COMPANY

Empower Trust Company and Prudential Insurance Company of America, the qualified institutions of the Plan, have supplied the Plan administration with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statement net assets available for benefits as of December 31, 2024 and 2023, and the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of the year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

As described in Note 2, the Guaranteed Interest Account (GIA), a fully benefit-responsive contract, is a group annuity product issued by Prudential Insurance Company of America (PICA). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is periodically reviewed for resetting.

Participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their contract value. Contract value, also known as book value, represents deposits plus earnings at guaranteed credit rates, less withdrawals and fees. The contract is effected directly between the Plan Sponsor and the issuer. The repayment of principal and interest credited to the participants is a financial obligation of the issuer.

The fair value reported represents the estimated proceeds that would have been paid had the contract been discontinued as of the Plan year-end date. Fair value is calculated by multiplying the Contractual Market Value Adjustment (MVA) by the contract value. The MVA formula is generally specified in the group annuity contract and is based on the standard formula which approximates the change in market value of a bond given a change in the rate environment. The MVA formula is equal to:

The average rate being credited under the contract (aged rate) minus the rate credited to new deposits for plans with similar (new rate environment) times a duration estimate.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on rate guaranteed by the issuer based at 3.00%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

- a. Amendments to the Plan's document (include complete or partial Plan termination or merger with another plan,
- b. Changes to the Plan's prohibition on competing investment options or deletion or equity wash provisions,
- c. Bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan (such as divestitures or spin-offs), or,
- d. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value participants are probable of occurring.

The group annuity contract does not permit the insurance company to terminate the agreement unless the Plan is not in compliance with the contract.

The guaranteed yield of the Guaranteed Interest Account (based on actual earnings and on the interest rate credited to Participants) for the years ended December 31, 2024 and 2023 is 3.00%.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed in various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower trust Company, and Prudential Insurance Company of America, the qualified institutions of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Empower Trust Company, is the Trustee as defined by the Plan. Empower Retirement acquired all of Prudential Financial Inc. full-service retirement business, which includes Prudential Trust Company, and Prudential Retirement Insurance Company, therefore these investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment advising, consulting, and annual audit services are included in administrative expenses. SageView Advisory Group, LLC is the Plan's investment advisor and has a fiduciary responsibility to the Plan. CliftonLarsonAllen LLP is the Plan's auditor: therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
