## Independent Auditor's Report

### Plan Administrator The J. Paul Getty Trust Employee Investment Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the J. Paul Getty Trust Employee Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, and the Schedule of Reportable Transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements.



The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1      DESCRIPTION OF THE PLAN**

The following description of The J. Paul Getty Trust Employee Investment Plan (the Plan or EIP) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**(a) General**

The Plan is a defined contribution plan, as defined under Section 403(b) of the Internal Revenue Code (IRC), which is funded by the employee before tax payroll contributions to purchase one or more Annuity Contracts or Custodial Accounts for the benefit of participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee is eligible to participate in the Plan if they meet the following criteria: (a) regular employee scheduled to work 20 hours or more a week or (b) regularly scheduled to work less than 20 hours a week, after completion of or with the anticipation that they will complete 1,000 hours of service within a 12-month period beginning on the date of hire or during any subsequent calendar year. An employee is not eligible to participate in the Plan if they are covered by a collective bargaining agreement or are classified as a leased employee.

Each eligible employee shall become a participant in the Plan as of the earliest of (a) the effective date of the eligible employee's contribution agreement, if any, (b) the date such eligible employee automatically becomes a participant, and (c) the date on which the eligible employee submits the administrative forms necessary to make a rollover contribution. Employees hired on or after January 1, 2009 will be automatically enrolled in the Plan within 30 days of their hire date.

Effective March 1, 2018, eligible employees who are not participants in the Plan or who are contributing less than 4% on July 1, 2018 will be automatically enrolled in the Plan with a 4% contribution or have their noncontribution increased to 4%.

Effective June 25, 2023, any employee who becomes eligible on or after that date will have their Compensation automatically reduced by 5%. This amount will be contributed as a Participant Pre-tax Contribution on behalf of the eligible employee.

**(b) Contributions**

An employee makes before-tax payroll contributions to the Plan each payroll period for a minimum of \$50 a year and up to the maximum limit allowed by the Internal Revenue Service (IRS). An employee who is age 50 or older before the end of a plan year can contribute a catch-up contribution to the Plan up to the maximum limit allowed by the IRS.

Effective January 1, 2014, the Plan also offers after-tax Roth contributions. Additionally, participants may also rollover amounts representing distributions from other qualified retirement or profit-sharing plans.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**(c) Participant Accounts**

The Plan is designed to satisfy section 404(c) of the Employee Retirement Income Security Act (ERISA) and Title 29 of the Code of Federal Regulations Section 2240.404 (c) -1. The program offers employees the opportunity to exercise control over their EIP account by allowing them to choose from a wide range of investments, determine the manner in which assets will be invested, and receive and access information necessary to make informed decisions with respect to the investment options under the Plan.

Each employee's account is credited (charged) by (a) the participant's contributions (b) allocations of investment earnings (losses), and (c) rollover contributions. Earnings or losses are allocated to the participants' accounts based on the proportion each account bears to the total of all account balances within each investment fund.

Effective October 1, 2018, participants may no longer elect Prudential as an investment for contributions.

**(d) Vesting**

Participants are immediately vested for their entire contributions plus actual earnings thereon.

**(e) Payment of Benefits**

Participants terminating employment receive the lump-sum value if it is less than or equal to \$5,000. If the account value is greater than \$1,000 but does not exceed \$5,000 and the participant does not elect to receive his or her benefit in a single lump-sum cash payment or to have such amount distributed directly to an eligible retirement plan, the amount will be distributed in a direct rollover to an individual retirement plan.

If the participant's total account balance is more than \$5,000, it can remain in the Plan or participants can request a lump-sum distribution to be paid either directly to the participant or rolled over into another qualified plan or IRA. If the participant elects to postpone receiving benefits, the Plan provides for distributions to be made after the participant attains the age of 73 or to the extent required by the IRC and ERISA, all amounts held in a Custodial Account shall become payable beginning no later than the earlier of the applicable date specified in (a) ERISA section 206(a) or (b) IRC sections 403(b)(10) and 401(a)(9), as each is amended and in effect from time to time. Upon death, the beneficiary will be entitled to receive 100% of the participant's accounts.

While actively employed at The J. Paul Getty Trust, a participant may be eligible to withdraw contributions excluding earnings from the EIP account to meet a financial hardship or upon reaching the age of 59 ½, make a lump-sum withdrawal of all or part of the account.

Effective August 1, 2018, a participant may elect to receive his or her balances under the Plan in monthly, quarterly, semi-annual or annual installments over a fixed period of time not to exceed the life expectancy of the participant or the joint life and last survivor expectancy of the participant and his or her beneficiary.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**(e) Payment of Benefits (Continued)**

Effective October 1, 2018, participants, beneficiaries of deceased participants and alternate payees shall no longer be permitted to give investment instructions to invest contributions made on his or her behalf in an annuity contract, and any such instructions previously given shall be rescinded. In addition, no exchanges from a custodial account to an annuity account shall be permitted.

**(f) Notes Receivable from Participants**

Participants are no longer permitted to borrow against their account with Prudential after May 1, 2012.

Effective May 1, 2012, participants may borrow against their interest in the custodial account with Vanguard Fiduciary Trust Company (Vanguard). The minimum loan amount is \$1,000 and the maximum amount is equal to the lesser of 50% of the participant's account balance or \$50,000. The length of time during which a participant is required to pay a loan depends on the purpose of the loan. A loan made to purchase a primary residence must be repaid within 15 years. Loans for other purposes must be repaid for a maximum of five years. Interest on the loan is based on the prime rate plus 1% at the time of the loan. Principal and interest are paid through after-tax payroll deductions.

Effective January 1, 2014, the Plan also offers general-purpose loans.

**(g) Plan Amendments**

*Compensation*

Compensation with respect to a participant means the base salary and overtime payments for the plan year, plus any such amounts that have been paid to the participant but for a salary reduction agreement under IRC section 125, 132(f)(4), 401(k) 403(b) or 457, and excluding bonuses, lump sum payments, car allowance payments, relocation allowance payments, and similar payments. Effective January 1, 2023, Compensation shall include lump sum payments designated by the employer as payments in lieu of salary increases.

*Automatic Enrollment for New Employees*

Effective June 25, 2023, an employee who becomes an eligible employee on or after June 25, 2023 is deemed to have elected to have his or her compensation reduced by 5% (and have that amount contributed as a participant pre-tax contribution on such eligible employee's behalf) at the time the employee becomes an eligible employee, and to have agreed to be bound by all the terms and conditions of the Plan. Contributions made under this automatic participation provision shall be made to the new participant's custodial account and invested in investment vehicles selected for the purpose of all new participants by the Committee. Any eligible employee who automatically becomes a participant shall file a designation of the beneficiary with the Custodial Account custodian and may change the election provided for in Section 4.1 (c)(1) in the manner described in 4.1(c)(2) of the plan document.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**(g) Plan Amendments (Continued)**

*Roth In-Plan Conversion*

Effective March 12, 2024, the Plan was amended to allow Roth In-Plan Conversions. Specifically, new definitions were added to Article 2 to define “Roth In-Plan Conversion” and “Roth In-Plan Conversion Account.” Additionally, Section 4.3 (“Rollover Contributions”) was amended to reflect updated rules governing the acceptance of rollover contributions, including the treatment of Roth rollovers. A new Section 4.13 was also added, outlining the rules for Roth In-Plan Conversions, including participant eligibility, account treatment, tax reporting requirements, and the irrevocable nature of such elections. Roth In-Plan Conversions allow participants to convert certain pre-tax contributions and rollover amounts to designated Roth accounts within the Plan, subject to applicable IRS regulations and Plan provisions.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**(a) Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

**(b) Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the trustees and management of the Plan to make certain estimates and assumptions. These affect the reported amounts of assets, liabilities, and changes therein, including the disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from the estimates made.

**(c) Investment Valuation and Income Recognition**

The Plan’s investments in mutual funds and money market funds are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Investments in insurance contracts are measured at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**(d) Net Appreciation (Depreciation) in Fair Value of Investments**

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation, or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in the fair value of investments.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**(e) Notes Receivable from Participants**

Notes receivable from participants are measured at the outstanding principal amount plus accrued, but unpaid interest.

**(f) Payment of Benefits**

Benefits are recorded when paid.

**(g) Administrative Expenses**

All usual and reasonable expenses are paid by the employer, and any expenses not paid by the employer may be paid from the plan assets if not prohibited by applicable law or regulation.

**(h) Risks and Uncertainties**

The Plan provides for various investment options in mutual funds and money market funds. Investment securities are exposed to various risks such as interest rate, credit risks, and overall market volatility. Because of the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the various risk factors, in the near term, could materially affect participants' account balances and the amounts reported in the accompanying financial statement.

**NOTE 3      INVESTMENTS AT FAIR VALUE**

The Plan follows Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*. ASC Topic 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

*Level 1:* Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2:* Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3:* Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All of the Plan's investments at fair value amounting to \$268,476,501 and \$231,687,967 as of December 31, 2024 and 2023, respectively, are actively traded and therefore, classified as Level 1.

**NOTE 4 INVESTMENTS AT CONTRACT VALUE**

The Plan has an existing fully benefit-responsive insurance contract with Prudential. Prudential maintains the contributions in a general account. The contract guarantees the principal and provides a stated rate of return backed by Prudential. The contract is included in the financial statements at contract value as reported to the Plan by Prudential. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The average yield based on actual earnings was approximately 4.00% both in 2024 and 2023.

The Plan follows Accounting Standards Update No. 2016-12 (the Update), *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965) – (I) Fully Benefit-Responsive Investment Contracts, (II) Plan Investment Disclosures, and (III) Measurement Date Practical Expedient (a consensus of the FASB Emerging Issues Task Force)*. This Update designates contract value as the only required measure for direct investments in fully benefit-responsive investment contracts. Accordingly, the Plan's investments in fully benefit-responsive investment contracts amounting to \$1,158,523 and \$1,407,184 as of December 31, 2024 and 2023 respectively, are presented at contract value.

**NOTE 5 INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES**

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by Prudential and Vanguard, the trustees of the Plan. The Plan Administrator has obtained certifications from the trustees that the information provided to the Plan Administrator by the trustees related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following:

- Investments, as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Notes 3 and 4;
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) - December 31, 2024;

**NOTE 5      INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES (CONTINUED)**

- Reportable Transactions, as reflected in Schedule H, Part IV, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024; and
- Insurance contracts reported at contract value as of December 31, 2024 and 2023 disclosed in Note 4.

**NOTE 6      PARTY-IN-INTEREST TRANSACTIONS**

Certain investments of the Plan are shares of mutual funds managed by Vanguard and insurance contracts managed by Prudential. These two entities are the trustees as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions that are exempt under ERISA.

**NOTE 7      PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE 8      TAX STATUS OF THE PLAN**

The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9      NEW LAWS AND REGULATIONS**

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0) became law. The new law includes provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods for plans years beginning after December 31, 2024.

**NOTE 10      SUBSEQUENT EVENTS**

The Plan Administrator has evaluated events or transactions that occurred subsequent to December 31, 2024, through July 24, 2025, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements and determined that no subsequent matters required disclosure or adjustment to the accompanying financial statements.
