### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Viridos, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (an ERISA 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Viridos, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### NOTE 1. DESCRIPTION OF PLAN

#### General

Viridos, Inc. 401(k) Retirement Plan (the "Plan") is sponsored by Viridos, Inc. (the "Plan Sponsor"). The Plan, which became effective on April 21, 2006, is a defined contribution plan covering all eligible employees of Viridos, Inc. as well as its subsidiary, Synthetic Genomics Vaccines, Inc. ("SGV"), the participating employers in the Plan. As of and for the year ended December 31, 2024, SGV had no active employees. Viridos, together with SGV, are hereinafter referred to as the "Company." The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the provisions of the Internal Revenue Code (the "Code").

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### Eligibility

Employees who are at least 18 years of age and have completed one month of service with the Company are generally eligible to participate in the Plan. Ineligible employees include residents of Puerto Rico, leased employees, those whose compensation and employment terms are established by a collective bargaining agreement, and non-resident aliens with no earned income from the Company which constitutes United States source income. Employees may enter the Plan on the first day of each month coincident with or next following the date on which the Plan's age and service requirements are met.

#### Participant Contributions

*Elective Contributions* – The Plan allows eligible participants to make elective salary reduction contributions in an amount up to 95% of eligible compensation as defined by the Plan and subject to statutory limits imposed by the Code. In addition, employees who are age 50 or older may elect to defer additional amounts (called "catch-up contributions") to the Plan up to the maximum allowed by the Code. The Plan permits both pre-tax deferral contributions, after-tax amounts designated as "Roth" contributions, and effective January 1, 2018, traditional after-tax deferrals are also allowable.

Participants may also contribute amounts representing rollover distributions from other qualified sources; however, the Plan does not accept rollovers of non-Roth after-tax employee contributions.

*Automatic Enrollment and Contributions* – The Plan includes provisions for automatic enrollment, generally as follows: newly-eligible employees, including those hired on or after January 1, 2015 without a deferral election or with a zero election on file (except those who affirmatively elect to not participate or those who elect a specific contribution amount), shall automatically have 3% of their eligible compensation deferred into the Plan.

*Automatic Escalation* – Newly-eligible employees who do not make an affirmative deferral election who are automatically enrolled will have their pre-tax deferral contribution increased annually on April 1 by 1% until a deferral rate of 10% is reached.

Employees may also opt out of the automatic enrollment and automatic increase features of the Plan by affirmatively electing to not participate or by specifying a different contribution percentage.

#### **Employer Contributions**

The Plan permits three types of discretionary employer contributions: matching contributions, nonelective employer contributions (profit sharing contributions), and qualified nonelective employer contributions. No employer matching contributions were made to the Plan for 2024. Since inception, and including for 2024, neither employer matching nor profit-sharing contributions have been made to the Plan. During 2024, no qualified nonelective contributions were made.

#### **Vesting**

Participants are always 100% vested in their contributions as well as any qualified nonelective employer contributions. Any nonelective employer contributions and employer matching contributions vest ratably over a four-year period based on years of vesting service as defined in the Plan.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the Plan's investment options. Subsequently, participants may change their allocations and transfer account balances between investment options in accordance with Plan provisions.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of (a) the employer's contributions, if any, and (b) investment earnings or losses, and may be charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Notes Receivable from Participants (Participant Loans)**

Participants may borrow against their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested interests in their account balance. Loans are required to be repaid within 5 years unless the loan is to be used to acquire the principal residence of the participant, in which case the loan repayment period (for loans made subsequent to January 1, 2015) is a maximum of ten years. Loans are secured by the participants' vested interests in their account balances. Loans shall bear interest at a reasonable fixed rate as determined by the Plan Administrator based on the prevailing interest rates for loans which would be made under similar circumstances. As of December 31, 2024, the interest rate on outstanding loans was 4.25%. Principal and interest are paid regularly through payroll deductions.

#### **Payment of Benefits**

Upon termination from service, death, total disability, or attaining age 59½, participants are entitled to receive a distribution of their account in lump sum, or may defer distribution if their vested account exceeds \$5,000. However, if such a participant's vested account balance is less than \$5,000, but greater than \$1,000, the Plan may roll the balance into an individual retirement account. At its discretion, the Plan may elect to distribute vested account balances of less than \$1,000.

#### Payment of Benefits (Continued)

Participants normally begin to receive distribution of benefits upon attaining normal retirement age (65), and may, in certain circumstances, defer distribution of benefits until April 1 of the year following the later of the year in which such participant attains age 70½ or the year in which the participant retires. If still employed with the Company upon reaching age 70½, a participant may elect to defer minimum required distributions until the calendar year following retirement.

Pursuant to the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE” Act), which became law on December 20, 2019, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reaches the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires.

The distribution provisions of the SECURE Act were modified by the SECURE 2.0 Act of 2022 (Note 7), such that beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reaches the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

In addition, in the event of hardship as defined by the Code, participants may request withdrawals from their respective deferral contributions account.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

#### Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants (Participant Loans)**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain of the Plan's administrative expenses, such as custodian/trustee, accounting, and legal expenses, are paid by the Company; recordkeeping and certain distribution and loan fees are paid by the Plan or requesting participants, as applicable.

#### **Income Tax Status**

The Company has adopted a pre-approved defined contribution plan, and relies upon the pre-approved plan's opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, in which the IRS stated that, in its opinion, the pre-approved plan's design was in accordance with the applicable requirements of the Code. The Company has not applied for a determination letter from the IRS specific to the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### **Subsequent Events**

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued (Note 8).

### NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the custodian of the Plan.

### NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### *Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### *Level 2*

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

### NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023:

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts consist primarily of interest-bearing cash (money market), publicly traded stocks, and mutual funds for which identical securities are observable in active markets.

*Common/collective trust:* Valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer may reserve the right to require a notification period in order to ensure that securities liquidations will be carried out in an orderly business manner.

- The Putnam Investments Stable Value Fund is a stable value collective trust which primarily consists of indirect investments in high-quality guaranteed investment contracts, security-backed investment contracts, high-quality money market instruments, cash, cash equivalents, and stable value funds through an investment company.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company pays substantially all of the administrative costs of the Plan with the exception of certain recordkeeping and advisor fees, and also provides administrative services for the Plan at no cost to the Plan. Certain investments are managed by the custodian of the Plan. These transactions qualify as exempt party-in-interest transactions.

### NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 7. SECURE 2.0 ACT

On December 29, 2022, the SECURE 2.0 Act of 2022 (the "SECURE Act 2.0") became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. In addition to the changes to minimum required distributions described in Note 1, the SECURE Act 2.0 includes various required and optional provisions that will become effective between 2023 and 2033, certain of which are described below:

- Beginning January 1, 2025, a participant from the ages of 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.

#### **NOTE 7. SECURE 2.0 ACT (Continued)**

- Beginning January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12 month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Beginning January 1, 2026, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.

Additionally, Plan management has not yet determined which of the optional provisions, if any, the Plan will implement. Plan management expects to formally amend the Plan by December 31, 2026.

#### **NOTE 8. SUBSEQUENT EVENT**

The Plan Sponsor filed for Chapter 11 bankruptcy on April 14, 2025. As of the date of the audit report, the Company intends to seek a buyer for its business assets and there are currently no intentions to terminate the Plan.
