INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of
VSC HBO, LLC d/b/a HealthBridge Children's Hospital 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedule of assets held for investment purposes and schedule of delinquent participant contributions at end of year as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024

NOTE 1 DESCRIPTION OF PLAN

The **Vivra Specialty Care, LLC 401(k) Plan** (the Plan) was adopted effective January 1, 2020. In September 2021, **Vivra Specialty Care, LLC**, the Plan sponsor, changed its name to **HealthBridge Specialty Care, LLC** and the Plan sponsor changed to **VSC HBO, LLC**. At that time the Plan changed its name to **VSC HBO, LLC d/b/a HealthBridge Children's Hospital 401(k) Plan**. The Plan was amended April 1, 2023. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-excluded employees of **VSC HBO, LLC** (collectively referred to as the "Company"). Employees are eligible to participate in the Plan upon reaching age 21 and completing three months of service. Participants will then enter the Plan on the first day of the month following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan.

Contributions

Eligible participants may contribute an elected percentage of pre-tax or post-tax annual compensation, as defined in the Plan, and subject to certain Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision. All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated default investment.

The Company may, at its discretion, elect annually to make matching and profit-sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, no matching or profit-sharing contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, including matching and profit sharing, if any, and (b) Plan earnings or losses. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contributions is based on years of credited service. A participant is fully vested after four years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, upon death, or becoming permanently disabled.

Notes to Financial Statements (Continued)

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Participants who terminate their employment with less than 100% vested in discretionary employer contributions forfeit their non-vested portion. Forfeitures are retained by the Plan to pay administrative expenses. At December 31, 2024 and 2023, the Plan did not have any unallocated forfeited non-vested balances. No forfeitures were used during the years ended December 31, 2024 and 2023.

Loans to Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participant loans are secured by the respective participant's vested account balance and are subject to interest charges. Loans receivable from participants as of December 31, 2024 bear interest rates ranging from 5.25% to 10.5% and mature at various times through October 2031. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the participant's vested interest in his or her account in the form of a lump sum distribution or as a direct rollover to an individual retirement account. The Plan allows for in-service distributions when the participant reaches age 59 ½. Hardship distributions are allowed subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize the benefit payment be rolled into an individual retirement account in the participant's name.

Participant Hardship Withdrawals

According to the Plan, each participant who has not attained age 59 ½ may make a hardship withdrawal if he or she demonstrates that the withdrawal is necessitated by the participant's immediate and heavy financial need and the participant lacks the available resources.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results may differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the common collective trusts and two mutual funds which are reported at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes to Financial Statements (Continued)

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Distributions Payable

Amounts payable to participants for distributions not yet distributed. There were no distributions payable at December 31, 2024. There were \$2,528 of distributions payable at December 31, 2023.

Excess Contributions Payable

Amounts payable to participants or employer for contributions in excess of amounts allowed by the IRS are recorded as a liability. The excess amount may be used to reduce either participant contributions or plan expenses. There were no excess contributions payable at December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant loans or benefits distributed to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through July 10, 2025, which is the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

During 2024, the Plan's investments appreciation in value by \$196,675.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 inputs) and the lowest priority to unobservable inputs (level 3 inputs).

The three levels of the fair value hierarchy under the standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual Funds – valued at the daily closing price reported in the active market in which the individual mutual funds are traded or the net asset value (NAV) at year end.
- Common Collective Trust Funds – valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. The NAV is determined by the custodian of the fund and is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The inputs or methodologies used for valuing investments may not be an indication of the risk associated with investing in those securities. Furthermore, the Plan believes its valuation methods are appropriate and consistent. The use of different methodologies or assumptions could result in a different fair value measurement at the reporting date.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all amounts credited to the participants' accounts will become fully vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7 TAX STATUS

The Plan sponsor adopted a prototype non-standardized profit-sharing plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service, which stated that the Plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Financial accounting standards for uncertain tax positions prohibit financial statement recognition of the impact of a tax position if the position is not "more likely than not" to be sustained on audit, based on the technical merits of the position. The Plan's Annual Return/Report of Employee Benefit Plan remains subject to examination by taxing authorities, generally for three years after they have been filed. There are currently no returns for any tax periods under examination.

NOTE 8 INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, Reliance Trust Company, the custodian of the Plan, certified the accuracy and completeness of the information provided to the Plan administrator as of and for the years ended December 31, 2024 and 2023 included in the accompanying statements and supplemental schedules.

Accordingly, the following information was certified by Reliance Trust Company and was not subjected to any auditing procedures except for comparing such information with the related information contained in the accompanying statements and supplemental schedules:

- A. Investments held by Reliance Trust Company at fair value as of December 31, 2024 and 2023, which are included in the accompanying statement of net assets available for benefits.
- B. Investment income and expenses included in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- C. Investments held by Reliance Trust Company as of December 31, 2024, which are included in the accompanying schedule of assets held for investment purposes.

Notes to Financial Statements (Continued)

NOTE 9 PARTIES-IN-INTEREST TRANSACTIONS

Various companies, along with Reliance Trust Company as the custodian, provide professional services to the Plan such as administrative, recordkeeping, investment advisory, and other professional services at reasonable and customary rates, are parties-in-interest transactions. The Company, who has fiduciary responsibilities to the Plan, directly pays certain administrative expenses of the Plan. There were no prohibited transactions with any parties-in-interest.

NOTE 10 DEFERRED BENEFIT DISTRIBUTIONS

As of December 31, 2024 and 2023, \$61,984 and \$57,167, respectively, were allocated to the accounts of persons who as of that date were retired or had otherwise separated from the Company. The amounts are payable to the former participants as provided under the terms of the Plan. The amounts have not been recorded as a liability as of December 31, 2024 and 2023 because benefits are only recorded when paid.

NOTE 11 PROHIBITED TRANSACTIONS

As reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ending December 31, 2023, certain participant contributions were not remitted to the trust in a timely manner. The Plan sponsor subsequently remitted all such contributions to the trust. The Company has calculated lost earnings on these untimely contributions and remitted the related excise tax to the IRS. This transaction was prohibited according to the provisions of the Department of Labor.
