## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Lidl US, LLC 401(k) Profit Sharing Plan and Trust

### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Lidl US, LLC 401(k) Profit Sharing Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### OPINION

**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Lidl US, LLC 401(k) Profit Sharing Plan and Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees of Lidl US, LLC and its affiliates and subsidiaries (collectively referred to as the Company), provided the employee is at least 18 years old and attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Effective January 1, 2024, all eligible participants are automatically enrolled to make a 3% deferral, unless the participant makes an affirmative election of a different amount. Each employee's initial automatic deferrals are increased 1% annually until reaching a maximum of 6%.

The Company makes a safe harbor qualified non-elective matching contribution equal to 100% of the first 5% of eligible compensation, as defined by the Plan, for all active participants.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any employer contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**VESTING**

Participants are immediately vested in their voluntary contributions. Effective January 1, 2024, employer safe harbor contributions fully vest after two years of service.

#### **INVESTMENT OPTIONS**

Upon enrollment in the Plan, participants may direct their contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

#### **NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their accounts, up to a maximum of the lesser of 50% of their vested balances or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

#### **PAYMENT OF BENEFITS**

Benefits are payable as soon as practicable following normal retirement, disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan document.

#### **FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$291,192 and \$263,105, respectively. These accounts will be used to reduce future Plan expenses and Company contributions in accordance with the Plan document. During the year ended December 31, 2024, Company contributions were reduced by approximately \$23,517 from forfeited non-vested accounts.

#### **PLAN TERMINATION**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

#### **SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 21, 2025, the date the financial statements were available to be issued.

**NOTE 2**    **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

**BASIS OF ACCOUNTING**

The accompanying financial statements are presented on the accrual basis of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**VALUATION OF INVESTMENTS**

Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

**RISK AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**NOTE 4**    **VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2    Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Collective Trusts: Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Plan obtained its latest determination letter from the Internal Revenue Service on October 6, 2020 regarding its prototype plan adopted from ADP, LLC, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 6 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management fees, administrative fees, and custodial fees to parties in interest. The Plan paid approximately \$368,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the change in fair value of investments.
