Note 1 - Description of the Plan

The following brief description of Statistics & Data Corporation 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Statistics & Data Corporation 401(k) Plan, established on June 1, 2008, is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees, except union employees, non-residence alien, leased employees, part-time, temporary, or seasonal employee who works less than 1,000 hours of service in a year, and project employees, are eligible to participate on the first day of the month after they have completed one month of service and have attained the age of 21. Statistics & Data Corporation (the "Company") is the plan administrator. Reliance Trust Company ("Reliance") is the trustee and custodian of plan assets and ADP Retirement Services ("ADP") serves as recordkeeper.

The Plan includes an employees' thrift savings plan established under the provisions of Internal Revenue Code Section 401(k). Under the savings plan, a certain percentage of employees' wages, as defined in the Plan, can be deferred as an employee contribution to the Plan.

Effective February 26, 2024, the Company entered into an agreement to transfer its ophthalmology business unit, including employees, to a related company owned by the shareholders. As part of the agreement, domestic employees were transferred to the related company effective February 23, 2024. As a result of this transfer, the affected employees are no longer eligible to participate in the Plan.

Enrollment - All eligible employees may participate in the Plan upon meeting the age and service requirements and can enroll on the first day of each month subsequent to becoming eligible. Participants may change their deferral percentage at anytime.

Contributions - Participants may contribute pretax annual compensation up to the maximum permitted by Code Section 402(g). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans. Participants may also make elective deferrals as Roth contributions. The Plan is a safe harbor 401(k) plan. Each year, the Company makes a safe harbor matching contribution equal to 100% of the eligible compensation up to 3% and 50% of the eligible compensation between 3% and 5%. To be eligible for the safe harbor matching contribution, the participants must have completed one year of service and have attained age 21.

A discretionary matching contribution may be made each year at the option of the Company's Board of Directors. There was no discretionary matching contribution made to the Plan for the year ended December 31, 2024. In addition, each year, the Company may make a discretionary profit-sharing contribution. Each employee's portion of the Company's discretionary profit-sharing contribution is based on the employee's compensation in relation to total participant compensation. To be eligible for the discretionary profit-sharing contributions, an employee must have 1,000 hours or more of service during the Plan year, attain age 21 and is an active employee on the last day of the Plan year. There was no discretionary profit-sharing contribution made to the Plan for the year ended December 31, 2024. Contributions are subject to certain limitations and eligibility requirements apply to such contributions.

Participant Accounts - Each participant account is credited with (a) the participant's contributions, (b) employer safe harbor matching contribution, (c) discretionary matching contributions, if any, (d) discretionary profit-sharing contributions, if any, (e) plan earnings, and (f) plan expenses, if any. Allocations of plan earnings and plan expenses are based on account balances, as defined. Allocations of the employer contributions are based on participant's compensation. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral contributions, rollover contributions, and safe harbor matching contribution plus actual earnings thereon. Vesting in the employer discretionary matching contribution and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after six years of credited service.

Investment Options - Upon enrollment in the Plan, and at any time during the plan year, a participant may direct their contributions in one percent increments to various investment options comprised of certain selected mutual funds. Participants may reallocate their funds or redirect new contributions on a daily basis among any of the offered funds.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates of 1% above the Prime rate. Principal and interest is paid ratably through payroll deductions. Generally, notes must be repaid within five years unless being used to purchase a principal residence. Participants may have three notes outstanding at a time.

Forfeitures - Forfeitures can be used to reduce plan expenses related to the administration of the Plan or to reduce future employer contributions. Forfeited non-vested accounts in the amount of \$1,970 were used to reduce employer safe harbor matching contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, unallocated forfeitures amounted to \$930 and \$884, respectively.

Payment of Benefits - Upon termination of service, retirement, disability or death, participants or beneficiaries are entitled to a distribution equal to the total value of the participant's vested account. A participant or beneficiary may elect to receive the value of the vested account in a lump-sum cash payment or a rollover distribution to an eligible retirement account, or a combination of both payout options.

For vested balances less than \$5,000, benefit payments are automatically made to the participant in the form of a rollover to an IRA account. If the vested balance is greater than \$5,000, the participant may defer payment until required by law to receive minimum required distributions.

Participants may withdraw from their vested accounts upon certain hardship situations defined in the Plan or upon attainment of age 59 1/2.

Plan Amendment and Termination - The Plan may be amended at any time by the Board of Directors, provided that no such amendment may deprive participants of their vested benefits. Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

Administrative Expenses - The Company pays the administrative expenses relating to the Plan except those relating to investment management fees, advisory fees and quarterly fund expenses including loan origination and maintenance fees, which are paid by the Plan's participants. Investment management fees charged to the Plan for all investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees are reflected as a reduction of net appreciation in the fair value of investments. During the plan year ended December 31, 2024, fees paid by the Plan's participants amounted to \$48,431.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with U.S. generally accepted accounting principles.

Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

Investment Valuation - All investments are reported at fair value in these financial statements. Fair value is measured in accordance with U.S. generally accepted accounting principles as more fully described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses include the plan's gains and losses on investments bought and sold as well as held by the Plan during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable are reclassified as distributions in accordance with the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits - Benefits are recorded when paid.

Tax Status - The Statistics & Data Corporation 401(k) Plan utilizes the ADP, LLC non-standard 401(k) prototype plan, which obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. The ADP, LLC prototype plan has been amended since that date. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Tax Status (Continued) - The Plan evaluates all significant tax positions as required by U.S. generally accepted accounting principles. As of December 31, 2024, the Plan has no uncertain tax positions that would require either recognition or disclosure in the financial statements. The Plan is generally subject to potential examination by taxing authorities for the prior three years. Currently there are no audits in progress for any tax periods.

Subsequent Events - The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is the date of the Independent Auditor's Report which is the date the financial statements were available to be issued.

Note 3 - Information Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, at fair value, and notes receivable from participants held at December 31, 2024 and 2023, and realized and unrealized gains and losses, net, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee and custodian of the Plan).

Note 4 - Fair Value Measurements

Fair value is defined under U.S. generally accepted accounting principles as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The Plan is required to maximize the use of observable inputs, minimize the use of unobservable inputs, and disclose in the form of an outlined hierarchy the details of such fair value measurements. The hierarchy of valuation techniques is based on whether the inputs to fair value measurement are considered to be observable or unobservable in a marketplace. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions.

The hierarchy requires the use of observable market data. When available, these inputs have created the following fair value hierarchy:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Observable inputs other than those included in Level 1. For example, quoted prices for similar assets in active markets or quoted prices for identical assets in inactive markets.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in estimating the value of the assets.

Following is a description of the Plan's valuation methodologies for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund and calculated at the close of business on the NYSE. The NAV is based on the value of the underlying asset owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds are classified within Level 1 of the valuation hierarchy.

The following table presents the financial instruments carried at fair value, by caption on the statements of net assets available for benefits and by the valuation hierarchy (as described above) as of December 31, 2024 and 2023, respectively:

Note 5 - Related Party Transactions

Reliance Trust Company is the custodian and trustee of the Plan and ADP is the recordkeeper of the Plan. Morgan Stanley Smith Barney is the investment advisor of the Plan. Accordingly, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, fees charged to participant accounts included \$19,411 of loan origination, maintenance fees and other administrative expenses that were paid to ADP and \$29,020 of investment advisory fees that were paid to Morgan Stanley Smith Barney. Notes receivable from participants also qualify as party-in-interest transactions. The Company, as plan sponsor, pays certain administrative expenses of the Plan.

Note 6 - Notes Receivable from Participants

As of December 31, 2024, notes receivable from participants bear interest at rates ranging from 5.75% to 9.50%, with maturities at various dates through November 2029.

As of December 31, 2023, notes receivable from participants bear interest at rates ranging from 5.75% to 9.50%, with maturities at various dates through September 2026.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
