INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hertz Investment Group Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Hertz Investment Group Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a Flexible 401(k) Profit Sharing Plan (defined contribution plan) that was adopted effective January 1, 2001, by Hertz Investment Group Inc. (the "Company" or the "Employer") for the benefit of eligible employees of the following companies:

The Board of Trustees oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

2. Eligibility

Other than nonresident aliens, those covered by a collective bargaining agreement and an employee as a result of an asset or stock acquisition, merger or similar transaction involving a change in the Employer of the employees of a trade or business in the current year, all employees having reached the age of 21 and completed one month of service are eligible for participation in the Plan. Eligible employees may participate immediately upon meeting age and service requirements.

3. Contributions

Participants may elect to contribute, on an after-tax and/or tax-deferred basis, up to 90% of compensation, up to the maximum annual deferral limit per Section 402(g) of the Internal Revenue Code ("IRC"). Additional "catch-up" contributions can be made beginning in the Plan year in which a participant will be at least age 50 by the end of the Plan year.

The Company makes matching contributions equal to 100% of participant contributions up to 3% of participant compensation. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. The Company makes employer match true-up contributions. This provision allows the Employer, for all eligible participants, to recalculate Employer matching contributions at year end and true-up contributions using a ratio of elective deferrals to compensation for the Plan year.

4. Investment Options

Participants can direct employee and Employer contributions, as desired, in any of a variety of investment options offered by Reliance Trust Company ("Reliance"), the trustee. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Forfeiture

Any portion of a participant's account, which is non-vested upon separation from service, is forfeited. Forfeitures reduce discretionary Company matching and profit-sharing contributions, if any. Any remaining forfeitures are allocated among the participants. During 2024, forfeitures of \$42,841 were applied against Company matching contributions. As of December 31, 2024 outstanding forfeitures were \$127,221 and as of December 31, 2023, outstanding forfeitures were \$79,312.

7. Vesting

Participant contributions, rollovers, Company qualified non-elective contributions and actual earnings on all such contributions are fully vested at all times. Vesting of the Company's matching contributions, non-elective contributions, and actual earnings on such contributions are based upon the participant's years of service with the Company as follows:

8. Benefit Payments

Upon termination of service or retirement, participants are entitled to receive a lump-sum amount equal to the value of his or her vested account balances. In the event of death or disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. The Plan provides for cash-out distributions of vested participant accounts not exceeding \$5,000. Additionally, participants may receive distributions upon attaining age 59 ½.

9. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All notes receivable are secured by the balance in the participant's account and bear an interest rate of 1% above the U.S. prime rate. The interest rate is determined monthly. Loans must be paid back within 60 months of the date of issuance. Loans for the purchase of a primary residence may be extended. Principal and interest are paid ratably through bi-weekly payroll deductions. Participants are limited to one outstanding loan at a time.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements have been prepared based on the accrual basis of accounting.

2. Plan Administration

The Company is the Plan sponsor and the Plan administrator. The Plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

The Plan invests, through mutual funds, in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

5. Payment of Benefits

Benefits are recorded when paid.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

7. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

9. Partial Plan Termination

During the year ended December 31, 2024, the Company experienced a reduction in workforce resulting in the termination of approximately 37% of plan participants. Management determined that a partial plan termination occurred under IRS Revenue Ruling 2007-43. In accordance with applicable IRS and ERISA requirements, all affected participants are required to be fully vested in their account balances as of the date of termination. Upon review, the Plan Administrator identified that certain affected participants were not fully vested at the time of distribution.

Management is actively working with the third-party administrator to evaluate vesting status at the individual participant level and to initiate corrective actions, including restoring forfeited amounts of \$113,945 where necessary.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The trustee is a party-in-interest with respect to the Plan. All investments are held with the trustee. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions.

NOTE F - TAX STATUS

The Employer adopted a prototype non-standardized profit-sharing plan for which the IRS has opined on the form of the Plan by a letter dated October 6, 2020 that the Plan is designed in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Administration errors, if any, that are insignificant or operational in nature, are handled by the Plan administrator in accordance with applicable IRS correction policies. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
