Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MPH Savings and Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the MPH Savings and Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

The following description of the MPH Savings and Retirement Plan (Plan) provides only general information. Participants should refer to the plan document, as amended, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established September 1, 1987, and most recently amended and restated effective July 1, 2020. Employees of Milk Products Holdings (North America) Inc. (Company) who have one year of service become eligible to participate in discretionary employer retirement contributions upon attaining the age of 18. Employees are credited with a year of service for eligibility purposes if they work 1,000 or more hours during the year. In addition, participants are eligible to participate in Company-matching contributions upon attaining age 18 with no service requirement.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

Each year participants may contribute any amount up to 75% of their pretax annual compensation, as defined in the Plan. Participants may also contribute an amount designated as after-tax ROTH contributions. Participants may also contribute amounts representing distributions and rollover contributions from other qualified defined benefit or defined contribution plans. Contributions for any plan year shall not exceed the maximum provided by the Internal Revenue Code. Contributions cannot exceed \$23,000 and \$22,500 in 2024 and 2023, respectively. Age 50 and over participants can contribute an additional \$7,500 in both 2024 and 2023, in accordance with the IRC. The Plan currently offers various registered investment companies and a common or collective trust fund for participants to direct their investments.

The Company makes a matching contribution each payroll period equal to 100% of the participants' first 3% of deferred compensation and 50% of the next 2% of deferred compensation. The Company may also make a discretionary retirement contribution in an amount not less than 3% of participants' eligible compensation. In 2024 and 2023, the Company did not make a discretionary contribution.

Investment Options

Participants direct the investment of their account balances into various investment options offered by the Plan. Participants may select any of the investment options in multiples of 1% and may make changes at any time via the recordkeeper's online participant portal.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary retirement contribution and plan earnings. Allocations of discretionary contributions are based on participant compensation. Plan earnings shall be allocated in the ratio that a participant's account balance invested in the fund bears to the total of all account balances in the fund. Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to termination of employment, death, disability or retirement, a participant will receive a lump-sum amount equal to the vested portion of the participant's account. Distributions are subject to the applicable provisions of the plan agreement.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant may have only one loan outstanding at a time. Note terms range from one to five years or over a reasonable period of time for purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.5% at December 31, 2024, which is commensurate with prevailing market rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions.

Vesting

Participants are immediately vested in their contributions and the Company's matching and discretionary contributions plus actual earnings thereon.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with registered investment companies valued at quoted market prices. The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees paid by the Plan for professional services rendered by parties-in-interest during 2024 and 2023, were \$39,517 and \$30,020, respectively. Other administrative expenses of the Plan are paid by the Company. Certain investment fees are netted in the net appreciation in fair value of investments.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the daily price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Transactions With Parties-in-Interest

Certain plan investments are shares of registered investment companies managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be fully vested in their accounts and the trustee will distribute plan assets to participants or their beneficiaries in accordance with the plan agreement.

Note 7. Income Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency and ADP, LLC has obtained an opinion letter from the Internal Revenue Service (IRS), stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through July 25, 2025, which is the date the financial statements were available to be issued.
