#### Significant Audit Matters

##### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by General Tool Company, Incorporated 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the fair value of investments as described in Note 8 to the financial statements. We evaluated the key factors and assumptions used to develop the fair value measurement of investments in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of risks and uncertainties in Note 6 to the financial statements where disclosure is made that investment securities are exposed to various risks that changes in the values of investment securities may occur that could materially affect participants' account balances.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no such misstatements.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated July 21, 2025.

*Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Other Matters*

With respect to the ERISA-required supplementary information accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of the Board of Trustees and management of General Tool Company, Incorporated 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

## INDEPENDENT AUDITORS' REPORT

To The Board of Trustees & Participants  
General Tool Company, Incorporated 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of General Tool Company, Incorporated 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the General Tool Company, Incorporated 401(k) Plan (the "Plan") is provided for general information purposes only. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants should refer to the Plan document for more complete information.

##### **General**

The Plan was established March 1, 1963 and was restated May 4, 2022. All employees except union and leased employees of General Tool Company, Inc. ("Company") who have reached age 18 and completed 3 months of service are eligible to participate in the Plan.

##### **Contributions**

Participants may contribute up to 75% of their annual compensation, not to exceed the maximum amount allowable under the Internal Revenue Code ("IRC"). Eligible employees who fail to make an affirmative election will be automatically enrolled into the Plan at a "default" contribution rate of 4%. In April 2024, the contribution rate was increased to 5%. The Plan allows eligible participants to make catch-up contributions in accordance with IRC. The Company may make a discretionary matching contributions based on a participant's salary reduction amount. The Company's discretionary matching contribution was 50% of the first 4% of a participant's eligible compensation. In July 2023, the Company's discretionary matching contribution was amended to 50% of the first 7% of a participant's eligible compensation. In addition, the Company may make a discretionary profit sharing contribution to the Plan. The Company made no discretionary profit sharing contribution to the Plan for 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary contributions and (b) Plan earnings (losses). The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

ADP Retirement Services has been assigned the administrative function of maintaining separate accounts of the participants as provided in the Plan agreement. They have no discretionary authority or responsibility to make sales, investments and reinvestments. Under the direction of the participants, ADP Retirement Services invests the individual participant accounts in any or all of the Plan's investment options. The investments are not covered by federal insurance.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of continuous service, starting at 20% after two years of service and 20% additional for each year of service thereafter.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published by the Wall Street Journal plus 1% as determined by the plan administrator at the time of the loan. Principal and interest is paid ratably through biweekly payroll deductions.

**Payment of Benefits**

Normal retirement age is 65 years. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or their choice of various annuity programs offered by the Plan. In the event of a participant's death, any remaining balance will automatically become 100% vested and paid to designated beneficiaries.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses and fees for administration of distributions and notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

**Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan represents a forfeiture. The Plan document permits the use of forfeitures to reduce future employer contributions for the plan year. The balance in the forfeiture account at December 31, 2024 was \$34,324 and at December 31, 2023 was \$8,018. The 2024 employer contributions was reduced by \$49,091 from forfeited nonvested accounts.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)**

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to a participants' contributions. Amounts payable to participants for contributions in excess of amounts allowed by the IRS were \$1,809 at December 31, 2024 and \$6,883 at December 31, 2023. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 4 - INCOME TAX STATUS**

The Plan obtained its latest determination letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021. There are currently no audits for any tax periods in progress.

**NOTE 8 - FAIR VALUE MEASUREMENT**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were used by the Plan.
