## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF THE PLAN

The following description of the Paralyzed Veterans of America - Incentive Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### General -

The Plan is a defined contribution plan established April 15, 1995. The Plan covers substantially all employees of Paralyzed Veterans of America (the Sponsor). Leased employees, interns, and temporary workers are excluded from the Plan. The Plan was most recently amended and restated effective December 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was subsequently amended effective January 1, 2024, to include a roth option.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan. The Plan Sponsor has until December 31, 2026 to adopt formal Plan amendments related to SECURE 2.0, the provisions that became effective in 2023 and beyond will still need to be administered by the Plan's management prior to adoption of the amendments.

#### Eligibility -

An employee is eligible to make elective deferrals into the Plan beginning on his or her date of hire. An employee is eligible to participate in the employer portion of the Plan on the first of the month following the date of hire once he or she has completed ninety (90) days service.

#### Contributions -

Each year, participants may contribute up to 80% of pre-tax annual compensation, as defined in the Plan, subject to IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Additionally, participants may contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan currently offers a variety of mutual funds, one money market fund and one guaranteed investment contract as investment options for participants. The Sponsor contributes a matching contribution of 100% up to 3% of compensation that a participant contributes to the Plan. The Sponsor also contributes a guaranteed contribution equal to 3% of a participant's compensation. Additional discretionary amounts may be contributed at the option of the Plan Sponsor.

No additional discretionary contributions were made in 2024 and 2023. Contributions are subject to certain annual IRS limitations.

#### Participant accounts -

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and an allocation of the investment earnings and losses. Allocations of investment earnings and losses are based on account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### 1. DESCRIPTION OF THE PLAN (Continued)

##### Vesting -

Employees are 100% vested in all contributions of the Plan.

##### Forfeited accounts -

Forfeited non-vested amounts will be used to reduce future employer contributions at the discretion of the employer. As of December 31, 2024 and 2023, the Plan had balances of \$1,279 and \$1,565, respectively, available in the forfeiture account to use in future periods. These amounts are included in investments on the accompanying Statements of Net Assets Available for Benefits. The Sponsor used \$195,091 of its forfeiture balance to reduce contributions during the year ended December 31, 2023. The Sponsor did not use the forfeiture balance to reduce contributions during the year ended December 31, 2024.

##### Notes receivable from participants -

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prevailing commercial interest rates, which were between 4.25% and 9.5% for outstanding loans at December 31, 2024 and 2023. Principal and interest are paid through payroll deductions.

##### Payment of benefits -

Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions described in the Plan document. Benefits are payable in a lump sum, installments, or annuity payments.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Method of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

##### Use of estimates -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### Fair value measurement -

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements. The Plan accounts for a significant portion of its financial instruments at fair value or considers fair value in their measurement.

Investment valuation and income recognition -

The investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

The fully benefit-responsive investment contract is presented at contract value. Contract value is the relevant measurement attribute for the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative expenses -

The Plan's expenses are paid either by the Plan or the Sponsor as provided by the Plan document. Expenses that are paid directly by the Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions net of revenue credits in the accompanying Statements of Changes in Net Assets Available for Benefits.

In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits.

Benefits -

Benefits are recorded when paid.

**3. GUARANTEED INVESTMENT CONTRACT**

The Plan maintains an investment in a fully benefit-responsive guaranteed investment contract with Principal which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statement of Net Assets Available for Benefits at contract value.

#### 3. GUARANTEED INVESTMENT CONTRACT (Continued)

Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact with the issuer. Such events include termination of the Plan, the failure of the trust to qualify for exemption from Federal income taxes under ERISA, or any prohibited transactions. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### 5. PARTY-IN-INTEREST

Certain Plan investments consist of shares of mutual funds managed by affiliates of Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee and record keeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

#### 6. TAX STATUS

The Plan is a prototype plan of Fidelity Management Trust Company, which received an opinion letter dated March 31, 2019, in which the Internal Revenue Service stated that the form of the Plan document was acceptable under the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 8. FAIR VALUE MEASUREMENT

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used, or transfers made, as of December 31, 2024 and 2023:

- *Investments in Money Market Funds* - The money market funds are open-ended funds that are registered with the Securities and Exchange Commission (SEC) and are deemed to be actively traded.
- *Investments in Registered Investment Companies* - Valued at the daily closing price as reported by the fund. These funds are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily value and to transact at that price. Registered investment company investments held by the Plan are deemed to be actively traded.
- *Fully Benefit-Responsive Investment Contract* - The fully benefit-responsive accounts are reported at contract value which is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses. In determining the reasonableness of the methodology, a number of factors are considered, such as economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, while others are substantiated utilizing available market data.
