1. Description of Plan

The following description of The Baker Company Profit Sharing and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all U.S. employees of The Baker Company, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and Participation

Employees are eligible to participate in the Plan after having completed service requirements and attaining age 18. Employees must complete 1 ½ months of continuous service upon hire or complete at least 1,000 hours during a subsequent 12 month period. A participant can enter the Plan on the first day of the payroll cycle coinciding with or next following the date on which eligibility is established. To be eligible for non-elective employer profit sharing or safe harbor contributions, employees must complete one year of service and will be eligible to receive a contribution as of the first day of the Plan year for which eligibility requirements are met.

Contributions

A participant may elect to contribute pre-tax or post-tax dollars to the Plan up to the Internal Revenue Service maximum amount.

The Company may make an annual profit sharing contribution at the discretion of the Company's Board of Directors. Profit sharing contributions are to be allocated to eligible participants based on a classification group formula. Each classification group will receive either a percentage of compensation or a dollar amount. The Company approved an annual profit sharing contribution of \$325,000 for the years ended December 31, 2024 and 2023.

The Plan also has the option to make safe harbor non-elective contributions. There were no safe harbor contributions in 2024 or 2023.

Participant Accounts

All contributions to the Plan are participant-directed among investment options offered by the Plan. Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution plus/minus Plan earnings and losses and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor contributions, if any, plus actual earnings thereon. Participants vest in the Company's profit sharing contributions as follows:

3 but less than 4	40%

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their balances.

Forfeitures

Forfeitures of terminated non-vested account balances may be used to either pay administrative expenses or employer matching contributions. Forfeitures were not material to the financial statements.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear a fixed interest rate of prime plus 1% (notes bear interest ranging from 4.25% to 9.50% at December 31, 2024). Principal and interest are paid ratably through payroll deductions.

Distributions

Generally, no amounts may be distributed to participants from their accounts prior to their termination of employment or their attainment of age 59½ unless the participant has incurred a hardship, as defined.

Administrative Expenses

Plan audit, fiduciary, and legal fees are paid by the Company. Certain administrative expenses, loan initiation, and service fees are paid by the Plan to Empower Annuity Insurance Company of America, the custodian and recordkeeper of the Plan, Commonwealth Equity Services, LLC, an investment advisor of the Plan, and Downeast Pension Services, Inc. a third-party administrator of the Plan. These payments are considered party-in-interest transactions, although not prohibited under ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

The Plan's investments in mutual funds are stated at fair value based upon quoted market prices which represent the net asset value of shares held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in a group fixed annuity contract with Empower Annuity Insurance Company of America through the Guaranteed Interest Fund. The investment in this contract is stated according to the provisions of Accounting Standards Codification (ASC) Topic 946, *Reporting of Fully Benefit-Responsive Investment Contracts Held by Certain Investment Companies Subject to the AICPA Investments Company Guide and Defined-Contribution Health and Welfare and Pension Plans*, which states that contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by the trustees, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain employer initiated events may reduce the reported value of the investments in the group fixed annuity contract. These events include discontinued operations, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan, or other events. Such events are not expected to be probable to occur.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The issuer, Empower Annuity Insurance Company of America, maintains the contributions to the Guaranteed Interest Fund in a general account. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed and may be reset on a quarterly basis.

Contributions

Participant elective deferrals are recorded in the period in which payroll deductions are made. Employer profit sharing, safe harbor non-elective, and other qualified non-elective contributions are accrued once they are approved by the Company.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated the existence of subsequent events through July 17, 2025, which represents the date the financial statements were available to be issued.

3. Fair Value Measurement

ASC Topic 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There has been no change in the methodology used during 2024.

5. Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the third-party administrator prototype plan. The Internal Revenue Service has determined and informed the third-party administrator by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Party-in-Interest Transactions

In addition to the party-in-interest transactions previously disclosed, a plan investment is managed by Empower Annuity Insurance Company of America and there are notes receivable from participants. These transactions are considered to be party-in-interest transactions, although not prohibited under ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Excess Contributions

Contributions determined to be in excess of maximum contribution levels for certain participants are refunded in the subsequent Plan year. These excess contributions are reported on the Plan's Form 5500 as corrective distributions, while they are reported as a reduction to participant's contributions for financial reporting purpose in the statement of changes in net assets available for benefits.
