Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EXFO USA 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A: DESCRIPTION OF THE PLAN

The following description of the EXFO USA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement, including amendments, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by EXFO America, Inc. Generally, all United States company employees of EXFO America, Inc., EXFO Burleigh Products Group Inc. and EXFO Service Assurance (collectively the “Companies”) are eligible to participate in the Plan on their date of hire. Plan entry dates are at any time coincident with or following satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are entitled to defer up to 100% of their total annual compensation in whole percentages into the Plan as a qualified pre-tax contribution, subject to certain limitations. The Companies remit a 3% "Safe Harbor" contribution to all eligible employees. During 2024, “Safe Harbor” contributions totaled \$528,389. All contributions for each participant are subject to the provisions of ERISA and the Internal Revenue Code (IRC).

Participant accounts

Each participant's account is credited with the participant's contribution, the safe harbor contribution, and an allocation of plan investment income. Investment income is allocated to participant accounts based on the amount of participant dollars in a fund relative to total fund dollars. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The fair value of each participant's account is determined daily. The change in the fair value of each participant's account includes the effect of contributions, investment income or loss, distributions, and withdrawals affecting the Plan’s assets since the preceding valuation date.

Investment options

Plan participants may direct the investment of their account among mutual fund and guaranteed investment contract options provided by the Plan.

Vesting

In the past, the Plan allowed for discretionary contributions and employees are vested in these previous discretionary contributions according to the following schedules:

Participants are immediately vested in their voluntary contributions and the Companies' "Safe Harbor" contributions plus actual earnings thereon.

Forfeitures

Any forfeitures of discretionary contributions arising under the Plan are used to reduce plan expenses and to reduce the employer's "Safe Harbor" contributions under the Plan. There were \$19 in forfeitures available to offset future contributions at both December 31, 2024 and 2023. During 2024, no forfeitures were utilized to offset administrative fees.

Payment of benefits

Upon retirement, death, resignation or termination of employment or permanent and total disability, the value of the participant's account may be paid in a lump sum, rolled over to another qualifying investment, or used to purchase an annuity, subject to limitations as specified in the Plan. If the participant's vested account balance exceeds \$1,000, the participant may defer the payment of the benefits until attaining the age of 73. A participant terminating employment because of permanent disablement is deemed to have retired as of their normal retirement date. In addition, hardship withdrawals are available under the Plan, subject to certain early withdrawal penalties. Other withdrawals may be subject to restrictions as defined in the Plan.

The Plan allows participants who have attained the age of 59 ½ and are still employed at the Companies to obtain distributions from their vested accounts.

Notes receivable from participants

Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance less any outstanding loan balances or \$50,000. Participant notes receivable are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. Loans generally have five-year terms; however, loans for purchasing a primary residence can have a maximum term equal to 360 months. Principal and interest payments on the loans are redeposited into the participants' accounts based on their current investment allocation elections.

Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Valuation of guaranteed investment contract

The Plan has a fully benefit responsive group annuity contract with an insurance company, which is called the Key Guaranteed Portfolio Fund. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly and the minimum crediting rate under the contract is 0%. The average yield based on actual earnings and credited to participants for 2024 was 1.41%.

Certain events may limit the ability of the plan sponsor and/or plan participants to transact at contract value with Empower Annuity Insurance Company of America. Examples of these events would include (but would not be limited to) full or partial plan termination and premature termination of the guaranteed investment contract. The Plan administrator does not believe that the occurrence of any of the aforementioned events, which would limit the Plan's ability to transact with Empower Annuity Insurance Company of America at contract value with participants, are probable.

Notes receivable from participants

Notes receivable from participants are stated at their unpaid principal balance, plus accrued but unpaid interest. Loans outstanding are reflected as a receivable of the Plan. Delinquent notes receivable remain as notes receivable until a qualifying event happens, as defined in the Plan document.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Companies, as provided by the plan document. Expenses that are paid directly by the Companies are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through July 24, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to amend the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants have a fully vested interest in their accounts and their accounts will be paid to them as provided by the plan document.

NOTE E: TAX STATUS

The Internal Revenue Service determined and stated by a letter dated November 14, 2022, that the non-standardized, pre-approved plan under which the Plan was adopted, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or reduce an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: TRANSACTIONS WITH PARTY-IN-INTEREST

Notes receivable from participants qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. As described in Note B, the Plan paid certain expenses related to the plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H: FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE H: FAIR VALUE MEASUREMENTS, Cont'd

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively traded, open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value and to transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
