Opinion

Note 1. Plan Description

The following brief description of Trust Point Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering the employees of Trust Point Inc. (the Plan Sponsor, Plan Administrator and Employer) who meet the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor has established a Plan Committee, which is responsible for oversight of the Plan.

The Plan Sponsor is also the trustee of the Plan. The trustee is responsible for maintaining custody of the Plan's assets, processing contributions, notes receivable and distributions, and executing transactions to appropriate investment options.

Eligibility: All employees of Trust Point Inc. who are age 21 or older, with the exception of union employees, nonresident aliens, leased employees, interns, and temporary employees, are eligible to participate in the Plan and for salary deferrals and Plan Sponsor safe harbor matching contributions, upon completion of 30 days of service. Temporary employees are eligible to participate in the Plan upon the completion of 1,000 hours of service during any year of employment. The Plan entry date for salary deferrals and Plan Sponsor safe harbor matching contributions is the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. Eligible employees must complete 1,000 hours of service during the plan year and be actively employed on the last day of the plan year (except in a year of death, permanent disability or retirement) to receive a discretionary profit sharing contribution. The Plan entry date for discretionary profit sharing contributions is the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date the employee satisfies the eligibility requirements.

Employee (participant) deferral and rollover contributions: Participants may contribute to the Plan a certain percentage of their eligible compensation, up to the maximum allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and Roth deferrals. Participants may also contribute amounts representing distributions from other qualified plans or from individual retirement accounts (rollovers).

Employer safe harbor matching contributions: Employees are eligible for Plan Sponsor safe harbor matching contributions based on the same eligibility criteria as for participant deferral contributions. During 2024, the Plan Sponsor made safe harbor matching contributions equal to 100% of participant deferrals up to 4% of a participant's eligible compensation. Plan Sponsor safe harbor matching contributions totaled approximately \$369,000 for the year ended December 31, 2024.

Employer profit sharing contributions: The Plan also allows for discretionary profit sharing contributions. The contribution is allocated to each eligible participant based on the participant's annual eligible compensation, as defined by the Plan, as a percentage of the total annual eligible compensation of all participants eligible to share in profit sharing contributions for the plan year. The Plan Sponsor made discretionary profit sharing contributions totaling approximately \$868,000 for the year ended December 31, 2024.

Note 1. Plan Description (Continued)

Participant accounts and investment options: Individual accounts are maintained for each participant of the Plan. Each participant's account is credited or charged with the participant's contributions, the Plan Sponsor's safe harbor matching contributions, and an allocation of the Plan Sponsor's profit sharing contributions, if any, Plan investment results, and expenses that are paid by the Plan. Allocations are based upon participant contributions, eligible participant compensation or account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may elect to have all or part of their account balances and future contributions transferred from one investment option to another in any combination.

Vesting: Participants are immediately vested in their voluntary contributions and the Plan Sponsor's safe harbor matching contributions and actual investment earnings or losses thereon. Participants become vested in the Plan Sponsor's discretionary profit sharing contribution portion of their accounts based on years of service according to the following vesting schedule.

A participant is also 100% vested if employed on or after normal retirement age, as defined by the Plan, or if the participant dies or becomes permanently disabled.

Payments of benefits: On termination of service, a participant may elect to receive a distribution of the value of their vested account in the form of: (1) a lump-sum payment or (2) a partial withdrawal of at least \$500. Participant balances that are less than \$1,000 at the time of termination may be paid out in a single lump-sum payment of cash without the need for the participant's consent. Balances between \$1,000 and \$7,000 may be rolled over into an individual retirement account, designated by the Plan Administrator, for the benefit of the participant without the need for the participant's consent. If the vested account balance is more than \$7,000, the participant must consent to any distribution before it is made. Voluntary withdrawals of a participant's account balance while still employed with the Plan Sponsor are allowed upon attainment of age 59½ by the participant or, with respect to rollovers, at any time and for any reason.

Notes receivable from participants: A participant may borrow from his/her vested account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms cannot be greater than five years; however, if the proceeds from the note are used by the participant to purchase a principal residence, the term may be 15 years. The note must be adequately secured. Notes bear interest at the prime rate plus 1%, and the interest rate is fixed for the duration of the note. There are two notes outstanding as of December 31, 2024. The rate of interest on existing notes at December 31, 2024, ranged from 7.00% to 9.00% on notes maturing through August 2035. Principal and interest payments are made ratably through payroll deductions.

Forfeited accounts: Amounts not vested upon termination of employment are forfeited by participants and may be used to pay Plan expenses or fund a portion of the Plan Sponsor's contributions to the Plan. Forfeited accounts totaling approximately \$40,000 were used in 2024 to fund a portion of the Plan Sponsor's discretionary profit sharing contribution for 2024. There were no forfeited nonvested accounts at December 31, 2024 or 2023.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates in the preparation of financial statements: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee or other third parties. See Note 3 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses is recorded at December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan.

Notes receivable from participants are classified as an investment for Form 5500 reporting purposes and, accordingly, are included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Contributions: Participant contributions and the related Employer safe harbor matching contributions are recognized in the period in which the participant contributions are withheld from compensation. Employer profit sharing contributions are recognized based on the period in which eligible compensation is paid to participants.

Benefit payments: Benefits are recorded when paid.

Administrative expenses: The Plan's administrative expenses are paid by the Plan or Plan Sponsor, as provided by the Plan agreement and determined by the Plan Administrator. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses reduce total investment results.

Subsequent events: The Plan Administrator has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Shares of registered investment companies are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Collective trust fund: The collective trust fund held by the Plan as of December 31, 2023, was a stable value fund that invested primarily in fully benefit-responsive guaranteed investment contracts. The fund was valued at the net asset value (NAV) of the units of the collective trust fund held by the Plan. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the contract value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it was determined to be probable that the Plan would sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) occurred daily. The Plan is not invested in collective trust funds as of December 31, 2024.

Note 3. Fair Value Measurements (Continued)

Common stock: The common stock held by the Plan as of December 31, 2023, consisted of one share of common stock of TPI Holdings, Inc., the parent company of Trust Point Inc. The value of the common stock was based on the prices of the same shares in an inactive market. The transfer of the common stock was restricted. TPI Holdings, Inc. was given the first option to purchase the share, and the price for the share was equal to TPI Holdings, Inc.'s most recently audited book value on a per share basis. The Plan is not invested in common stock as of December 31, 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to change or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 5. Tax Status

The Plan adopted a nonstandardized defined contribution pre-approved plan sponsored by Trust Point Inc. Trust Point Inc. has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Risk and Uncertainties

Participants are allowed to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 7. Related-Party and Party-in-Interest Transactions

The Plan Sponsor pays the majority of the administrative expenses related to the Plan. Trust Point Inc. is the Plan Sponsor, Plan Administrator and trustee of the Plan. The Plan held one share of common stock of TPI Holdings, Inc. as of December 31, 2023.
