To the Trustees
TM Holdings, Inc. 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TM Holdings, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note J to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note A - Description of Plan

The following description of TM Holdings, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a voluntary, contributory, defined contribution plan covering employees who have attained 21 years of age. A year of service is defined by the Plan as a twelve-month period during which the employee completes not less than 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established with an effective date of November 1, 1997, with the most recent restatement on January 1, 2021. The Plan restatement was drafted using a nonstandardized pre-approved agreement that, if adhered to, is deemed tax exempt by the Internal Revenue Service in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan includes all employees of a related group of companies including TM Holdings, Inc.; Title Midwest, Inc.; Kansas Secured Title, Inc.; Nebraska Title Company; Rochester Title and Escrow Company, Inc.; Missouri Secured Title, Inc.; Walnut Valley Title, LLC (through March 31, 2022); Secured Title of Kansas City LLC; Secured Title of Texas, LLC; Dominion Title & Exchange Services, LLC; Secured Vendor Management Services, LLC; Professional Title Management, LLC; and Oklahoma Secured Title, LLC.

2. Contributions

Contributions to the Plan by TM Holdings, Inc. (the Company), are discretionary and are determined annually by the Board of Directors. The Company matches 33 percent of employee contributions up to 6 percent of eligible compensation to the Plan. The Plan also allows for a supplemental discretionary match, which is allocated in the same manner as the matching contribution. Participants may make voluntary contributions to the Plan so long as the total participants' contributions do not exceed the Internal Revenue Code Section 402(g) limitation. Adjusted for costs of living, this limitation was \$23,000 for the 2024 plan year, plus an additional \$7,500 of catch-up contributions for employees age 50 and older was also permitted.

3. Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and plan net income or loss, as defined. Allocations are based on participant earnings or account balances, as defined, and are credited as of the last day of each plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

4. Vesting

Participant contributions, together with the net earnings attributable to such contributions, are fully vested with the participants at all times. Qualified matching contributions, together with net earnings attributable to such contributions, vest with the participant based on years of service with the Company. Participants are 100 percent vested in employer contributions after completing five years of service. All contributions, together with net earnings attributable to such contributions, are fully vested if the participant enters normal retirement, becomes disabled, or dies. Plan forfeitures are used to reduce the Company's contribution.

5. Participant loans

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to, together with interest calculated over the entire term of the loan, the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms generally may not exceed five years. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1.5 percent above the prime rate as published in the *Wall Street Journal* on the day the loan is initiated. The interest rate is fixed for the duration of the loan. Principal and interest is paid ratably through payroll deductions.

6. Investment options

Each participant may direct account balances to be invested in one or any combination of investment options offered by the Plan and may change the allocation daily. The Plan does not have any nonparticipant directed investments.

7. Payment of benefits

On termination of service, participants may elect to receive their nonforfeitable accrued benefit by payment in a lump sum amount. In addition, participants may elect in-service distributions, including financial hardship distributions, as defined by the Plan.

8. Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,712 and \$108,812, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$134,456 and \$4,385, respectively, were used to reduce employer contributions.

Note B - Summary of Accounting Policies

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note D for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

4. Net appreciation (depreciation) in fair value of investments

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments.

5. Participant loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

6. Payment of benefits

Benefits are recorded when paid.

7. Expenses

Certain expenses of maintaining the Plan are paid by the Company and, therefore, are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of participant loans are included in administrative expenses and charged directly to the participant's account.

8. Date of management's review and subsequent events

Subsequent events were evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

Note C - Party-in-Interest Transactions

All plan investments are managed by John Hancock Trust Company LLC, the plan trustee. The Plan paid \$83,171 and \$49,989 of recordkeeping fees to John Hancock Retirement Plan Services during 2024 and 2023, respectively. In addition, the Plan paid \$60,932 and \$56,963 of investment advisory fees to Commonwealth Financial Network during 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified contractual term, Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective funds

Valued at fair value based on the net asset value (NAV) of units held in the collective fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will see the investment for an amount different than the reported NAV.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note E - Income Tax Status

On June 30, 2020, the Internal Revenue Service stated that the nonstandardized pre-approved agreement adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable taxing authorities. Management is not aware of any uncertain tax positions taken by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note F - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

Note H - Reportable Transactions Under ERISA

The Plan had no loans or fixed income obligations at December 31, 2024. The Plan had no leases at December 31, 2024. All plan assets are in an investment contract with an insurance company.
