### 1. Description of plan

Southeastern Computer Consultants, Inc. 401(k) Plan (the Plan) is a defined contribution plan covering substantially all employees of the plan sponsor, Southeastern Computer Consultants, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees age 21 or older are eligible for the Plan on the first day of the pay period following the date of the hire.

The following description of the Plan provides only general information. The Plan agreement and summary plan description should be referred to for a more complete description of the Plan's provisions.

#### **Contributions and funding**

Each year, participants may elect to defer a percentage of their annual compensation, as defined in the Plan, to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company may provide a matching contribution as determined at the discretion of the Company's board of directors. For the years ended December 31, 2024 and 2023, the employer match was 50% of the first 6% contributed by the participant with a maximum match of \$1,500. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. No discretionary contributions were accrued for the years ended December 31, 2024 and 2023.

#### **Participant accounts**

Each participant's account is credited with the (a) participant's contribution, (b) allocations of the Company's contribution and (c) investment earnings, net of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's employer matching and profit sharing contributions are based on a cliff vesting schedule whereby a participant is 100 percent vested after three years of credited service.

#### **Payment of benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive his/her vested account balance in a lump-sum, receive the balance in monthly or annuity payments, or roll the account balance to an individual retirement account or to another employer's tax qualified plan. Vested account balances less than \$5,000 will be distributed in a single lump-sum payment. Pre-retirement withdrawals are allowed for participants who have attained age 59½, or who have a qualifying hardship subject to the plan agreement.

#### **Administrative expenses**

Most costs and expenses of administering the Plan are paid by the Company except for fees paid to the investment managers from their respective funds, certain fees paid directly by the participants, and quarterly management fees which may be paid with forfeitures.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,328 and \$81,355, respectively. During 2024, \$113,710 of forfeitures were used to reduce employer contributions. This amount is available to pay plan expenses and reduce Company contributions.

#### **Participant loans**

Participants may borrow from their fund accounts with a minimum loan of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at commercially reasonable rates of interest. Principal and interest are paid ratably through automatic payroll deductions, or through ACH or check. A participant may only have one loan outstanding at any time.

## **2. Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates and assumptions.

#### **Income recognition**

Purchases and sales of securities are recognized principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### **Employee contributions receivable**

Contribution receivables are determined based on the payroll pay date, not the process date into the Plan.

#### **Payment of benefits**

Benefits are recorded when paid.

## **3. Information certified by the custodian**

The plan administrator has elected the alternative method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Accordingly, as permitted under such election, the investment information certified by Voya Retirement Insurance and Annuity Company (Voya) was not audited by the independent auditors except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

The Plan's financial information that was certified by Voya includes plan investments as of December 31, 2024 and 2023 of \$32,519,991 and \$31,347,065 respectively, notes receivable from participants for \$239,768 and \$153,517, respectively, interest income on notes receivable from participants for 2024 of \$13,678 and investment appreciation and dividends for 2024 of \$4,068,624.

#### 4. Investment contract with insurance company

The Plan holds a benefit-responsive investment contract with Voya totaling \$2,543,040 for December 31, 2024 and \$2,623,541 for December 31, 2023. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 2.2% for the fund.

The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: Fund administration amendments or changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and /or issuer. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include management of the portfolio is not in accordance with investment guidelines, a breach of any material obligation under the wrap agreement, any representation or warranty made by the contract holder becomes untrue in any material way, a replacement of the Investment Advisor without prior consent of the issuer, the Fund is terminated or ceases to qualify as a group trust or plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA.

#### 5. Investments at fair value

The Plan classifies its investments into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

Registered investment companies (mutual funds): Mutual funds for which a quoted market price is available on an active market are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Related party transactions

The Plan's assets are invested in funds managed by Voya. Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan investments have internal expenses that compensate Voya.

#### 7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in all employer contribution accounts.

#### 8. Tax status

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

In accordance with authoritative guidance issued by the Financial Accounting Standards Board (FASB), the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examinations for years ended December 31, 2021 through December 31, 2024.

#### **9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

#### **10. Subsequent events**

The plan administrator assessed events occurring subsequent to December 31, 2024 through July 16, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements.


