## Independent Auditor's Report

To the Plan Administrator of the Trefz Corporation & Its Affiliates Profit Sharing 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Trefz Corporation & Its Affiliates Profit Sharing 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). A. PLAN DESCRIPTION:

The following description of the Trefz Corporation & Its Affiliates Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for more detailed information.

General

The Plan is a defined contribution plan covering all employees of Trefz Corporation and its Affiliates (the "Company") who have attained the age of 21 and who have earned one year of service (1,000 hours) as defined by the Plan. Employees can participate in the Plan as of the earlier of January or July 1 following the date that eligibility requirements are met. Trefz Corporation and its Affiliates are a group of companies under common control. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Upon meeting eligibility requirements participants may contribute up to 100% of their plan compensation on a pre-tax basis, subject to Internal Revenue Code ("IRC") limitations. Participants who are at least 50 may make an additional "catch up" contribution subject to IRC limitations. Participants may also contribute funds from another qualified plan ("rollover contributions"), subject to certain requirements.

The Company may elect to make matching contributions. The Company matched 50% of employee contributions, up to 3% of a participant's compensation, for a maximum match of 1.5% of a participant's compensation for the 2024 plan year.

In addition, each participating employer shall make such profit sharing contributions as it shall determine for a plan year. Such contributions shall be allocated only to employees of the employer making the contributions. Such contributions shall be allocated to those employees in the same proportion as each such employee's annual compensation bears to the annual compensation of all participating employees of the employer making the contribution. Employees must work 1,000 hours during the plan year and be employed on the last day of the plan year to be eligible for profit sharing contributions.

Commencing with the plan year beginning in 1989, no elective deferral, matching contribution or other employer contribution shall be made for the benefit of a key employee or a highly compensated employee.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participant's accounts based on each participant's account balance within each fund for participant directed investments. Each participant's account is credited with the participant's proportional allocation of the Plan's earnings, including unrealized gains and losses, and expenses for nonparticipant directed investments. For participant directed investments participants determine the percentage in which contributions are to be invested in each fund.

For participant directed investments participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in that portion of their account which represents their contributions, Company matching contribution and the income earned thereon. Participants become 100% vested in the Company profit sharing contributions and earnings thereon upon death, total and permanent disability. Otherwise, a participant's interest in the Company's contributions and earnings thereon vests according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan or excess employer contributions occur, the nonvested portion of a participant's account and excess employer contributions represents a forfeiture, as defined by the Plan. Forfeitures are first used to pay plan expenses, with any remaining forfeitures used to reduce employer contributions. During 2024, no forfeitures were used to reduce employer contributions or used to pay plan expenses. Unallocated forfeitures at December 31, 2024 and 2023 were \$3,514 and \$3,178, respectively.

Unallocated Assets

The Plan holds assets in an administrative fee credit account which receives deposits as a result of a revenue sharing agreement with Ascensus, LLC. During 2024, deposits to the account totaled \$51,747, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account are used to pay qualified plan expenses including recordkeeping fees, and third-party fees. During 2024, \$43,208 was used to pay plan expenses. Unallocated assets were \$37,620 and \$29,080 at December 31, 2024 and 2023, respectively.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment, by reason of retirement, disability, death, or other separation from service. Distributions under the Plan may be made in lump sums or annuities.

A participant may also request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document.

Notes Receivable from Participants

Loans are not permitted under the Plan.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan pays all investment management fees and other expenses of administering the Plan. Expenses that are paid by the Company, if any, are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange traded funds and common stocks* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Common collective trusts* – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

*Life insurance policies* – Valued at fair value by management by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. In determining the reasonableness of the methodology, management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, minimum crediting rate, duration or payout date) while others are substantiated utilizing available market data (for example, discount rate).

**D. TAX STATUS:**

The Company has adopted a pre-approved non-standardized profit sharing plan document of Ascensus, LLC. The Internal Revenue Service ("IRS") has determined and informed Ascensus, LLC by a letter dated June 30, 2020 that the pre-approved non-standardized profit sharing plan document and related trust adopted by the plan sponsor are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Accordingly, transactions with investment funds are both managed and held by the trustee and custodians considered party in interest transactions.

G. PLAN TERMINATION:

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

H. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
