## **Independent Auditor's Report**

Plan Administrator and Participants  
Parrish-Hare Electrical Supply 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Parrish-Hare Electrical Supply 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 14, 2024 (liquidation basis) and December 31, 2023 (ongoing basis), and the related statements of changes in net assets available for benefits for the period January 1, 2024 through October 14, 2024 (liquidation basis) and the year ended December 31, 2023 (ongoing basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the periods ended October 14, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ## **Emphasis of Matter – Plan Termination and Basis of Accounting**

As discussed in Note 7 to the financial statements, the governing body of the Parrish-Hare Electrical Supply 401(k) Plan elected to terminate the Plan, effective March 11, 2024, and a plan of liquidation was approved. As a result, the Plan has changed its basis of accounting from the ongoing (accrual) basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Parrish-Hare Electrical Supply 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Effective March 11, 2024, the Plan’s governing board elected to terminate the Plan. The assets were fully distributed from the Plan as of October 14, 2024. The Plan Terminated on March 11, 2024. Accordingly, the descriptions below are provisions of the Plan prior to termination. See Notes 2 and 7 for additional information.

General

The Plan is a defined contribution plan established by Parrish-Hare Electrical Supply, L.L.C. and affiliated employers (the “Company”) under the provision of Section 401(a) of the United States Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company.

The Plan covers substantially all employees of the Company. Each covered employee must have completed two months of service with the Company and reached the age of 18 to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Administration

The Plan is administered by the Company (the “Plan Administrator”). The duties of the Plan Administrator are to oversee the operations and administration of the Plan in accordance with the specific terms of the Plan, provide for prudent investment of Plan assets, and maintain accurate records and reports. Accordingly, the Plan Administrator has been granted discretionary authority concerning investment and management activities. The Plan’s custodian, Fidelity Management Trust Company (“Fidelity”) is responsible for the custody and management of the Plan’s assets.

Contributions

The Plan is funded through participant elective deferrals and Company contributions. Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to the dollar limitation under §402(g) of the IRC. The Plan permits both pre-tax and certain after-tax (Roth) deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a matching contribution equal to a discretionary percentage of a participant’s elective deferral contributions. Each year, the Company determines the amount of the discretionary matching percentage. During 2024 and 2023, the Company matched 50% of each eligible participant’s elective deferral contribution up to 10% of their annual compensation. Additionally, each year, the Company may make a discretionary profit-sharing contribution to the Plan. Participants must make elective deferral or catch-up contributions and complete two months of eligibility service to share in employer matching contributions. Participants must complete 1,000 hours of service during the plan year and be employed on the last day of the year to share in employer discretionary non-elective (profit sharing) contributions. Contributions are subject to certain limitations.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related employer matching and other contributions, as well as the participant’s share of investment income, appreciation (depreciation), and any related administrative expenses and distributions. The participant determines both the amount to be invested and the allocation of the investment to one or more of the investment alternatives. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may modify investment elections, transfer existing account balances, and obtain information regarding the investments on a daily basis.

1. DESCRIPTION OF PLAN (Continued)

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan to any one or more of the investment alternatives maintained by the Custodian, determined at the discretion of the participant and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

Vesting

Participants are vested immediately in their elective and rollover contributions and the earnings received thereon. Vesting in the Company's contribution portion of their accounts and the earnings thereon is based upon years of vesting service, as defined in the Plan. A participant is 100 percent vested after six years of credited service. Full and immediate vesting will also occur upon normal retirement age (age 65), death, total disability, or termination of the Plan. Participants who leave the Company before they are fully vested in the Company's contributions forfeit their non-vested portion. Participants who are employed on the date they reach early retirement age (age 59 ½) and have completed 5 years of vesting service are also fully vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, whichever is less. A participant may only have one loan outstanding at any time. All loans are secured by the balance of the participant's account and bear interest at a fixed rate commensurate with local prevailing rates as determined by the Company. Currently, the loan interest rate is determined using the Prime interest rate published in the Wall Street Journal on the date the loan is issued plus 1.00%. Interest rates range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions at a frequency determined when the loan is made, but no less frequently than quarterly.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may leave their account in the Plan (if the account balance is greater than \$5,000), may elect to receive a single lump-sum payment in cash, a direct transfer to another qualified retirement plan, or may receive partial withdrawals. In addition, in-service and hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. These funds may be used to restore forfeitures, reduce the Company's contributions (or reallocate as Company contributions), or pay Plan expenses. At October 14, 2024 and December 31, 2023, forfeited accounts totaled \$- and \$37,976, respectively. For the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023, forfeitures of \$32,382 and \$21,392 were used to reduce Company contributions, respectively. For the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023, forfeitures of \$9,566 and \$8,025 were used to pay Plan expenses, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Method of Accounting

Due to the decision to terminate the Plan, the financial statements for the period January 1, 2024 through October 14, 2024 are prepared on the liquidation basis of accounting, in accordance with accounting principles generally accepted in the United States of America. No adjustments to the financial statements were required to present the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of the assets, and any other costs expected to be incurred during the liquidation process. The Plan's 2023 financial statements are prepared on the ongoing (accrual) basis of accounting in accordance with United States generally accepted accounting principles.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan. The remaining administrative expenses are paid by the Company. The Plan has no obligation to reimburse the Company for the expenses paid by the Company. Plan expenses paid by the Company are not included in these financial statements. Fees related to the administration of notes receivable from participants or fees paid related to benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Management fees and operating expenses charged to the Plan for investments in the various mutual funds and common/collective trust are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of such investments.

Use of Estimates

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document or loan policy of the Plan. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at October 14, 2024 and December 31, 2023.

Investment Valuation and Income Recognition

Investments are stated at fair value. Changes in market value are reflected in operations. Mutual funds and common/collective trusts represent investments with various investment managers. Mutual funds are valued at the net asset value of units held by the Plan at year-end. The net asset value is based on the market value of the underlying investments, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value at year-end. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of investments are recorded on the trade-date basis. The net appreciation (depreciation) of investments includes realized gains and losses on sales during the period and current changes in unrealized appreciation (depreciation) in the market value of investments held at year-end.

The Plan's interest in the Morley Stable Value Fund (the "Stable Value Fund") is based on the value of the Stable Value Fund's underlying investments using information reported by the Stable Value Fund's trustee, with the Stable Value Fund's trustee specifying the source(s) to use for underlying investment asset prices. The fair values of units held in common/collective trusts are based on their net asset values, as reported by the Stable Value Fund's trustee and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date.

Investment Valuation and Income Recognition (Continued)

The Stable Value Fund is a common/collective trust. The Stable Value Fund invests in fully benefit responsive guaranteed investment contracts. The crediting interest rates are fixed for the life of the underlying investments or change quarterly. The blended crediting rate for the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023 was approximately 2.85% and 2.76%, respectively. The average yield for the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023 was approximately 4.03% and 3.23%, respectively. The objective of the Stable Value Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plans or participant payments. The Stable Value Fund seeks to achieve this objective by investing primarily in a variety of high-quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents. It is intended that the Stable Value Fund's stable value investment contracts will maintain a minimum weighted average credit quality rating of A or better. The underlying fixed income securities must be rated investment grade and meet issuer diversification guidelines. The duration of the Stable Value Fund's investments will not exceed four years. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Stable Value Fund's net asset value. The Stable Value Fund is not registered under the Investment Company Act of 1940, and the units of the Stable Value Fund are not registered with the Securities and Exchange Commission under the Securities Act of 1933. There is no public market for the units.

The Stable Value Fund imposes certain restrictions on the Plan, and the Stable Value Fund itself may be subject to circumstances that affect its ability to transact at contract value. Redemptions are generally permitted daily. Individual participant redemptions for benefit payments and redemptions by participants to reinvest in options that do not compete with the common collective trust are generally permitted without restriction upon request but in all cases within thirty days after written notification has been received. Were the Plan to initiate a full redemption of the common/collective trust, a twelve-month advance written notice is required, although the Stable Value Fund may waive this requirement at its discretion. Plan management believes that the occurrence of events that would cause the Stable Value Fund to transact at less than contract value is not probable.

Risks and Uncertainties

The Plan provides for various investment securities with different investment strategies, which in general, are exposed to various risks, such as interest rate, credit, foreign investment, active management, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

3. REPORTABLE TRANSACTIONS

During the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023, there were no reportable transactions, loans or leases in default or uncollectible, investment assets both acquired and disposed of, or non-exempt transactions with parties-in-interest which would require supplemental presentation under United States Department of Labor ("DOL") regulations.

4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and other accounts managed by Fidelity. Fidelity is the custodian and record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Purchases and sales of these accounts and the underlying investments comprising these accounts were open market transactions at fair market value. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

5. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified to the completeness and accuracy of the information reflected on the accompanying statements of net assets available for benefits and the related investment activity reflected in the statements of changes in net assets available for benefits.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures* provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the period January 1, 2024 through October 14, 2024 and the year ended December 31, 2023, there were no significant transfers in or out of levels 1, 2, or 3.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 14, 2024 and December 31, 2023.

*Mutual Funds:* Valued at the net asset value of shares held by the Plan at year-end.

*Common/Collective Trust:* Valued at the net asset value (“NAV”) of units held by the Plan based on information using the audited financial statements of the common/collective trust at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the trust less its liabilities, divided by the total number of units. The practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV. The common/collective trust has (1) no unfunded commitments, and (2) a daily redemption frequency with no advance notice requirements. Plan management believes that the termination of the Plan (see Note 7) might limit the ability of the Plan to transact at NAV with the common/collective trusts or that also limit the ability of the Plan to transact at NAV with the participants. The NAV is not a publicly quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and the IRC. On March 11, 2024, the Plan's trustee issued notice of the Plan's termination to all participants. Upon Plan termination all participants became 100% vested in their accounts to the extent not otherwise vested, and the assets of the Plan were distributed to the participants in accordance with the provisions of the Plan agreement, ERISA, and the IRC, subject to payment of liquidation costs and expenses.

8. TAX STATUS

The Company has adopted the Fidelity Defined Contribution Volume Submitter Plan. The Internal Revenue Service has issued an opinion letter dated June 30, 2020 stating that the volume submitter plan is acceptable under Section 401(a) of the IRC for use by employers for the benefit of their employees. The Company is relying on the opinion letter (in accordance with Announcement 2017-41) that the Plan meets the qualification requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 14, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. CHANGES IN PLAN OPERATIONS

Effective January 1, 2020, certain administrative defaults for the Plan were updated to be in accordance with final regulations of the Setting Every Community Up for Retirement Enhancement ("SECURE") Act of 2019. These changes included altering the age at which required minimum distributions must begin for participants. If a participant reached the age of 70 ½ prior to 2020, then the prior rule of age 70 ½ applies. If a participant reaches the age of 70 ½ during 2020 or later, that participant must now take his or her first required minimum distribution after reaching the age of 72.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.
