## INDEPENDENT AUDITOR'S REPORT

### ***Opinion***

We have audited the financial statements of IBEW Local 317 Vacation Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of IBEW Local 317 Vacation Fund, as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### 1 – DESCRIPTION OF PLAN

The following description of the IBEW Local 317 Vacation Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was established pursuant to a collective bargaining agreement between the West Virginia - Ohio Valley Chapter of the National Electrical Contractors Association, Huntington Division (NECA), and Local Union No. 317 of the International Brotherhood of Electrical Workers (Union). The Plan covers employees employed under the terms of the collective bargaining agreement between the NECA and the Union, between the Union and other employers, and between the Plan and employers. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions and Benefits - Funding is provided by participating employers based on the negotiated contribution rates set forth in the collective bargaining agreement, or other written agreements. Vacation benefits are paid biannually, in a lump sum, on the first business day of April and October. The April payment represents contributions and accrued interest less administration expenses for the previous July 1 through December 31. The October payment represents contributions and accrued interest less administrative expenses for January 1 through June 30.

Investment Income – Interest is adjusted monthly based upon the depository bank's overnight Federal Funds Rate available the first business day of the month and credited among all individual accounts on a pro-rata basis. Expenses of the Plan are divided equally among all individual accounts and deducted on a biannual basis.

Plan Termination - The Plan's Board of Trustees has the right under the Plan to modify the benefits provided to participants. The Plan may be terminated if the Trust Fund is unable to carry out the intent and purpose of the Trust Agreement or to meet the payments due or to become due under the Plan or if there are no individuals living who qualify as Employees or as participants and/or beneficiaries or by action of the Union and NECA. Following termination, any surplus is to be designated for no purpose other than any of the purposes declared exempt under Section 501(c)(3) of the Internal Revenue Code.

### 2 – SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review - Subsequent events were evaluated through the date of this report, which is the date the financial statements were available to be issued.

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments - Money market funds are valued at cost plus accrued interest which approximates fair value.

Contributions - Participants' contributions receivable represent amounts due as of December 31, under the terms of the collective bargaining agreement.

Allowance for Doubtful Accounts – The Plan's administrator has evaluated employer contributions receivable and has determined that an allowance for doubtful accounts was not necessary as all amounts are deemed to be fully collectible.

#### **4 – TAX STATUS**

The Plan obtained its latest determination letter on July 30, 1975, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code, Section 501(c)(9). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being administered in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### **5 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. American Benefit Corporation, Inc. is the third-party administrator and bookkeeper. The Plan purchases Fiduciary and Fidelity insurance from Liberty Mutual., and Mountain State Insurance Agency. Ledbetter Partners, LLC serves as the legal counsel to the Plan. Gray, Griffith & Mays, A.C. provides financial statement audit services for the Plan, while Harris, Hardin and Company, A.C. provides payroll audit services for the Plan.

#### **6 – CONCENTRATIONS OF CREDIT RISK**

All of the revenues and receivables shown on the financial statements are from electrical services. The Plan's ability to collect contributions and enter into contracts could be affected by fluctuations in the electrical services industry and the overall economy.

#### **7 – RISKS AND UNCERTAINTIES**

The Plan has cash on deposit in the United National Bank in excess of the maximum amount insured by the Federal Deposit Insurance Corporation.

#### **8 – SUBSEQUENT EVENTS**

The Plan's management has evaluated events and transactions occurring after December 31, 2024, through the date of the Auditor's report, which is the date the financial statements were available to be issued.
