INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the
Transportation Communications
Union Staff 401(k) Plan

Opinion

We have audited the accompanying financial statements of the Transportation Communications Union Staff 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Transportation Communications Union Staff 401(k) Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with the modified cash basis of accounting.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.


Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplementary schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Departments of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of Transportation Communications Union Staff 401(k) Plan (the Plan) provides certain general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The National Union of the Transportation Communications International Union/IAM (TCU/IAM), instituted a defined-contribution plan under the provision of Section 401(k) of the Internal Revenue Code (IRC), to provide benefits to employees of the National Union (formerly Grand Lodge).

Employee Contributions - Plan participants may contribute up to 75% of their total pretax compensation, paid in any one year, limited to a legal maximum contribution per year. Contributions to the Plan are invested as directed by the participant in various mutual funds.

Employer Contributions - TCU/IAM makes a monthly discretionary contribution for the Training Services Department's employees who are no longer accumulating service credits under any other benefit plan if they were employed on the last day of each month. In addition, a discretionary matching contribution was added to the Plan for which Training Services Department employees will receive a 1% match from certain employers. The discretionary employer contributions can be modified or discontinued at any time. A decision is made, prior to the end of the Training Services Department contract year, as to what changes in the discretionary amount, if any, should be made in place of the normal monthly employer contribution.

Participant's Accounts - Each participant's account is credited with the participant's contributions and allocations of the Plan's investment earnings. Allocations of investment earnings are based upon each participant's account balance, as defined in the Plan. Each participant is entitled to the benefit that can be provided from the participant's account at the time of termination, retirement, withdrawal under hardship provisions (as defined by the Plan), total disability, or death. Participants must evaluate their own investment goals and objectives and choose the mutual funds best suited to achieve those goals and objectives. Poor investment performance by the mutual funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Vesting - Participants are fully vested from their date of enrollment in the Plan. Rights to receive benefits under the Plan are nonforfeitable.

Benefits - A participant who retires or otherwise terminates employment is entitled to receive the vested balance in his account in the form of a lump sum (or direct rollover) at any time during the period beginning within a reasonable time after the participant requests payment and ending on the participant's Section 401(a)(9) required beginning date.

A portion of the vested balance of a participant's account may be withdrawn under hardship provisions as defined by the Plan. Participants may also elect in service distributions when they reach age 59½.

Total disability and death benefits are determined in accordance with the provisions of the Plan, which generally stipulate that upon total disability or death, the participant or designated beneficiary is entitled to the vested balance in the participant's account.

Notes Receivable from Participants - Participants may borrow up to the lesser of: (1) 50% of their vested interest in the Plan; or (2) \$50,000, subject to certain limitations. The Plan provides that participants must repay borrowings over a period not to exceed 60 months. The loans are secured by the balance in the participant's account. The loan interest rate is set at SOFR + 1%. Principal and interest are paid ratably through payroll deductions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan prepares its financial statements using the modified cash basis of accounting, which includes unrealized appreciation (depreciation) in the fair value of the investments and assets and liabilities arising from cash transactions. Under the modified cash basis of accounting, revenue is generally recognized when collected rather than when earned, and expenses are generally recognized when paid rather than when incurred. Consequently, the financial statements do not include receivables for revenue earned, amounts due to vendors and suppliers, prepaid expenses and liabilities for accrued expenses other than those described above.

Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of the revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable are valued at their unpaid principal balance. Interest income on loans receivable is recognized when received.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation - The Plan's investments are carried at fair value which generally represents reported quoted market value as of the last business day of the year. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recognized on a trade-date basis. Interest and dividends are recognized on the modified cash basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Level 1

Mutual funds are traded in active markets on national and international securities exchanges and are valued at closing prices on the last business day of each period.

NOTE 4. TAX STATUS

The Plan obtained its latest determination letter on December 11, 2001, in which the Internal Revenue Service (IRS) stated that the Plan as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The Plan has subsequently been amended. The Plan's administrator and the Plan's tax counsel, however, believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management of an entity to evaluate tax positions taken and recognize a tax liability if the entity has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is no longer subject to tax examinations for years before the Plan's year ended December 31, 2021.



NOTE 5. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, TCU/IAM has the right, under the Plan, to terminate the Plan subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). In the event of termination, participants remain 100% vested in their account balances.

NOTE 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

TCU/IAM and the Training Services Department contract pay their respective portion of the administrative costs of the Plan. The administrative costs paid by TCU/IAM, on behalf of the Plan, for the years ended December 31, 2024 and 2023 were \$44,931 and \$43,054, respectively.

Certain Plan investments are managed by Fidelity Investments, the custodian of the Plan assets; and therefore, these transactions qualify as party-in-interest transactions.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE 8. SUBSEQUENT EVENTS REVIEW

Subsequent events have been evaluated through July 17, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an additional adjustment to or disclosure in the accompanying financial statements.


