## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of **C.B. Management Co, Inc. Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

## NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### 1. Description of plan

The following description of the **C.B. Management Co, Inc. Profit Sharing Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of **C.B. Management Co, Inc., Harry Cooper Supply Company, and Joplin Supply Company** (collectively the Company) who have at least one year of service with the Company and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was originally established on November 5, 1980. The Plan was amended and restated as of September 1, 2023, making Bank of America, N.A. the corporate trustee for the Plan and putting into effect the Merrill Lynch, Pierce, Fenner & Smith, Inc. Non-Standardized Defined Contribution Plan document into place.

Effective January 1, 2024, the Plan was amended by changing the eligibility requirements to age 18 and completing two months of service with the Company. The break in service rules was amended to state that a period of twelve consecutive months of a participant not being employed will constitute a break in service, except for certain leaves such as maternity or paternity leave.

#### Contributions

Each year, participants may contribute a percentage of their annual eligible wages by way of pre-tax contributions or as after-tax Roth contributions, up to 75% of eligible compensation or the amount currently allowable by the Internal Revenue Code. Participants who have attained age 50 and/or are between the ages of 60-63 before the end of the Plan year are eligible to make catch-up contributions based upon the IRS regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Employee contributions are subject to certain limitations as limited by IRS regulations. The Company matches 100% of a participant's contributions up to a maximum of 5% of compensation.

Upon reaching eligibility, participants are automatically enrolled into the Plan with a default deferral rate of 5% of eligible compensation unless the participant makes an election to the contrary. Following auto-enrollment, each year on January 2, without an election to the contrary or unless auto-enrollment occurred less than 6 months prior, the deferral rate increases 1% each year, to a maximum of 10%.

The Plan has a discretionary profit-sharing contribution feature which allows for contributions, at the sole discretion of the Boards of Directors of the Company, to be allocated among Plan participants. No contributions were made in 2024 or 2023.

Participants direct the investment of their entire account balance into various investment options offered by the Plan.

### NOTES TO THE FINANCIAL STATEMENTS (CONTINUED)

#### Participant accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is 100% after completion of three years of service.

#### Payments of benefits

On termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. In addition, if a participant's account balance is less than \$5,000 then the account will be automatically cashed out and paid to the participant. In-service distributions are allowed for participants who have reached the age of 62 or if a participant experiences a qualifying disability or hardship, subject to the provision of the Plan agreement.

Effective January 1, 2024, the Plan elected to allow for disaster relief withdrawals. Disaster relief withdrawals are allowed for participants whose principal place of residence was affected by a qualified disaster and an economic loss by reason was sustained. For each qualified disaster, a participant can take up to \$22,000 in total from all retirement plans.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,956 and \$1,923, respectively. Forfeitures may be used to pay Plan expenses, reduce employer contributions, or may be allocated among active participants based upon compensation. During 2024 and 2023, employer contributions were reduced by \$0 and \$10,000, respectively, from forfeited nonvested accounts.

## **2. Summary of significant accounting policies**

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Some investment related expenses are included in net appreciation (depreciation) of fair value of investments

Subsequent events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

**3. Fair value measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash* – Valued at the amount held in interest-bearing cash and money market fund accounts.

*Registered investment companies* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts* - Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Summary of certified information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Bank of America, N.A. for the years ended December 31, 2024, and from Fidelity Management Trust Company and Bank of America, N.A. for the year ended December 31, 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's trustee.

#### 5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

#### 6. Tax status

The Plan was designed under a volume submitter non-standardized defined contribution pre-approved plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code. Although Plan has been amended and restated since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### 7. Related party transactions and party-in-interest transactions

The Plan is administered by a committee appointed by the board of directors of the Company. The administrators do not receive any compensation for services rendered to the Plan. Expenses of the Plan may be paid by the Company at the discretion of the board of directors.

The Plan holds investments in funds managed by Bank of America, N.A. Since Bank of America, N.A. was the custodian and recordkeeper for the Plan, these transactions qualify as party-in-interest transactions. The Plan pays administrative expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

#### 8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 9. Subsequent events

Effective February 1, 2025, **Interstate Electrical Supply, Inc.** was brought into the Plan as an eligible participating employer and part of the Company. Years of service with Interstate Electrical Supply, Inc., were counted for a participant's eligibility determination, along with periods of service being counted for vesting purposes.
