Note 1 - Plan Description

The following description of Corrigan Moving and Storage Co. Tax Deferred Savings Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1989. The Plan covers employees who have completed one year of service, are age 18 or older, and are not leased or part-time employees for the following companies under common ownership: Corrigan Moving and Storage Company, Inc.; Corrigan Intellectual Property, LLC; Corrigan Moving Systems - Ann Arbor, Inc.; Corrigan Worldwide, Inc.; Corrigan Moving Systems - Grand Rapids, Inc.; Air and Sea Pak Co.; Corrigan Record Storage, LLC; Corrigan Systems - New York, LLC; Corrigan Moving Systems - Illinois, LLC; Signature Relocation, Inc. (formerly known as Corrigan Relocation, Inc.); Transportation Consulting, Inc.; Corrigan - Pennsylvania, LLC; and Premier Relocations, LLC (collectively, the "Companies" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies under Internal Revenue Service Code Sections 401(a) and 401(k). Effective July 1, 2022, the Plan was amended to eliminate the one-year service requirement, and eligible employees can participate in the Plan when they have attained 18 years of age or older.

Contributions

Participants may make contributions up to 60 percent of their annual wages through payroll withholdings as either pretax or after-tax deferrals subject to applicable Internal Revenue Service (IRS) limits. Participants are eligible for allocation of participating employer discretionary matching contributions if they are employed by the Companies on the last day of the plan year or if they have terminated employment during the year by reason of early or normal retirement, disability, or death. The employer discretionary matching contribution for 2024 was 50 percent of the participant's elective deferral, not to exceed \$2,000.

Effective July 15, 2022, the Plan was amended to include automatic enrollment for employee contributions of new plan participants. Participants are auto-enrolled into the Plan at 5 percent. Additionally, the Plan was amended to include automatic escalation for employee annual contributions. A participant's contribution percentage increases automatically by 1 percent each year, up to 10 percent.

Participant Accounts

Each participant's account is credited with the participant's contributions and the employer discretionary matching contribution, if applicable, along with an allocation of plan earnings and charged with an allocation of administrative expenses. Allocation of plan earnings and administrative expenses to participants' accounts is based on each participant's proportionate share of funds in each of the investment accounts.

Vesting

Participants are immediately vested in their contributions and related earnings. Vesting in the portion of their accounts related to the Companies' contributions plus related earnings is based on years of service. Participants are 20 percent vested after two years of credited service and 20 percent each successive year thereafter through year six, at which time they are fully vested.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive all or a portion of his or her vested account balance. Normal retirement age is 65, and early retirement age is 55 with 10 years of service. A participant who continues in employment as an employee and who has attained the age of 59½ is permitted to withdraw, upon request, all or any portion of his or her vested account balance.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. Fidelity Management Trust Company (the "Trustee") must approve any such hardship withdrawals.

Forfeitures

A participant forfeits the unvested portion of his or her account upon five consecutive one-year breaks in service. Forfeitures are retained in the Plan and are used to reduce future employer discretionary matching contributions or to pay administrative expenses.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under the Employee Retirement Income Security Act of 1974 guidelines.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a rate of 1.00 percent above prime determined at the time of issuance.

Termination of the Plan

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan. In the event of termination of the Plan, all participant account balances would become fully vested.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative fees of the Plan were paid directly by the Companies for 2024. These fees were not significant to the Plan's total assets.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Effective February 3, 2025, an entity under common ownership, Trans Advantage USA, Inc. (formerly known as TA Acquisition of Michigan), was added as a participating employer in the Plan.

The financial statements and related disclosures include evaluation of events up through and including July 21, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan, as adopted, is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020 indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at quoted prices reported in active markets.

A participant who continues in employment as an employee and who has attained the age of 59½ is permitted to withdraw, upon request, all or any portion of his or her vested account balance.

Note 1 - Plan Description (Continued)

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. Fidelity Management Trust Company (the "Trustee") must approve any such hardship withdrawals.

Forfeitures

A participant forfeits the unvested portion of his or her account upon five consecutive one-year breaks in service. Forfeitures are retained in the Plan and are used to reduce future employer discretionary matching contributions or to pay administrative expenses.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under the Employee Retirement Income Security Act of 1974 guidelines.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a rate of 1.00 percent above prime determined at the time of issuance.

Termination of the Plan

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan. In the event of termination of the Plan, all participant account balances would become fully vested.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative fees of the Plan were paid directly by the Companies for 2024. These fees were not significant to the Plan's total assets.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Effective February 3, 2025, an entity under common ownership, Trans Advantage USA, Inc. (formerly known as TA Acquisition of Michigan), was added as a participating employer in the Plan.

The financial statements and related disclosures include evaluation of events up through and including July 21, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan, as adopted, is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020 indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at quoted prices reported in active markets.
