## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gaming Capital Group LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**Basis for Opinion**

#### Note 1. Plan Description

The following description of Gaming Capital Group LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Members of the Plan Sponsor have delegated the responsibility for oversight of this Plan to the Plan Administrator, who determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**General:** The Plan is a defined contribution plan covering all qualified employees of Gaming Capital Group, LLC (the Company). Employees must complete one month of service and attain 21 years of age to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 96% of their eligible compensation, as defined in the Plan, designated in any combination as pretax or after tax (Roth) contributions. Participants who have attained 50 years of age before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation for the first year, increasing 1% for the next three years, until the maximum of 6% is reached or until changed by the participant. Automatically enrolled participant contributions are invested in a designated balanced fund until changed by the participant. The Company makes matching contributions in an amount equal to 100% of the first 1% of eligible compensation contributed by the employee, and 50% of the next 5% of eligible compensation contributed by the employee, for a maximum matching contribution of 3.5%. The Company may, at its discretion, make an additional profit sharing contribution to the Plan. There were no discretionary profit sharing contributions made during the 2024 plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution, Company matching contributions, allocations of the Company's profit sharing contribution, if any, and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and investment losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their own contributions and Company profit sharing contributions, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. Participants vest at 20% per year until they are 100% vested after five years of credited service; upon attainment of retirement age, total disability or death during the term of employment; or termination of the Plan.

**Forfeited accounts:** Forfeited nonvested accounts are used to partially fund the Company's contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$2,700 and \$500, respectively. No forfeitures were used to fund employer contributions in 2024 and 2023.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance excluding any Roth 401(k) balances. Note terms range from one to five years unless such note is used for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a market rate. Principal and interest are paid ratably, no less than quarterly, through payroll deductions. The rate of interest on existing loans at December 31, 2024, ranged from 4.25% to 9.50% on loans maturing through February 2031.

**Payment of benefits:** On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to all or part of the vested balance in his or her account or installment payments over a specified period of time in accordance with Plan provisions, unless the participant's vested balance is less than \$5,000, in which case only a lump-sum distribution is allowed. A participant may elect to receive an in-service distribution if they become permanently disabled.

#### Note 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Mutual funds:** Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

**Interest-bearing cash:** The interest-bearing cash account is valued at cost plus accrued income, which approximates fair value measured by similar assets in active markets.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan and not to each individual participant.

Although it has not expressed any intent to do so, the Company has the right under the Plan to change or to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

#### Note 6. Tax Status

The Plan has adopted a non-standardized preapproved profit sharing plan sponsored by Ascensus, LLC. The plan provider has received a favorable opinion letter from the IRS dated June 30, 2020, as to its qualified status. The preapproved plan opinion letter has been relied upon by this Plan. Although the Plan has been restated since the version receiving the determination letter, the Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### **Note 6. Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related-Party and Party-in-Interest Transactions**

Ascensus, LLC is the record keeper and Ascensus Trust Company and Newport Trust Company, LLC, are the trustees of the Plan. Transactions with the record keeper and trustees qualify as party-in-interest transactions.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the 2024 and 2023 statements of net assets available for benefits.
