Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Zyscovich AIA Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2023 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Plan Merger

As further discussed on Note 1, the Plan was merged into the Stratus Team, LLC 401(k) Plan (“Stratus Team Plan”). The Plan assets were transferred to the Stratus Team Plan on February 27, 2023, at which time the Plan was terminated.

Other Matter – 2022 Financial Statements

The financial statements of Zyscovich AIA Profit Sharing Plan as of December 31, 2022, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by the qualified institutions. Their report dated October 11, 2023 indicated that in their opinion (a) the amounts and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2022 financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2022 supplemental schedules, other than the information in the 2022 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2022 supplemental schedules related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

PERIOD FROM JANUARY 1, 2023 TO FEBRUARY 27, 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of Zyscovich AIA Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan was a defined contribution plan and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was adopted on January 1, 1998, for the benefit of the employees of Zyscovich, Inc. (the “Company” and “Sponsor”) under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covered all full-time and part-time employees of the Company who were eligible to participate on the first day of the first month following the employees’ month of hire. Employees were eligible for the profit sharing upon completion of one year of service while having worked at least 1,000 hours.

Plan Termination: Effective January 1, 2023, the Plan was merged into the Stratus Team 401(k) Plan (“Stratus Team”) and all employees of the Company were eligible to participate in the Stratus Team Plan. As a result of the merger, the Plan transferred all assets totaling \$9,930,749 to the Stratus Team Plan on February 27, 2023, at which time the Plan was terminated.

Administration of Plan Assets: The Plan was administered by the Company. The Plan’s assets were maintained and administered by Reliance Trust Company during the period from January 1, 2022 through October 28, 2022, and by Empower Trust Company and Empower Annuity Insurance Company of America for the period from October 29, 2022 through February 27, 2023 (collectively, “qualified institutions”). The Plan’s recordkeeping services, and maintenance of participant account records were managed by the qualified institutions. The Plan administrator was responsible for the oversight of the Plan, determined the appropriateness of the Plan’s investment offering and monitored investment performance.

Contributions: Participants were able to elect to contribute up to 100% of pretax annual compensation, as defined in the Plan, without exceeding limitations prescribed by the Internal Revenue Code (“IRC”). Plan entry dates were the first day of each calendar month. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who were making contributions to the Plan, were allowed to make catch-up contributions as defined in the Plan. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options through the qualified institutions of the Plan, for participant-directed investments.

The Company was able to make matching or profit-sharing contributions at its discretion. During the period from January 1, 2023 to February 27, 2023, the Company did not make any discretionary matching contribution to the Plan. Additionally, the Company could elect to make a non-elective safe harbor contributions. There was no non-elective safe harbor election made during the period from January 1, 2023 to February 27, 2023.

Participant Investment Account Options: Upon enrollment in the Plan, a participant could direct contributions into any of various investment options held by the qualified institutions. Participants may change their investment options at their discretion.

Participant Accounts: Each participant’s account was credited with the participant’s contributions and an allocation of (a) the Company’s contributions, b) Plan earnings, and c) forfeitures of Company contributions, and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

PERIOD FROM JANUARY 1, 2023 TO FEBRUARY 27, 2023

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting: Participants were immediately vested in their contributions plus actual earnings thereon. A participant's interest in discretionary contributions vested after six years of continuous service. However, if a participant's service was terminated due to retirement, disability, or death, the non-elective matching contributions were deemed to be fully vested.

Notes Receivables from Participants: Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. Loan terms were limited to five years; however, any loan used for the purchase of a primary residence was extended up to 10 years from the date of the loan. The loans were secured by the balance in the participant's account and bore interest at prime rate plus one percentage point. Principal and interest were paid ratably through payroll deductions.

Payments of Benefits: Participants were allowed in service withdrawals of their participant's vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. On termination of service due to death, disability or retirement, a participant (or participant's beneficiary) was entitled to receive 100% of their accrued benefit either in a single or a partial lump-sum distribution. Upon termination of service for any other reason or in the event of a financial hardship, a participant was able to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Administrative and Investment Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees were paid by the Plan and were reflected in the financial statements as administrative expenses of the Plan. Investment management fees were charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan were paid by the Company.

Forfeitures: Forfeitures are used to reduce employer contributions and Plan expenses. During the period from January 1, 2023 to February 27, 2023, forfeitures were used to pay Plan expenses totaling approximately \$9,000. The balance prior to the termination date, February 27, 2023, totaling approximately \$44,000 was returned to Plan Sponsor.

NOTE 2 –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value of investments. Actual results could differ from those estimates.

NOTE 2 –SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants: Benefits are recorded when processed and paid by the Plan.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. However, contract value was the relevant measurement attribute for that portion of the net assets available attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements: U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such investments pursuant to the valuation hierarchy. There have been no changes in methodologies used at February 27, 2023:

Mutual Funds: The fair values of investments in mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Fund: Short term investment fund is valued at cost, which approximates fair value and is classified within the Level 2 in the valuation hierarchy.

Common Collective Trust Fund – Investment in the common collective trust is stated at estimated daily net asset value (“NAV”), which has been determined based on the unit values of the funds. The investment is valued at a daily-calculated unit value, which is determined by the organization sponsoring such fund by dividing the funds’ net assets at fair value by its units outstanding at each valuation date. As the investment is indirect, NAV is used as a practical expedient to estimate fair value and the trusts are shown outside the fair value hierarchy.

The methods described above produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 to February 27, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the qualified institution.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had a fully benefit-responsive investment contract with the qualified institutions. The Plan's investment in the fund held in the insurance company general account consists of units of the Guaranteed Interest Account. This investment aimed to provide a guaranteed stream of income for life or some other fixed period of time based on accumulated savings allocated to the purchase of an annuity under this investment option. This investment had no unfunded commitments or redemption frequency restrictions.

Contract value represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were able to ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was based on a formula agreed upon with the issuer. Such interest rates were reviewed on a monthly basis for resetting. The average yield on the investment contract for December 31, 2022 was 0.50%.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-off of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The guaranteed investment contract did not permit Mass Mutual to terminate the agreement prior to the scheduled maturity date.

NOTE 7 – TRANSACTIONS WITH PARTIES-IN-INTEREST

Plan investments and the related transactions as of and for the period from January 1, 2023 to February 27, 2023 were managed by the qualified institution; therefore, these investments and transactions qualified as party-in-interest transactions. Notes receivable from participants were also considered to be party-in-interest transactions because they were transacted with Plan participants.

NOTE 8 – INCOME TAX STATUS

The Plan adopted a prototype standardized profit sharing plan which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which stated that the prototype Plan was designed in accordance with applicable sections of the IRC. The Plan had not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and had no income subject to business income tax and, therefore, the Plan continued to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of February 27, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
