Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the Global Connections to Employment, Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan was established on January 1, 2020 and provides health and other benefits to full-time and part-time regular employees of Global Connections to Employment, Inc. (the Organization) and their covered dependents. The assets of the Plan are held in a trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees become eligible to participate the first day of the month following the completion of 30 days of employment.

Benefits: The Plan provides health benefits (medical, vision, and dental), life insurance, short-term disability benefits, accidental death and dismemberment benefits, critical illness, hospital indemnity, and accident benefits, and an employee assistance program. The Plan also provides for a variety of flexible spending accounts and bundled programs that provide for a mix of the above benefits for certain participants. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured benefits: The Plan offers medical, dental and vision programs that participants can choose. The Plan fully insures all benefits. Premiums are paid from the assets of the trust.

The insurance contract of a certain medical provider is subject to experience-rating contract adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company) are determined in the year following the end of each 2 year policy period. As of December 31, 2024, the amount of the refund due or additional premiums required will not be known until 2026 and therefore, cannot be reasonably estimated at the report date. At December 31, 2023, it was determined \$2,857,588 was due back the Plan and is reported as an experience-rating refund due from insurer in the accompanying Statement of Benefit Obligations and Net Assets Available for Benefits as of December 31, 2023.

Contributions: Participants contribute specified amounts to the Plan based on applicable monthly premiums established for their respective benefit elections. The Organization pays the full cost of basic life insurance and accidental death and dismemberment insurance.

The Organization makes contributions on behalf of employees in amounts required to satisfy the fringe benefit contribution obligations under different prevailing wage programs. The Organization also makes contributions to the Plan as needed to fund premiums in excess of participant contributions and administrative expenses.

Participant accounts: A separate Premium Reserve Account is maintained for each participant subject to prevailing wage programs. The account is credited monthly with the employee and employer contributions for the month and reduced by the premiums paid and administrative expenses incurred on behalf of each participant. Any net contribution in excess of a three month premium reserve is paid to the Organization's qualified retirement plan on the participant's behalf.

2. Significant accounting policies

Basis of accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions receivable: Contributions receivable represent amounts due from the participants for premiums and from the Organization for premiums and prevailing wage contributions.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: Management has evaluated subsequent events for disclosure in these financial statements through July 24, 2025, which is the date the financial statements were available to be issued.

3. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds are reported at cost, which approximates fair value.

- 4. Administrative expenses**

The Plan pays administrative expenses that consist primarily of fees paid to third-party administrators. These payments qualify as exempt party-in-interest transactions.
- 5. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

- 6. Tax status** The trust received a favorable exemption letter from the Internal Revenue Service on August 2, 2022, under provisions of Section 501(c)(9) of the Internal Revenue Code (IRC) indicating that the trust is exempt from income taxes.
- The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the related trust is tax-exempt.
- Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 7. Plan termination** Although it has not expressed any intention to do so, the Organization has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
