### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Omaha Track, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Plan Description

---

The following brief description of the Omaha Track, Inc. 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Omaha Track, Inc. and its wholly-owned subsidiaries Omaha Track Equipment, LLC, Ribbon Weld, LLC, TM Track Machines, LLC, and Iron Junction Logistics, LLC (collectively the Company).

Employees are eligible to make pre-tax salary deferral contributions and after-tax Roth contributions, and to receive discretionary matching contributions after attainment of age 18 and completing 2 months of service. Additionally, employees are able to enter the Plan on the first day of the month following the date on which eligibility requirements are met.

Participants are also eligible to receive discretionary non-elective contributions if they are employed on the last day of the year and have completed 1,000 hours of service during the Plan year.

#### ***Contributions***

Each year, participants may contribute up to 100% of eligible compensation as defined by the Plan up to the maximum dollar limits allowable by law. Effective August 23, 2024, employees who become eligible to participate in the Plan and active participants without a deferral election on file are automatically enrolled with an initial 4% (3% prior to August 23, 2024) salary deferral. Participant deferral rates are automatically increased annually, on February 1<sup>st</sup> of each year, by 1% up to a maximum of 10% (6% prior to August 23, 2024). At any time, a participant can elect not to contribute or may increase or decrease their deferral rate to any rate allowed under the Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may also make discretionary matching contributions and discretionary non-elective contributions. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Catch-up contributions are not eligible to be included in the calculation of the Company's discretionary matching contributions.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's discretionary matching contribution, b) the Company's discretionary non-elective contribution and c) Plan earnings or losses. The Company's discretionary matching contribution is allocated among participants based on each participant's elected salary deferral. The Company's discretionary non-elective contribution is allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Fidelity Management Trust Company (Fidelity).

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. The Company's contributions credited to participants' accounts are vested based on years of continuous service. Participants merged into the plan from the TM Track Machines, LLC 401(k) Plan are 20% vested after two years of credited service and 100% vested after three years of credited service. All other participants are 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through weekly payroll deductions for active participants.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may receive lump sum, partial or installment payments equal to the value of the vested funds allocated to the participant's account. Effective January 1, 2024, the Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Upon attainment of age 59 ½, a participant may withdraw all or a portion of the contributions made to the Plan in which they are 100% vested. Distributions under \$1,000 will be paid to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay Plan expenses or to reduce the Company's contributions. As of December 31, 2024 and 2023, unused forfeited non-vested accounts totaled \$428 and \$6,589, respectively. For the years ended December 31, 2024 and 2023, the Company used \$122,585 and \$86,898, respectively, to reduce Company contributions.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Other***

Certain administrative and investment management expenses may be paid by the Plan or the Company. If the Company does not pay Plan-related expenses, such expenses are allocated to the accounts of participants and are included in net appreciation in fair value of investments or in administrative expenses. Other expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Audit fees are paid by the Company and are excluded from these financial statements.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 15, 2025, noting no items requiring disclosure.

## **3. Information Certified by Fidelity**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Money Market and Mutual Funds:* Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Money market and mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued at NAV based on the market value of its underlying investments, FASB ASC 820, *Fair Value Measurements and Disclosures*, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these investments meet those requirements. Were the Plan to initiate a full redemption of the applicable collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2024:

## 5. Tax Status

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

#### 7. Related Party Transactions

---

Plan investments include a money market fund, common collective trusts, and mutual funds managed by Fidelity. Fidelity is the custodian of the Plan, therefore, these transactions qualify as party-in-interest transactions.
