## INDEPENDENT AUDITORS' REPORT

To the Board of Directors of  
The Lewis Bear Company Profit-Sharing/401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Lewis Bear Company Profit-Sharing/401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND PLAN DESCRIPTION**

**Plan Description**

The following description of The Lewis Bear Company Profit-Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that provides for retirement and disability benefits for employees of The Lewis Bear Company (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

*Profit-Sharing Component* – All employees who are 21 years of age and have completed at least 1,000 hours of service during the Plan year and are employed as of the last day of the Plan year are eligible to receive any profit-sharing contributions that may be made for that Plan year.

*401(k) Component* – All employees who are 21 years of age and who have completed three months of service are eligible to participate in the Plan. Entry dates into the Plan are January 1st, April 1st, July 1st and October 1st of each fiscal year.

**Contributions**

*Profit-Sharing Component* – The Company voluntarily contributes to the Plan out of profits earned. Employee contributions are not permitted. Contributions are allocated to participant accounts based on each participant's pro rata share of gross wages, while investment gains and losses are based on the percentage that each participant's account balance bears to the total of all account balances at the beginning of the Plan year. There were no unallocated assets as of December 31, 2024 and 2023. No discretionary contributions were made in 2024.

*401(k) Component* – Participants can authorize payroll deferrals up to the lesser of 60% of their eligible compensation or the maximum percentage of compensation or dollar amount permissible by the Internal Revenue Code (IRC). The Plan permits Roth elective deferral contributions and has an automatic enrollment feature. Unless an eligible employee opts out upon reaching eligibility status, default elective deferrals are made on behalf of the employee on a pre-tax basis in an amount equal to four percent of the employee's eligible compensation. The Company may make a matching contribution equal to fifty percent (50%) of a participant's elective deferrals, which do not exceed three percent (3%) of the participant's compensation. Participants are permitted to contribute catch-up contributions in accordance with IRC requirements. Participants direct the investments of their contributions into various investments offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of (1) the Company's contribution and (2) Plan earnings. Allocations are based on the participants' salary or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a qualified joint or survivor annuity. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal. Hardship withdrawals are allowable in accordance with current Internal Revenue Service guidelines.

Benefit payments to participants are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants represent loans to participants and are measured at the unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants are allowed one outstanding note per 12-month period from their account. The note amount is allowed at a minimum of \$1,000 and a maximum of 50% of the participant's vested balance up to \$50,000. Notes are available only from the participant's 401(k) non-forfeitable accrued benefit. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined at the time of the note issuance. Principal and interest are paid ratably through payroll deductions.

**Vesting**

Participants are fully vested with respect to their employee contributions, plus actual earnings thereon. Vesting of employer-matching and profit-sharing contributions is based on years of continuous service beginning with the participant's date of hire and thereafter as follows:

**Forfeitures**

At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$12,942 and \$8,067, respectively. Forfeited, nonvested contributions are used to reduce Company matching contributions. Employer contributions were reduced by \$55,733 and \$74,271 in 2024 and 2023, respectively, from forfeited, nonvested accounts.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value based on quoted market prices. The Plan presents in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year, and the unrealized appreciation (depreciation) on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

**Administration**

The Company serves as the administrator for the Plan and has sole responsibility for the administration of the Plan. Those services are provided without charge to the Plan. The Company also pays most trustee administrative fees on behalf of the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments as they are paid through revenue sharing rather than a direct payment.

**Subsequent Events**

The Plan has evaluated events and transactions that occurred between December 31, 2024, and July 25, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels and gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and lowest priority to unobservable inputs (Level 3 inputs). The three broad levels of the fair value hierarchy are:

- Level 1 - Inputs consist of unadjusted quoted prices in active markets for identical investments in active markets.
- Level 2 - Inputs include quoted prices for similar investments in active markets; quoted prices for identical or similar investments in markets that are not active; and model-derived valuations whose significant value drivers are observable.
- Level 3 - Inputs consist of investment valuations whose significant value drivers are not observable.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* The fair values of mutual funds are based on quoted net asset values (NAV) of the shares held by the Plan at year end and are included as Level 1 inputs.

*Common/Collective Trusts (CCT):* Valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no redemption restrictions or unfunded commitments relative to the CCTs.

#### **4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **5. TAX STATUS**

The Plan has adopted a prototype "standardized" plan, and the prototype sponsor has received an opinion letter dated June 30, 2020, from the Internal Revenue Service indicating that the Plan is a qualified plan meeting the requirements of applicable sections of the Internal Revenue Code. Accordingly, Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

As of December 31, 2024 and 2023, there were certain Plan investments managed by Bank of America. While Bank of America continues to serve as the trustee, as defined by the Plan, the transactions in 2024 and 2023 qualified as party-in-interest transactions and therefore are exempt from the prohibited transaction rules. Notes receivable from participants during 2024 and 2023 also qualified as party-in-interest transactions, which are exempt from the prohibited transaction rules.
