### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hood Industries Retirement and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**Note 1. Description of the Plan**

The following description of the Hood Industries Retirement and Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution safe-harbor plan, which covers substantially all employees of Hood Industries, Inc. (the "Company") who are eighteen or older. An employee may begin participation in the Plan on the first day of January or July following the date on which the employee meets the requirement for eligibility. Participation ceases upon termination of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan allows for participants to make pretax contributions, including catch-up contributions, to the Plan subject to the limitations set forth in the Internal Revenue Code (the "Code"). Such contributions may not be less than one percent of total eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes qualified matching contributions ("QMAC") equal to 100 percent of the first 3 percent and 50 percent of the next 2 percent of eligible compensation contributed by the participant. The Company may elect to contribute a discretionary profit-sharing contribution to each participant's account. For 2024 and 2023, there were no discretionary contributions. Employees are not required to contribute to the Plan to receive discretionary profit-sharing contributions.

Participants may also transfer to the Plan certain vested account balances from other qualified plans, subject to regulatory requirements. Transfers from the Plan represent distributions to other qualified plans within the controlled group. Rollovers represent distributions from qualified plans not sponsored by entities within the controlled group.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company QMAC as well as allocations of the Company's discretionary profit-sharing contributions and Plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

All participants are immediately vested in their voluntary contributions, QMAC and allocated earnings or losses thereon.

Participants' interests in any Company contributions and allocated earnings or losses thereon, other than QMAC, vest according to the following schedule:

Participants must obtain 1,000 hours of service to be credited with one year of vesting service. Regardless of the years of service, the participant's Company contribution accounts become fully vested in the event of death, disability or the attainment of normal retirement age (age 65).

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the balance of an outstanding loan or 50 percent of the fair value of the participant's vested account balance. Note terms range from one to five years, unless used for the purchase of a principal residence and are collateralized by the balance in the participant's account. The notes bear interest at rates ranging from 5.25 percent to 10.50 percent for the years ended December 31, 2024 and 2023. Loan interest rates are set commensurate with rates available for bank loans of comparable risk with similar terms. Principal and interest is paid ratably through weekly payroll deductions for hourly employees and semi-monthly payroll deductions for salaried employees.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid by either a lump-sum amount equal to the value of the participant's vested interest, periodic payments over an actuarially determined period or rolled over into a qualified plan, subject to regulatory requirements. After attaining age 59 ½, a participant may elect to receive an in-service distribution for all or a portion of their vested balance. Hardship distributions are also available from participants' elective deferral accounts, including earnings on such deferrals, subject to regulatory requirements.

Forfeitures

Forfeitures, which result from employees withdrawing from the Plan prior to fully vesting in Company contributions other than QMAC, are used to reduce future Company contributions or pay Plan expenses. There were no forfeited nonvested accounts held by the Plan as of December 31, 2024 and 2023. During 2024 and 2023, forfeited amounts applied to administrative expenses and used to reduce employer contributions totaled \$0 and \$1, respectively.

**Note 2. Summary of Accounting Policies**

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation of investments in the statements of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants and matching contributions, if any, from the Company are recorded in the year in which the participant wages are earned. All participant and employer contributions are participant directed.

Administrative Expenses

Administrative expenses of the Plan, to the extent that the Company does not pay such expenses, are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Expenses that relate to a specific participant are assessed against such participant as provided for in the Plan document.

Notes receivable totaling \$2,826,744 and \$2,592,890 for the years ended December 31, 2024 and December 31, 2023, respectively, related to the Plan, were certified by Principal to be complete and accurate.

Principal also certified to the completeness and accuracy of \$7,175,323 and \$8,588,797 of net appreciation in fair value of investments and \$115,937 and \$141,223 of interest related to the aforementioned assets for the years ended December 31, 2024 and 2023, respectively.

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Pooled separate accounts:* Pooled separate accounts held by the Plan are invested in domestic and international stocks, mutual funds or fixed securities. These are primarily valued at NAV per share based on quoted market prices of underlying investments (Level 2).

*Collective investment trusts:* The collective investment trusts include the Principal Stable Value Preferred Fund ("Fund") and Principal LifeTime Hybrid Collective Investment Trusts ("CITs") (Level 2).

The Fund invests in conventional, synthetic, and separate account investment contracts issued by life insurance companies, banks and other financial institutions. The objective of the Fund is to provide preservation of capital with relatively stable returns. The Fund is valued at NAV, as reported by investment managers of the Fund and are supported by unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date resulting in a readily determinable fair value. Participant transactions and redemptions (purchases and sales) may occur daily. Withdrawals, other than for benefit payments and participant transfers to noncompeting options, require twelve month advance written notice. As of December 31, 2024 and 2023, there were no unfunded commitments.

CITs invest in a collective trust fund as well as a variety of separate accounts and mutual funds that seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor with a specific target retirement date. These are valued at NAV per unit held by the Plan at year-end as reported by the custodians, which is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are units or shares of pooled separate accounts and collective investment trusts managed by Principal, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to Principal totaled \$125,078 and \$119,945 for the years ended December 31, 2024 and 2023, respectively.

**Note 6. Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants would become fully vested and the assets of the Plan, after payment of expenses, would be distributed to the participants.

**Note 7. Income Tax Status**

The Company has adopted a prototype Plan sponsored by Principal, which received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The prototype plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

The Plan has evaluated subsequent events through July 22, 2025, the date these financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to permit participants to make Roth 401(k) contributions. Prior to this amendment, only traditional pre-tax elective deferrals were permitted under the Plan. The Plan Sponsor implemented the Roth 401(k) feature to provide participants with greater flexibility in retirement planning and tax diversification strategies.

Effective January 15, 2025, the Company merged the Distributor Service, Inc. 401(k) Plan into the Plan. All Distributor Service, Inc. 401(k) Plan assets were transferred to the Plan on January 15, 2025. Participant accounts will retain their vested interest in their account balances from the Distributor Service, Inc. 401(k) Plan with participants continuing to vest according to the vesting provisions of the Plan.
