## **INDEPENDENT AUDITOR'S REPORT**

To the Trustees and Participants of  
Fareway Stores, Inc. Group Insurance Benefits Plan

### **Opinion**

We have audited the financial statements of Fareway Stores, Inc. Group Insurance Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of the Fareway Stores, Inc. Group Insurance Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, which became effective July 1, 1989, was established by Fareway Stores, Inc. (the Company) as a means of providing insurance benefits to its employees and early retirees. The Plan provides self-insured medical, prescription drug, dental and short-term disability benefits, along with fully insured vision, long-term disability, life, accident, critical illness and accidental death and dismemberment (AD&D) benefits to eligible employees of the Company. Full-time employees that have satisfied the 45-day elimination period, or eligible early retirees and their eligible dependents may participate in the plan. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act. The Plan is administered by Trustees appointed by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants may elect from multiple coverage options provided by the Plan. Participants electing the high-deductible option are also eligible to contribute to a health savings account arrangement (HSA). HSA contributions are sent to a third-party administrator by the Company, and the HSA accounts and activities are excluded from the Plan's financial statements as the Plan (as well as the Company) is not obligated to pay the benefits.

**Contributions**

Participants contribute, in the form of payroll deductions, for insurance coverage. The Company makes contributions to the Plan to cover benefits, premiums and service fees in excess of participant contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

**Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, as well as fees charged by the Center for Medicaid and Medicare Services. These expenses are reported on the statements of changes in benefit obligations and net assets available for benefits as administrative expenses. All other administrative expenses are paid by the Company on behalf of the Plan and are not reflected in these financial statements.

**Plan Termination**

Although it has not expressed any intention to do so, the Company has the right, under the Plan, to modify the benefits provided to active participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Company will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims in course of settlement, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of Benefits**

All claims are paid by appointed third-party administrators. The administrators accept and review all requests for claim payments, and after due investigation and verification, determine the eligibility of the participants for benefits and disburse the benefit amount. Benefits are recorded by the Plan when paid by the third-party administrators. Amounts due to third-party administrators that have yet to be reimbursed by the Plan are recorded as payable to administrators in the accompanying statements of benefit obligations and net assets available for benefits.

**Claims Incurred But Not Reported**

The reserve for claims incurred but not reported is calculated based on reserving methods standard in the health insurance industry which consider Plan benefits, average payouts and expected run-off.

**Claims in Course of Settlement**

The reserve is for claims incurred and reported but not yet paid.

**NOTE 3 — RECEIVABLE FROM EMPLOYER**

The Company makes contributions to the Plan based upon the estimated monthly benefits to be paid. At December 31, 2024 and 2023, the Plan recorded a receivable from the Company of \$2,013,647 and \$1,065,830, respectively, to reflect the Company's contractual requirement to cover the benefit obligations of the Plan as of those dates.

**NOTE 4 — FEDERAL INCOME TAX STATUS**

The Plan has been drafted to satisfy the requirement under the Internal Revenue Code (IRC) as they pertain to welfare benefit plans. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

**NOTE 4 — FEDERAL INCOME TAX STATUS (Continued)**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 5 — INSURANCE COVERAGE AND TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan has contracted Wellmark Blue Cross Blue Shield of Iowa (Wellmark) for payment of medical and prescription drug claims for a fee of \$1,656,229 and \$1,507,696 for the years ended December 31, 2024 and 2023, respectively. Additionally, the Plan has contracted Wellmark to provide stop-loss insurance coverage for medical and prescription drug claims in excess of \$150,000 per participant. Delta Dental of Iowa has been contracted to provide administration and payment of dental claims for a fee of \$159,638 and \$137,778 for the years ended December 31, 2024 and 2023, respectively. Payments of administrative expenses to other service providers totaled \$61,198 and \$61,964 during the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 — RISKS AND UNCERTAINTIES**

The estimated value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**NOTE 7 — SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.
