Opinion

We have audited the accompanying financial statements of Lincoln County Bancorp., Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Plan Description

The following description of the Plan is provided for financial reporting purposes only. Participants of the Plan should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2006 and was amended and restated May 1, 2021, and is an employee stock ownership (defined contribution) plan ("ESOP") designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC"), covering all eligible employees of Lincoln County Bancorp, Inc. (the "Plan Sponsor") and the participating employers; Peoples Bank of Altenburg, Exchange Bank of Northeast Missouri, Peoples Bank & Trust Co., and New Frontier Bank (the "Participating Employers"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Certain management of the Plan Sponsor serve as the Plan's trustees.

At December 31, 2024 and 2023, all Plan Sponsor stock ("Company Stock") is allocated to participants' accounts in accordance with applicable regulations under the IRC.

Eligibility

Employees may become participants following one year of service and attaining 20 years of age. Plan entry dates are January 1 and July 1. Employees who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Plan Sponsor contributions for such year.

Contributions

Each participating employer of the Plan Sponsor may make an annual discretionary cash contribution to the Plan. Contributions are based on a percentage of the participant's compensation. Participants must be actively employed at the end of the Plan year to receive employer contributions.

Participant Accounts

Each participant's account is credited as of the last day of each Plan year with an allocation of shares of Company Stock, money market account, certificates of deposit, and forfeitures of terminated participants' nonvested accounts. Allocations are based on a participant's compensation, relative to total compensation for all participants. Only those participants who are eligible employees of the Plan Sponsor and Participating Employers as of the last day of the Plan year will receive an allocation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance at year-end.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company Stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent.

Vesting and Forfeitures

Vesting in the Plan Sponsor's contributions plus earnings is based on years of service, as defined in the plan document, in accordance with the following schedule:

The nonvested balance is forfeited upon termination of service. Participants become fully vested upon death, termination of the Plan, normal retirement age, or total disability.

There were no forfeited nonvested accounts at December 31, 2024 and 2023. There were \$428 and \$478 of forfeited nonvested accounts reallocated among participants for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon attainment of normal retirement age, total disability, or death, the amount credited to a participant's account is payable in a lump sum. Upon termination of employment for reasons other than retirement, total disability, or death, the participant's account balance will be distributed in a manner based on the value of the account. If a separated participant's account does not exceed \$1,000, the benefit will be distributed in a lump sum within a reasonable time after termination of employment. If the participant's account balance exceeds \$1,000, the participant may elect to receive the benefit in a lump sum in accordance with the plan document. Distributions are made in cash or, if a participant elects, in the form of Company Stock plus cash for any fractional share of stock.

Under the provisions of the Plan, the stock must be immediately sold back to the Plan Sponsor or back to the Trust at a price equal to its fair market value to preserve the S Corporation status of the Company. There were no distributed shares for the years ended December 31, 2024 and 2023.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustees prior to the time that such rights are to be exercised. The trustees are not permitted to vote any allocated share for which instructions have not been given by a participant. The trustees are required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company Stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Plan Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock as of the most recent valuation date. The Plan Sponsor can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to convert the stock to cash.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses from Plan assets. If the Plan Sponsor does not pay these expenses from its own assets, then the expenses paid using Plan assets will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense.

Subsequent Events

The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value establishes a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
Level 2	Inputs to the valuation methodology to include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the instrument, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The instruments' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

Level 2 investments consist of a money market account and certificates of deposit. The money market account and certificates of deposit value are valued at cost plus accrued interest.

Level 3 investments consist of Company Stock that is not actively traded and significant other observable inputs are not available. The fair value of the common stock is determined by an annual independent appraisal as of December 31. The appraisal is based on a combination of the market and investment valuation approaches consistent with prior years. The appraisal took into account historical and projected cash flow and net earnings, return on assets, return on equity, market comparables, and applicable discounts and premiums. Plan management accumulates the data for the appraiser from the audited financial statements of the Plan Sponsor. The appraiser prepares a preliminary report which Plan management, along with the trustees, review in detail, discuss and approve.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Company Dividends

The Company paid Sub-S distributions to the Plan of \$33 per share, or \$515,691, and \$35 per share, or \$542,570, during the years ended December 31, 2024 and 2023, respectively.

5. Related Party and Party-in-Interest Transactions

At December 31, 2024 and 2023, certain Plan investments are shares of Company Stock and are held by the Trust. At December 31, 2024 and 2023, the Plan's money market account and certificates of deposits are held by People's Bank & Trust Co. and New Frontier Bank. Plan Sponsor contributions are held and managed by the trustees, which invest cash received, interest, and dividend income and make distributions to participants. Therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. During 2024 and 2023, the Plan Sponsor paid certain administrative and other operating expenses of the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Plan Sponsor contribution portion of their account.

7. Tax Status of Plan

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated October 22, 2013, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with GAAP, the Plan Sponsor is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to 2021. The Plan is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

8. Risks and Uncertainties

Concentration of Credit Risk

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist principally of money market accounts and certificates of deposit. The Plan maintains its money market account and certificates of deposit with two Participating Employers. The money market account and certificates of deposit are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. At December 31, 2024, there were money market account and certificate of deposit balances of \$2,030,956 in excess of FDIC limits.

Investments

The Plan investments consist primarily of Company Stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the Company Stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes could materially affect the amounts reported in the statement of net assets available for benefits.

9. Subsequent Event

The Plan has evaluated subsequent events through July 23, 2025, the date the financial statements were available to be issued.

On March 15, 2025, the Plan purchased 1,500 shares of Company Stock stock at \$761.54 per share totaling \$1,142,310.

Effective April 5, 2025, the Plan has been amended to increase the age for mandatory distribution to age 72 for distributions made after December 31, 2019, allow the Trustee to divest 10 percent of the outstanding shares of Plan Sponsor stock annually for the first 10 year's of a participant's retirement period to be reinvested into other investment options within the Plan effective January 1, 2026 if the participant has reached the age of 75, increase the amount of automatic distribution of account balance from \$1,000 to \$7,000 effective January 1, 2026, and allow cash amounts of participant accounts to be invested into investment funds offered by the Plan effective January 1, 2026.
