### Note 1: Description of the Plan

#### **General**

The following description of BankFirst 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by BankFirst (the Company) for the benefit of its employees. All employees are full participants in the Plan upon their official hire date. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Union Bank and Trust Company is the trustee of the Plan and also serves as Plan custodian and record-keeper.

#### **Contributions**

The Plan permits eligible employees, through a salary deferral election to have the Company make annual contributions of up to the lesser of \$69,000 or 100% of eligible compensation. The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made a contrary election otherwise. Employee rollover and Roth elective contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Plan participants are eligible to participate in employee salary deferrals and employer matching contributions on the participants date of hire. For the years ended December 31, 2024 and 2023, the Company made matching contributions of half of the employees' salary deferral amounts up to 1.5% of their compensation. The Plan permits matching contributions to be discretionary and approved by the Company's Board of Directors up to 6% of the participants eligible compensation.

Company profit sharing contributions are discretionary and are determined by the Company's Board of Directors. Plan participants are eligible to receive the discretionary contributions from the Company if they are employed on the last day of the plan year and they have completed at least 1,000 hours of service during the plan year. Once the participant meets these requirements, they are eligible for profit sharing contributions the following July 1<sup>st</sup> or January 1<sup>st</sup>. Contributions are subject to certain limitations. Forfeitures may be used to reduce Company contributions, pay plan expenses or be reallocated to active participants.

#### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 6 years of continuous service. Continuous service begins once the participant meets the eligibility requirements.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant with a vested account balance in excess of \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or may request a distribution of some or all of the vested account balance subject to any reasonable limits regarding timing and amounts as the Plan Administrator may impose. For termination of service for other reasons or a terminated participant with a vested account balance of less than \$5,000, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution only.

***Forfeited Accounts***

At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$0 and \$25,854, respectively. These accounts will be used to reduce future employer contributions or pay for certain plan expenses. Also, in 2024 and 2023, employer contributions were reduced by \$0 and \$120,012, respectively, from forfeited nonvested accounts.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual and money market mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3: Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Union Bank & Trust, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

#### **Note 4: Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, or relatives of such persons.

The Plan paid \$18,120 and \$19,156 of recordkeeping fees to Union Bank and Trust Company during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the plan.

#### **Note 5: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024, and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 1 securities include mutual funds and level 2 securities include money market funds. The Plan had no Level 3 securities at December 31, 2024 and 2023.

### Note 6: Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### Note 7: Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Union Bank and Trust Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United State of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods.

### Note 8: Risks and Uncertainties

#### *Investments*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 9: Subsequent Events

Subsequent events have been evaluated through July 28, 2025, which is the date the financial statements were available to be issued.
